a. Discussion on content portions of videos for Drug Chemistry and Latent Prints-The content portion of the Drug Chemistry video is complete. It is approximately 18 minutes long. The final videos will be shared with Commission Members in November so they can review before the Commission's December 10th quarterly meeting. The videos will be discussed at that Commission meeting and, assuming they are approved by the Commission, the videos then will be posted on the Commission's webpage. Ms. Watroba will work with PIO to get the videos posted once approved.

b. Update and discussion on next steps to create remaining videos addressing fundamentals of core forensic disciplines- The content for the Firearms video is the process of being created. The individuals working on the Toxicology video are at a conference this week, so no update is available. Content creation for the DNA video is in progress and there may be content for the subcommittee to review at the next meeting. Trace Chemistry received internal direction on topics to address in their video(s) and will begin working on content creation.
