If the name of the gang is **not** listed, contact **must** be made with the Illinois State Police, Statewide Terrorism Intelligence Center (STIC). Please provide STIC with the gang name and factors used to identify the gang, see the LEADS eManual, Gang Member File. STIC will then enter the gang into the gang name database, and entry of subject as a gang member may then be made.
