### Stolen Driver's License Article Query

Users can now receive hits from the Article file for Stolen Driver's License Article records when making a **Z2** inquiry on a DLN if that DLN had been entered as a Stolen Article. LEADS and NCIC will now cross-search the Z2 DLN number query against the Article Serial Number (SER) for Article TYP/IDRIVER, QDRIVER, ZDRIVER. This applies only to Stolen, not Lost Driver's License as IDRIVER and ZDRIVER are not valid TYP codes for entry of a Lost Driver's License. If the DLN queried in QVEHPER (or a comparable interface format) has been entered into the Article file as Stolen, the Article hit will return.
