NEW PROTECTION ORDER FORMS FOR CIVIL NO CONTACT AND STALKING NO CONTACT ORDER ENTRY

New formats for the entry of Plenary and Temporary/Emergency Civil No Contact Orders (740 ILCS 22) and Stalking No Contact Orders will be coming soon to Messenger 3.0. These forms were created to allow the Hot File records to more accurately reflect the correct Remedies and requirements contained in the court orders. This will result in three separate formats for the three different types of Protection Orders: Protection Order, Civil No Contact, and Stalking No Contact.

New Modify Civil No Contact and Modify Stalking No Contact formats have also been created. It is important that the correct Modify form be chosen when modifying a record so that the proper remedies are available to the user. All other transactions for these orders will use the standard Protection Order forms (Cancel, Clear, Supplemental, Add-On, Short Form Notice).

The Protection Order chapter of the LEADS 3.0 manual will be updated prior to deployment of the new formats to include information on the use of these forms. It is recommended that agencies that enter Protection Orders review these changes and familiarize themselves with these new forms.

Agencies that have access to Messenger 3.0 TEST may look at the new formats and establish TEST records ahead of the formats being activated on the Messenger 3.0 Production side.
