## **NICS Denied Transaction File Response**

The NICS Denied Transaction File (NDTF) is designed to share information regarding individuals who, having been determined to be prohibited persons according to the Brady Handgun Violence Prevention Act of 1993 (Brady Act), have been denied as a result of a National Instant Criminal Background Check System (NICS) background check.

When a persons inquiry is made and a match is found in the NICS Denied Transaction File, a hit will be returned (below).

No enforcement action may be taken based solely on a NICS Denied Transaction File response.

The reason why the individual was denied is not included in the hit. DO NOT contact ISP Firearms Service Bureau (FSB) seeking to find out the reason for denial. That information may not be released.
