## **SOS Soundex Inquiry Update**


\*\*\* This update is will be promoted the morning of June 13, 2022 \*\*\*

Using the SOS Soundex Inquiry format, users can obtain an individual's driver's license and license plate numbers. This applies <u>only</u> to drivers and vehicles registered through the Illinois Secretary of State; **the inquiry does not search LEADS nor NCIC Files.** 

The Illinois Secretary of State has updated their response: Begin PNO/02312187 End PNO/02312188 will *no longer appear* on the Soundex Results. The response will look like the response below: **Use Page Forward/Back for Additional Records**.
