<p align="center">7 Day Intra State</p> <ul style="list-style-type: none"> This permit can only be issued if the applicant has provided proof of ownership to the issuing agency. <ul style="list-style-type: none"> The holder must be an Illinois Resident. Only 3 permits are allowed per vehicle per year. The permit is void if any information is missing or altered. The top part of the permit is to be placed inside the upper left rear window. The permits are made of durable paper. The displayed portion is 8.5 inches by 3.5 inches. Appropriate mandatory insurance liability coverage is required. Dealers and Remitters are to retain records for 3 years. 	<p align="center">90 Day Drive Away</p> <ul style="list-style-type: none"> These permits may be used to operate a vehicle being driven to another state for 90 days. Ownership documentation must indicate an out of state address. Only 1 permit is allowed per vehicle per year. <ul style="list-style-type: none"> The top part of the permit is to be placed inside the upper left rear window. The permits are made of durable paper. The displayed portion is 8.5 inches by 3.5 inches. Dealers and Remitters are to retain records for 3 years.

The new style permits have one alpha character. They are valid for 7 or 90 days. The old-style permits are all numeric. Old style permits are valid for 7 or 30 days.
