NEW SEX OFFENDER CITATION CODE ISPSE10

Sex Offenders convicted in any state outside of Illinois that *also* have the duty to register in that correlating state of conviction, should now be entered with citation (CIT) ISPSE10 and the applicable conviction (CON) date. This code should be used for any sex offender residing, temporary domiciled, employed, or attending school in Illinois after 1/1/2012. These offenders will be classified as "sexual predators" and the CSO field should be populated with a P - Victim<18 or S - Victim≥18. The Ending Registration Date (ERD) will remain as NONEXP. The NCIC copy of the record will auto-populate the translation of ISPSE10 in the Miscellaneous (MIS) field. If the offender subsequently gets convicted in Illinois of a sex offense, the original ISPSE10 CIT and CON will remain, and the applicable Illinois AOIC CIT code and CON date will be added to the record.

* The agency that is creating the record will need to verify the conviction information by performing a criminal history search and NCIC search through LEADS on the offender. The agency can follow up verification by contacting the correlating SOR Unit within the state of conviction. Agencies will no longer need to contact the Illinois State Police Offender Registration Unit for offenders that meet these criteria.
