for October 21, 2020**

Notification Requirement - NCIC Supervised Release Hits

Some NCIC Supervised Release file records require the agency who received the hit to notify the Originating Authority (ORA). When a record has a notification requirement, it will be stated in the MIS field of the hit (see example below). Additionally, when a hit from the Supervised Release file is received by your agency, NCIC automatically sends a \$.O. message to ORA notifying them that your agency has received a hit (see example below). They will be awaiting contact from your agency.

Contact information for the ORA may be found in the SON (Name of Supervising Officer), SOT (Telephone Number of Supervising Officer), and EML (Email Address of Supervising Officer) fields. As an alternative means of notification, an administration message may be sent via NLETS to the ORI listed in the hit.
