INQUIRIES FOR WATERCRAFT/BOAT AND SNOWMOBILE TITLE AND REGISTRATION INFORMATION

On May 17, 2023, inquiries to the Illinois Department of Natural Resources (IDNR) for boat and snowmobile registration information will be available. Watercraft queries submitted with Boat Hull Numbers (BHN) or Registration Numbers (REG) and Snowmobile queries submitted with Vehicle Identification Numbers (VIN) will check NCIC and Illinois Hot Files **AND** the IDNR registration data.
