- GIS
 - 911 Authorities are in the process of working on the 7 data layers that the NG911 System will require to support geospatial routing.
 - The 1st draft of the EMS Boundary Layer is due 2/28
- A PO was issued to ESRI that includes a GIS Hub, ArcGIS Pro Software and Maintenance and Training. An email will be distributed to the 911 Authorities with the details.

FY21 Grants
