ORDER OF THE STATEWIDE 9-1-1 ADMINISTRATOR

WHEREAS the Southcom 9-1-1 System submitted a modification plan with the Office of the Statewide 9-1-1 Administrator on July 7, 2025, seeking to opt out the Village of Olympia Fields.

WHEREAS the modification plan has been read and reviewed by the 9-1-1 Bureau and the Administrator; and

WHEREAS the modification plan seeks to opt out the Village of Olympia Fields from the Southcom 9-1-1 System and into the Cook County 9-1-1 System;

WHEREAS, Section 30 of the Emergency Telephone System Act (ETSA) directs the Illinois State Police Division of Statewide 9-1-1 to make monthly disbursements of surcharge funds to the appropriate 9-1-1 Authority currently receiving 9-1-1 calls, based on the primary place of use (PPU) for zip code wireless subscribers, for amounts received for wireline and wireless surcharge. Accordingly, the Intergovernmental Agreement (IGA) specifies the boundary change resulting from the disengagement of Olympia Fields from the SouthCom 9-1-1 System, and its consolidation with the Cook County ETSB. The IGA further provides that the Cook County ETSB will be responsible for accounting for such funds in its audited annual financial reports, as required under Section 40 of the ETSA.

WHEREAS the Cook County ETSB and the Southcom 9-1-1 System have entered into an IGA concerning the payment of 9-1-1 surcharge, the financial reporting and auditing of the funds, and other specifics concerning the addition of the Village of Olympia Fields to the Cook County 9-1-1 System.

NOW THEREFORE, the Administrator orders the following;

IT IS HEREBY ORDERED that the Southcom 9-1-1 System's request for approval of its modification plan as follows:

Opting out the Village of Olympia Fields from the Southcom 9-1-1 System into the Cook County 9-1-1 System pursuant to Title 83: Public Utilities Chapter IV: Illinois State Police Part 1325 - Standards of Service Applicable to 9-1-1 Emergency Systems Section 205, is hereby approved subject to the requirements of this Order.

IT IS FURTHER ORDERED that the Cook County modification will be completed no later than November 1, 2025.

IT IS FURTHER ORDERED that the Olympia Fields surcharge remittances currently being remitted to the Southcom 9-1-1 System shall begin to be distributed to the Cook County 9-1-1 System as defined in 50 ILCS 750/30 beginning with the February 2026 remit period.
