Plan Narrative:

The Winnebago County Emergency Telephone System Board (ETSB) is filing a plan for modication with the State to include MercyHealth RockCom as a secondary answering point within the system. Rockcom Dispatch Center is a private dispatch facility operated by MercyHealth Systems which serves eight rural fire departments in Winnebago County (Durand Fire Department, Loves Park Fire Department, North Park Fire Protection District, Pecatonica Fire Department, Rockton Fire Protection District, Shirland Fire Department, South Beloit Fire Department, and Win-Bur-Sew Fire Protection District). Rockcom has operated as a dispatch center for a number of years without the official designation of secondary answering point. In order to comply with the Illinois Emergency Telephone System Act (ETSA), 50 ILCS 750/7 and the Illinois Adminstrative Code, the Winnebago County ETSB seeks to modify the existing system plan to include RockCom as a secondary answering point.

At a special ETSB meeting on October 26th, the Board approved a motion to accept RockCom as a secondary answering point in the Winnebago County 911 system and that MercyHealth should bear the costs of the equipment necessary to make that transition. According to a technical analysis of RockCom and their facility conducted by the State, it was determined that in order to comply with the standards necessary to be defined as a secdonary answering point under the ETSA, customer premise equipment capable of recieving voice and data transfer of 911 fire and EMS calls must be in place. The ETSB will ascertain the costs and processes necessary to make this transition and draft an agreement with MercyHealth outlining the roles and responsibilities of both entities. It is the intent to have these items and any other necessary procedural changes completed by June 1st, 2023.
