ORDER OF THE STATEWIDE 9-1-1 ADMINISTRATOR

WHEREAS the Cook County ETSB submitted a modification plan with the Office of the Statewide 9-1-1 Administrator on April 18, 2024, seeking to opt in the Village of Crestwood and the Village of Worth;

WHEREAS the modification plan has been read and reviewed by the Department and the Administrator; and

WHEREAS the modification plan seeks to opt in the Village of Crestwood and the Village of Worth into the Cook County 9-1-1 System from the Southwest Central Dispatch 9-1-1 System;

WHEREAS as it relates to “wireline” surcharge monies the Southwest Central 9-1-1 System and the Cook County ETSB have entered into an IGA allowing wireline surcharge monies to be paid to Cook County and requiring Cook County to account for such monies in its audited annual financial reporting as required under Section 40 of the ETSA.

WHEREAS as it relates to “wireless” surcharge monies, Section 30(b)(1)(D) and 30(2)(E) of the ETSA directs the Department to make monthly grants to the appropriate 9-1-1 Authority currently taking wireless 9-1-1 based upon zip code billing of wireless subscribers. Accordingly, the IGA specified the boundary change resulting from Crestwood and Worth disengaging with the Southwest Central 9-1-1 System and consolidating with Cook County and specified that Cook County will then be responsible to account for such monies in its audited annual financial reporting as required under Section 40 of the ETSA.

WHEREAS Cook County ETSB and the Southwest Central 9-1-1 System have entered into an IGA concerning the payment of 9-1-1 surcharge, the financial reporting and auditing of the funds, and other specifics concerning the addition of Villages of Crestwood and Worth to the Cook County 9-1-1 System.

NOW THEREFORE, the Administrator orders the following;

IT IS HEREBY ORDERED that the Cook County ETSB’s request for approval of its modification plan as follows:

Opting in the Villages of Crestwood and Worth from the Southwest Central 9-1-1 System to the Cook County 9-1-1 System pursuant to Title 83: Public Utilities Chapter IV: Department of State Police Part 1325 - Standards of Service

Applicable to 9-1-1 Emergency Systems Section 205, is hereby approved subject to the requirements of this Order.

IT IS FURTHER ORDERED that the Cook County modification will be completed no later than May 31, 2024.

IT IS FURTHER ORDERED that the Cook County 9-1-1 System will add Crestwood and Worth to their current Wireless Plan with an effective date no later than May 31, 2024.

IT IS FURTHER ORDERED that the Crestwood and Worth surcharge remittances currently being remitted to the Southwest Central 9-1-1 System shall begin to be distributed to the Cook County 9-1-1 System as defined in 50 ILCS 750/30 beginning with the September 2024 remit period.
