ORDER OF THE STATEWIDE 9-1-1 ADMINISTRATOR

WHEREAS, the Proviso-Leyden JETSB submitted a modification plan with the Office of the Statewide 9-1-1 Administrator on June 7, 2018, seeking to opt in the Village of Stone Park;

WHEREAS the modification plan has been read and reviewed by the Department and the Administrator; and

WHEREAS the modification plan seeks to opt in the Village of Stone Park into the Proviso-Leyden JETSB from the Cook County ETSB;

NOW THEREFORE, the Administrator orders the following;

IT IS HEREBY ORDERED that the Proviso-Leyden JETSB request for approval of its modification plan as follows:

Opting in the Village of Stone Park from the Cook County ETSB to the Proviso-Leyden JETSB

pursuant to Section 15.4a of the Emergency Telephone System Act, 50 ILCS 750/15.4a, is hereby approved subject to the requirements of this Order.


IT IS FURTHER ORDERED that the Proviso-Leyden JETSB modification will be completed no later than August 1, 2018.

IT IS FURTHER ORDERED that the Proviso-Leyden JETSB's 9-1-1 System Service Provider will conduct a P.01 Study and if necessary a Traffic Study to determine the number of 9-1-1 trunks required to serve the Proviso-Leyden JETSB with the addition of Stone Park.

IT IS FURTHER ORDERED that the Proviso-Leyden JETSB will file with the Administrator a Wireless 9-1-1 Plan to include Stone Park with an effective date no later than August 1, 2018.

IT IS FURTHER ORDERED that Stone Park surcharge payments currently being distributed to the Cook County ETSB shall begin to be distributed to the Proviso-Leyden JETSB as defined in 50 ILCS 750/30 beginning August 1, 2018.
