Plan Narrative:

1.) The E-COM Dispatch Center, also known as "E-COM," is a well-established dispatch center overseen by a 9-1-1 Authority Board of Directors. It provides emergency call-taking, Police, Fire, and Emergency Medical Services (EMS) dispatch services to the residents of the City of Country Club Hills, Village of East Hazel Crest, Village of Flossmoor, Village of Glenwood, Village of Hazel Crest, Village of Homewood, Village of Riverdale, Village of South Holland, and Village of Thornton.

Similarly, the SouthCom Dispatch Center, referred to as "SouthCom," is another established dispatch center governed by the same 9-1-1 Authority Board. It offers emergency call-taking, Police, Fire, and Emergency Medical Services (EMS) dispatch services to the Village of Matteson, Village of Park Forest, and Village of Richton Park.

Both E-COM and SouthCom member communities have passed ordinances agreeing to form a new Joint Emergency Telecommunications Services Board (JETSB) that combines the resources of E-COM and SouthCom. SouthCom operates on the STARCOM21 radio/telecommunications system, which is compatible with participating and adjacent agencies for police dispatch. On the other hand, E-COM operates on the Cook County encrypted radio system for police dispatch. Both E-COM and SouthCom utilize the Motorola Elite Dispatch MCC 7500 radio consoles and rely on the Motorola Flex Computer Aided Dispatch (CAD), Records Management System (RMS), and Mobile shared services.

Currently, E-COM & SouthCom JETSB have a tenancy agreement with the Village of Hazel Crest. This agreement involves the potential purchase of an existing structure located at 3700 W. 183rd Street, Hazel Crest, IL 60429. The purchase is tentatively scheduled for March 15, 2024, pending the approval of the Application for 9-1-1 Consolidation Plan.

The purpose of this purchase is to rehabilitate the structure and convert it into a single Public Safety Answering Points (PSAP). The remodeled facility will span an area of thirteen thousand four hundred square feet, providing ample space to accommodate both current PSAPs. This will allow them to coexist in one location, creating a unified JETSB/PSAP. Additionally, the facility has the potential for future expansion to serve the South Cook County region.

The consolidation of both ETSBs and PSAPs into one JETSB and one PSAP will bring several benefits, including:

- Reduce the number of 9-1-1 transfers
- Reduce the infrastructure required to adequately provide 9-1-1 network services
- Promote cost savings from resource sharing among 9-1-1 systems
- Facilitate interoperability and resiliency for the receipt of 9-1-1 calls
- Reduce the number 9-1-1 systems and reducing the number of PSAPs
- Cost savings resulting from 9-1-1 system consolidation

Narrative Plan:

2.) The AT&T services provided to E-COM will comply with all Federal and State laws and National Emergency Number Association Standards (NENA) and be NENA I3 compliant (NENA-STA-010.3a-2021). The NG9-1-1 service is being provided by Motorola CallWorks Emergency Call Handling Servers and Software. All system communications will be Internet Protocol. Both NG9-1-1 ESInet and Network Services will be monitored by AT&T Security Operations and Network Operations Centers 24-7-365 which will handle incidents and notifications per FEMA Incident Command System protocols. The E-COM facility was designed, constructed, and complies with NFPA 1221 (2002) and referenced standards for emergency communications centers. E-COM complies with current Illinois State Police (ISP) requirements for training and provision of Emergency Medical Service (EMS) instruction of obtaining licensure through the Illinois Department of Public Health (IDPH) for Emergency Medical Dispatch (EMD) services. Telecommunicators are trained and certified using APCO, Intl. for EMD certification. Southcom is already NG9-1-1 complaint. Both dispatch centers will be NG9-1-1 compliant prior to consolidation. This technology will be implemented at the new dispatch center prior to going live. 3.) Each AT&T NG9-1-1 server premise will be connected to AT&T's redundant ESInet service as provided to the State of Illinois. Each AT&T NG9-1-1 server premise will be connected to E-COM by means of a 24-7-365 monitored AT&T Switched Ethernet (ASE) fiber based Internet Protocol (IP) circuit. E-COM currently has and will retain diversely routed AT&T provided fiber based IP circuits. The AT&T NG9-1-1 servers and services will be shared with other 9-1-1 Authorities and PSAPs as provided in AT&T's Service Agreement was executed with the State of Illinois. 4.) Prior to cutover, AT&T will transition duplicate circuit appearances from E-COM's Centralized Automatic Message Accounting (CAMA) based 9-1-1 system, which includes legacy wireline, wireless and VoIP services which are currently selectively routed from AT&T's Central Office facility into the ESInet Legacy Network Gateway (LNG) and Motorola CallWorks NG9-1-1 server equipment. This will include the selective routing database currently in use for legacy E9-1-1 services. AT&T will provide ongoing connection to Legacy Selective Routers and gateways per NENA standards for receipt and transfer of 9-1-1 calls using the Legacy Network Gateway. 5.) The E-COM resides in the 708 area code. The current mechanism of separation is the CAMA trunked selective routing system provided by AT&T which recognizes address based on Emergency Service Number (ESN) exchange routing for wireline calls, carrier based location systems from wireline carriers and subscriber addressed based routing from VoIP providers. The new AT&T ESInet service will provide 9-1-1 call routing to E-COM using both ESN (tabular) and Geographic Information System (GIS) (spatial) routing on the Vesta Host Service. Should E-COM become unable to answer and process 9-1-1 calls, SouthCom Dispatch Center "SouthCom" continues to provide assistance to E-COM as the backup PSAP. In the event of a failure or overflow of 9-1-1 calls, incoming 9-1-1 calls

For the purpose of effective handling and routing of 9-1-1 Emergency Calls, 9-1-1 Authority Southland Communications Center and 9-1-1 Authority Tinley Park 911 System have entered into this Agreement pursuant to a framework established between participants of the 9-1-1 System (hereinafter the "Parties").

This Backup Agreement authorizes and directs the 911 System Manager of Southland Communications Center and the 911 System Manager of Tinley Park 911 System to enter into a 9-1-1 Authorities Backup Agreement ("AGREEMENT") to establish the procedures that enable management of emergency calls during prearranged, unanticipated, and exigent circumstances.

This AGREEMENT establishes the procedures to follow during such circumstances.

The headings contained in this AGREEMENT are for convenience of reference only and shall not affect in any way the meaning or interpretation of this AGREEMENT. As the Public Safety

Answering Point's (PSAPs) name will be used to describe the PSAPs that answer 9-1-1 calls.

I. DEFINITIONS

Abandoned Call - A call placed to 9-1-1 when a PSAP is in an abandonment state/offline.

<u>Contingency diversion</u> The capability of routing 9-1-1calls to a designated alternate location(s) if all 9-1-1 trunks are busy or out of service due to a service interruption. May be activated upon request or automatically, if detectable, when call volume exceeds a designated threshold, 9-1-1 equipment fails, the PSAP itself is disabled, or other conditions causing the processing and answering of a 9-1-1 call to be compromised.

<u>Exigent circumstances</u> – Situation impacting 9-1-1 call processing in which the PSAP authority determines is sufficiently significant and pressing to divert calls from the PSAP to a predetermined alternate PSAP.

<u>Primary [Diverting] PSAP –</u> The PSAP which, by agreement, reroutes 9-1-1 calls to an alternate PSAP under prearranged, unanticipated, or exigent circumstances.

<u>Prolonged event</u> – An exigent circumstance of a lengthy duration and condition that causes the PSAP's authority to invoke contingency diversion of 9-1-1 calls from one PSAP to a predetermined receiving PSAP.

<u>Backup [Receiving] PSAP</u> – The PSAP which, by agreement, answers 9-1-1 calls for another PSAP under prearranged, unanticipated, or exigent circumstances.

II. 9-1-1 EMERGENCY CALL HANDLING DISPATCH PROCEDURES AND PROTOCOLS

It is agreed by Southland Communications Center and Tinley Park 911 System that contingency diversion of 9-1-1 calls may not be supported if the Backup PSAP is experiencing its own emergency or has its own need for overflow call handling support.

The exigent circumstances and conditions under which a contingency diversion activation may occur shall include, but are not limited to the need for PSAP evacuation, network failure, call handling equipment failure, unavailability of numerous workstations, or other conditions causing the processing and answering of a 9-1-1 call to be compromised.

The rerouting of all 911 calls to the Backup PSAP shall be done at the 911 routing level (Selective router or NG911 Core Services [NGCS]) to maintain the same level of service and information, and not routed to ten digit lines. If this is not capable, the substitute methods must be approved by the 911 Coordinator.

Tinley Park 911 System agrees to accept the following call types from Southland Communications Center:

- **2** 911 Voice
- 911 Text
- ☑ 10-digit Emergency
- CAD-to-CAD Interface
- 10-digit Non-Emergency/Administrative (admin)
- Images/Video to 911
- A. Condition 1: Call overflow due to instances such as PSAP busy condition or ring, noanswer due to full call queue.
 - The Backup PSAP will accept overflow calls from Southland Communcications Center when its call queue is full, or a call goes unanswered for a period of thirty (30) seconds. The Backup PSAP will make best efforts to deliver any answered call details under this provision back to the PSAP's jurisdiction for dispatch by the following manner and in the following priority order:
 - 1. 1st Priority Method: Radio transmission on [N/A
 - 2. 2nd Priority Method: 10-digit non-emergency/admin (708) 799-6834
 - 3. 3rd Priority Method: Talk group N/A

- B. Condition 2: Call diversion due to instances such as PSAP offline or evacuated (also known as abandonment) or call handling equipment is offline due to a network outage.
 - i. The Backup PSAP will accept calls from the Primary PSAP when the Primary PSAP has invoked its abandonment state in the NGCS policy routing rules and the Backup PSAP is next in the rules queue. The Primary PSAP may have multiple alternate destinations provisioned ahead of the Backup PSAP which may assist in limiting the volume of calls diverted to its call queue. The Backup PSAP will make best efforts to deliver any answered call details under this provision back to the Primary PSAP for dispatch by:
 - 1. 1st Priority Method: Radio transmission on N/A
 - 2nd Priority Method: 10-digit non-emergency/admin (708) 799-6834
 - **3.** 3rd Priority Method: Talk group N/A
- C. Condition 3: Call misrouted due to routing function, shared exchange, mobile caller or other reason.
 - i. The Backup PSAP will accept calls from the Primary PSAP when misrouted calls are transferred.
- D. Both Southland Communications Center and Tinley Park 911 System agree to place an overflow queue for each other on their call handling screens to manage inbound diverted 9-1-1 calls within thirty days (30) days of execution of this AGREEMENT. Each Party shall bear their own costs for equipment modification. Both Parties understand that diverted calls may be answered with a lower priority than the answering jurisdiction's for text-to-911.
- E. During a call diversion event the Backup PSAP will audio record answered calls from the Primary PSAP. Recordings will be made available to the Primary PSAP upon request.
- F. During an emergency event lasting longer than four hours (4) continuing hours, the Primary Party will in good faith, make best efforts to send staff to the Backup PSAP to provide operational support and subject matter expertise to minimize impact to the Backup PSAP staff and operations.
- G. Parties will share their call handling and call documentation procedures to inform one another of the specifics of each other's operation. At a minimum, Parties will gather location information, call back number, nature of the call, and known safety information.

Parties will make a concerted effort to align with the call documentation procedures when handling calls from the other's jurisdiction.

- H. If a valid callback number is available, Parties will attempt to re-establish contact with abandoned calls. At a minimum, one callback should be performed to verify if an emergency exists when there are signs of distress, inaudibility, or a clear indication that emergency service is needed.
- I. When feasibly possible, Tinley Park 911 System will follow up with a delivery of an email to admin@ecom911.net of the available Computer-Aided Dispatch (CAD) record for Southland Communications Center calls. 532-9111
- J. When feasibly possible, Southland Communications Center will follow up with a delivery of an email to Ikortum@tinleypark.org available CAD record for Tinley Park 911 System calls.
- K. Within thirty (30) days of the activation date of this AGREEMENT, the Parties agree to conduct and document the appropriate training of their respective staff on the processes and procedures agreed to by the Parties.
- L. The Parties agree to notify the other Party of a return to normal conditions (such as the reoccupation of an evacuated PSAP) at the earliest possible opportunity. The Primary PSAP will be responsible for returning services back to normal conditions.
- M. If Southland Communications Center or Tinley Park 911 System is compelled by Law to disclose any call information, it shall provide prompt written notice to the other Party. If the Parties cannot fail to quash the legal process requiring disclosure, both Parties understand the requested call information will be disclosed only to the extent necessary to satisfy the request.

III. UPDATES AND MODIFICATIONS TO THIS AGREEMENT

This agreement shall last for a period of one year starting from activation date through December 31, 2025, and shall continue from year to year thereafter. If either party wishes to terminate this agreement, they shall provide the other party with at least thirty (30) days written notice of such termination.

The Parties agree to review this Agreement on a bi-annual basis, at a minimum, to update any processes or understandings.

Backup Agreement Southland Communications Center and Tinley Park 911 System

The Parties entering into this AGREEMENT acknowledge that any modifications must be by mutual consent, in writing, with as advanced notice as possible considering the circumstances, and will be treated as an amendment to this AGREEMENT.

The 911 Administrator shall be notified when there are any modifications to, or termination of, this AGREEMENT.

1.) The E-COM Dispatch Center, also known as "E-COM," is a well-established dispatch center overseen by a 9-1-1 Authority Board of Directors. It provides emergency call-taking, Police, Fire, and Emergency Medical Services (EMS) dispatch services to the residents of the City of Country Club Hills, Village of East Hazel Crest, Village of Flossmoor, Village of Glenwood, Village of Hazel Crest, Village of Homewood, Village of Riverdale, Village of South Holland, and Village of Thornton.

Similarly, the SouthCom Dispatch Center, referred to as "SouthCom," is another established dispatch center governed by the same 9-1-1 Authority Board. It offers emergency call-taking, Police, Fire, and Emergency Medical Services (EMS) dispatch services to the Village of Matteson, Village of Park Forest, and Village of Richton Park.

Both E-COM and SouthCom member communities have passed ordinances agreeing to form a new Joint Emergency Telecommunications Services Board (JETSB) that combines the resources of E-COM and SouthCom. SouthCom operates on the STARCOM21 radio/telecommunications system, which is compatible with participating and adjacent agencies for police dispatch. On the other hand, E-COM operates on the Cook County encrypted radio system for police dispatch. Both E-COM and SouthCom utilize the Motorola Elite Dispatch MCC 7500 radio consoles and rely on the Motorola Flex Computer Aided Dispatch (CAD), Records Management System (RMS), and Mobile shared services. Currently, E-COM & SouthCom JETSB have a tenancy agreement with the Village of Hazel Crest. This agreement involves the potential purchase of an existing structure located at 3700 W. 183rd Street, Hazel Crest, IL 60429. The purchase is tentatively scheduled for March 15, 2024, pending the approval of the Application for 9-1-1 Consolidation Plan.

The purpose of this purchase is to rehabilitate the structure and convert it into a single Public Safety Answering Points (PSAP). The remodeled facility will span an area of thirteen thousand four hundred square feet, providing ample space to accommodate both current PSAPs. This will allow them to coexist in one location, creating a unified JETSB/PSAP. Additionally, the facility has the potential for future expansion to serve the South Cook County region.

The consolidation of both ETSBs and PSAPs into one JETSB and one PSAP will bring several benefits, including:

- Reduce the number of 9-1-1 transfers
- Reduce the infrastructure required to adequately provide 9-1-1 network services
- Promote cost savings from resource sharing among 9-1-1 systems
- Facilitate interoperability and resiliency for the receipt of 9-1-1 calls
- Reduce the number 9-1-1 systems and reducing the number of PSAPs
- Cost savings resulting from 9-1-1 system consolidation

2.) The AT&T services provided to E-COM will comply with all Federal and State laws and National Emergency Number Association Standards (NENA) and be NENA I3 compliant

(NENA-STA-010.3a-2021). The NG9-1-1 service is being provided by Motorola CallWorks Emergency Call Handling Servers and Software. All system communications will be Internet Protocol. Both NG9-1-1 ESInet and Network Services will be monitored by AT&T Security Operations and Network Operations Centers 24-7-365 which will handle incidents and notifications per FEMA Incident Command System protocols. The E-COM facility was designed, constructed, and complies with NFPA 1221 (2002) and referenced standards for emergency communications centers. E-COM complies with current Illinois State Police (ISP) requirements for training and provision of Emergency Medical Service (EMS) instruction of obtaining licensure through the Illinois Department of Public Health (IDPH) for Emergency Medical Dispatch (EMD) services. Telecommunicators are trained and certified using APCO, Intl. for EMD certification. Southcom is already NG9-1-1 complaint. Both dispatch centers will be NG9-1-1 compliant prior to consolidation. This technology will be implemented at the new dispatch center prior to going live.

3.) Each AT&T NG9-1-1 server premise will be connected to AT&T's redundant ESInet service as provided to the State of Illinois. Each AT&T NG9-1-1 server premise will be connected to E-COM by means of a 24-7-365 monitored AT&T Switched Ethernet (ASE) fiber based Internet Protocol (IP) circuit. E-COM currently has and will retain diversely routed AT&T provided fiber based IP circuits. The AT&T NG9-1-1 servers and services will be shared with other 9-1-1 Authorities and PSAPs as provided in

AT&T's Service Agreement was executed with the State of Illinois.

4.) Prior to cutover, AT&T will transition duplicate circuit appearances from E-COM's Centralized Automatic Message Accounting (CAMA) based 9-1-1 system, which includes legacy wireline, wireless and VoIP services which are currently selectively routed from AT&T's Central Office facility into the ESInet Legacy Network Gateway (LNG) and Motorola CallWorks NG9-1-1 server equipment. This will include the selective routing database currently in use for legacy E9-1-1 services. AT&T will provide ongoing connection to Legacy Selective Routers and gateways per NENA standards for receipt and transfer of

9-1-1 calls using the Legacy Network Gateway.

5.) The E-COM resides in the 708 area code. The current mechanism of separation is the CAMA trunked selective routing system provided by AT&T which recognizes address based on Emergency Service Number (ESN) exchange routing for wireline calls, carrier based location systems from wireline carriers and subscriber addressed based routing from VoIP providers. The new AT&T ESInet service will provide 9-1-1 call routing to E-COM using both ESN (tabular) and Geographic Information System (GIS) (spatial) routing on the Vesta Host Service. Should E-COM become unable to answer and process 9-1-1 calls, SouthCom Dispatch Center "SouthCom" continues to provide assistance to E-COM as the backup PSAP. In the event of a failure or overflow of 9-1-1 calls, incoming 9-1-1 calls will be routed, answered, and processed by SouthCom.

6.) The NG9-1-1 database will be maintained by AT&T as contracted with the State of Illinois. E-COM and/or a third party contractor will make necessary corrections through the ISP or AT&T provided portal to maintain accuracy.

7.) Database updates regarding addresses will be performed by designated E-COM staff on an as-needed basis. Mapping changes to the ISP/AT&T database will be performed by a third-party GIS contractor which has been contracted by E-COM.

8.) Communications with the redundant AT&T servers and the ESInet connected border-wall servers is provided through a fiber based AT&T Switched Ethernet (ASE) Virtual Private Network (VPN) circuit between E-COM ETSB and it's on premise Motorola CallWorks server. The last-mile circuit from AT&Ts central office to the PSAP is implemented over diversely routed fiber circuits which enter the E-COM facility on the north side of the facility.

E-COM utilizes HikVision video surveillance and proximity key fob configuration security devices in our facility. The operating system for HikVision is contained in our equipment room which follows current NFPA 1225 Standards for power and security. This video surveillance equipment includes thermal imaging cameras inside the server room as well as application notifications for people identification when a person enters the server room or walks near the entrance door to the server room. Entrants to the equipment room must first be admitted to the Dispatch Center after identification by working staff. All NG9-1-1 equipment, wiring and cabling is contained in the lower basement level of E-COM as defined in NFPA 1221 and requires vetting by operating personnel prior to admittance into that secure environment.

The network infrastructure at E-COM includes two ASA Firewalls, a Barracuda Webfilter, and an Office 365 Spam Filter between all external and internal traffic. All user accounts are password protected with password complexity required. User passwords are rotated every ninety (90) days.

The required ASE fiber based connectivity will be available to E-COM within AT&T's monitored internal network and covered by AT&T security measures otherwise approved by the ISP. These include monitoring network operations.

24-7-365 at multiple security centers. Sensitive data resides in trusted data centers that employ logical and physical access controls. Hardware and software elements have been tested using stringent management processes that incorporate penetration scan testing. All AT&T buildings, Network Operations Centers (NOC) and data centers are monitored by 24x7 security and access control systems.

E-COM currently does not have the capability to accept text-to 9-1-1. E-COM intends to utilize the text-to-9-1-1 platform selected by the State of Illinois. We are exploring other options currently.

The following request is to update South Cook Communications Center PSAP to include all named units of government member agencies for Wireless 9-1-1 Calls upon completion of the new PSAP facility construction.

The covered jurisdictional boundaries include the City of Country Club Hills and the Villages of East Hazel Crest, Flossmoor, Glenwood, Hazel Crest, Homewood, Matteson, Park Forest, Richton Park, Riverdale, South Holland, and Thornton.

The South Cook Communications Center PSAP dispatches emergency medical services, fire and police.

The 9-1-1 system provider is AT&T Project Manager Lisa Wirtanen (Office 708-229-0388) 4918 W. 95th St Oak Lawn, IL 60453

South Cook Communications Center will implement Phase II cellular coverage with all carriers. An updated network diagram from AT&T is attached to this document. The center will establish call handling agreements with surrounding agencies. Tinley Park will serve as the backup for South Cook Communications Center. Operations will be centralized at a primary PSAP center in Hazel Crest, IL. To ensure continuity during emergencies or failures, the PSAP is planning for redundancy, including CAD production and replication backup on site at Tinley Park, and a backup phone system for fail over. Testing will be conducted with AT&T to verify the seamless transfer of wireless lines from Tinley Park.

E-COM and SOUTHCOM PUBLIC SAFETY COMMUNICATIONS JOINT EMERGENCY TELEPHONE SYSTEM INTERGOVERNMENTAL COOPERATION AGREEMENT

THIS AGREEMENT, entered into on the effective date specified hereafter, by and between the local governments signatory hereto and also those which may hereafter become signatory:

WITNESSETH:

WHEREAS, the signatories have determined that the implementation of an Enhanced 9-1-1 Emergency Telephone System would provide a significant public safety enhancement to the citizens of each of the participating municipalities; and

WHEREAS, the signatories have determined that a Joint Emergency Telephone System would be beneficial on an individual and mutual basis to the residents and agencies served by E-COM and SOUTHCOM; and

WHEREAS, Chapter 50, Act 750, Section 15.4 et seq. of the Illinois Compiled Statutes permits the formation of a Joint Emergency Telephone System Board to oversee the implementation and operation of an Enhanced 9-1-1 Emergency Telephone System; and

WHEREAS, Chapter 5, Act 220, Section 3 of the <u>Illinois</u> Compiled Statutes provides for the joint exercise by two or more local governments of any power, privilege, function or authority; and

WHEREAS, the E-COM E-9-1-1 Emergency Telephone System and the SOUTHCOM E9-1-1 Emergency Telephone System Boards were created by intergovernmental cooperation agreement and under the authority of the Emergency Telephone System Act in 2005 and 2000 respectively; and

WHEREAS, the signatories have individually established an Enhanced 9-1-1 Emergency Telephone System, centralized communications and 9-1-1 system, and are currently operating the same; and

WHEREAS, both the E-COM Emergency Telephone System Board and the SOUTHCOM Emergency Telephone System Board desire to cooperate and form a Joint Emergency Telephone System Board; and

WHEREAS, Public Act 99-0006 has encouraged consolidation of Emergency Telephone System Boards and 9-1-1 systems to advance public safety and to encourage the best use of government funds.

NOW THEREFORE BE IT AGREED BY AND BETWEEN THE PARTIES AS FOLLOWS:

- 1. <u>Venture Established</u>. Pursuant to the joint powers authorization of 50 ILCS 750/15.4, the Emergency Telephone System Act, and 5 ILCS 220/3, the Intergovernmental Cooperation Act, the undersigned hereby join together in a cooperative venture for the joint and mutual operation of an Enhanced 9-1-1 Emergency Telephone System, to be known as ECOM/SOUTHCOM Joint E9-1-1 Emergency Telephone System consisting of all units of local governments which may hereafter become signatory.
- Joint Emergency Telephone System Board. There is hereby established a Joint Emergency Telephone System Board (hereinafter referred to as the "Board") consisting of two (2) representatives from each member unit of local government.

One of the representatives must be any elected or appointed public official of the member unit of government or his/her designee which designee shall be either an elected Trustee or the Administrator/Manager of the member unit of government.

One of the representatives must be a public safety representative of the 9-1-1 public safety agency of the member unit of government including, but not limited to, police departments, fire departments, emergency medical service providers and emergency services and disaster agencies.

Each member unit of local government shall appoint by resolution its representatives to the ECOM/SOUTHCOM Joint Emergency Telephone System Board. A certified copy of this resolution shall be forwarded to the Secretary of the ECOM/SOUTHCOM Joint Board and shall act as the credentials for those representatives to conduct ECOM/SOUTHCOM business on behalf of the specific member unit of local government. Representatives shall serve until replaced by resolution of the appointing member unit of government, or their qualifying relationship ends.

The participating members shall also select, on an annual basis, a resident of a member community to serve as the citizen representative. The method of selection for the citizen member shall be set out in the bylaws.

- 3. <u>VOTING</u>. Each member shall be allowed voting authority as determined by the bylaws.
- 4. <u>BYLAWS</u>. The ECOM/SOUTHCOM Joint E9-1-1 Emergency Telephone System shall be subject to and shall be governed by certain bylaws which

shall be adopted by the Joint Emergency Telephone System Board together with any amendments which may be made in the manner and means provided.

- 5. <u>PARTICIPATION</u>. Each participating member unit of local government in the ECOM/SOUTHCOM Joint Emergency Telephone System, and each unit of local government which may hereafter become a participant, is a member and is entitled to the rights and privileges and is subject to the obligations of membership, all as may be provide in the bylaws.
- 6. <u>TERMINATION</u>. Any party to this Agreement may cease to be a party hereto and may withdraw from participation in the manner and means set forth in the bylaws.
- 7. <u>POWERS OF THE BOARD</u>. The powers and duties of the Joint Emergency Telephone System Board created by this Agreement shall include, but not be limited to the following:
 - A. Planning an Enhanced 9-1-1 and Next Generation 9-1-1 emergency telephone system.
 - B. Coordinating and supervising the implementation, upgrading, maintenance and operation of the system including the establishment of equipment specifications and coding systems.
 - C. Receiving monies from the surcharge imposed under Section 15.3 of the Emergency Telephone System Act, and from any other source, for deposit into the Emergency Telephone System Fund.
 - D. Authorizing all disbursements from the fund.
 - E. Hiring, discipline and termination of an Executive Director whenever in its judgement the best interests would be served thereby.
 - F. Making and entering into contracts with consultants, auditors and attorneys.
 - G. Acquiring, holding and disposing of property.
 - H. The purchase of equipment or of public works pursuant to the public bidding provisions of the Illinois Municipal Code including any future amendments to said statute. Public notice and competitive bids shall not be required for any contract which any one party to the Agreement could by law enter into without public notice and competitive bid.
 - I. Incurring debts, liabilities or obligations necessary for the accomplishment of its purposes.

- J. Operating a centralized communication center.
- K. Purchase or lease of facilities for the services to be provided under this Agreement.
- L. Approval and funding of annual budget and capital equipment fund for the implementation and operating of the system by a two-thirds vote.
- M. Approval of a five-year projection of capital equipment needs and costs of the system by two-thirds vote.
- N. To determine and approve all the contributions due from all the units of government.
- O. To contract for the purchase of insurance, employee benefits and otherwise undertake all actions necessary or incidental to the purposes of this Agreement or the powers set forth herein which are not otherwise prohibited by this Agreement.
- 8. INDEMNIFICATION

The ECOM/SOUTHCOM Joint Emergency Telephone System Board shall indemnify, defend, and hold harmless the member entities, along with their agents and employees, from all claims, causes of action, suits, damages, liabilities, costs, liens, fines, penalties, interest, expenses, or demands including without limitation, reasonable attorney fees and litigation costs incurred by the individual entities in connection with the defense of any action, suit or proceeding in which they are made a party by reason of any action including an omission to act where legally required to do so by ECOM/SOUTHCOM, its officers, agents or employees, in connection with the operation of the dispatch center, unless and except to the extent said claim, cause of action suit, damages, liabilities, costs, liens, fine, penalties, interest, expenses, or demands are the result of actions or omissions by one or more member entities or their officers, agents or employees. Nothing in this section shall prevent any member municipality from exercising any provisions of the Local Governmental and Governmental Employees Tort Immunity Act, 745 ILCS 10/2-102 et seq.

- 9. <u>FUNDING.</u> The ECOM/SOUTHCOM Joint Emergency Telephone System Board shall adopt an annual budget and capital equipment replacement schedule for the operation of the emergency telephone system and the joint dispatch center. The funding formula and allocation of costs shall be set out in the bylaws.
- 10. <u>AMENDMENT</u>. This Agreement may not be amended, except by written agreement and resolution of all the then current parties thereto.

E-COM & SouthCom Public Safety Communications Joint Emergency Telephone System Intergovernmental Cooperation Agreement

- 11. <u>DURATION</u>. This Agreement shall continue in effect until rescinded by unanimous consent of the current parties or until terminated in the manner provided in the bylaws.
- 12. <u>ENFORCEMENT</u>. Each member shall have the right to enforce this Agreement against any other member. If suit is necessary, a defaulting member shall pay reasonable attorney's fees as adjudicated by the Court.
- 13. <u>REPLACEMENT</u>. This Agreement, when effective, shall replace in entirety the prior E-COM Intergovernmental Combined Dispatch and Communications System Agreement and SOUTHCOM By-Laws of the Southern Combined Dispatch and Communication System.
- 14. <u>EFFECTIVE DATE</u>. This Agreement shall become effective when adopted by the individual corporate authorities of the members of E-COM and SOUTHCOM

Over the past few weeks, SouthCom Director Barnes and I have carefully evaluated the alternatives for the backup system of the Joint Emergency Telephone System Board (JETSB) Public Safety Answering Point (PSAP) located at 3700 W. 183rd St., Hazel Crest, IL 60429 as mandated by the Emergency Telephone System Act (50 ILCS 750/).

After thorough consideration, I've decided that the future PSAP will advance with Tinley Park PSAP to serve as the primary 9-1-1 backup system. This decision is based on the following rationale:

- Interoperability- With both PSAPs connected to ESInet, the rerouting of 9-1-1 calls can be executed within seconds in the event of an emergency evacuation. Tinley Park's Director and Radio Technician have agreed to invest in radio frequency interoperability between the two PSAPs, aiming to enhance public safety responder radio efficiency in addition to 9-1-1 routing.
- Consoles- Tinley Park has two consoles readily accessible at any given time, supplemented by an additional four situated remotely at the Tinley Park Police Department, making a total of six consoles available in case of emergencies.
- Travel distance- The distance separating the two PSAPs spans 5.3 to 5.4 miles, with minimal risk of travel disruption. Two primary routes are available, each offering an equal distance and an expected travel time of approximately eleven minutes. Neither route involves highway travel and features minimal traffic control signals.
- Telecommunicator Staffing- At present, the Tinley Park PSAP is staffed at eightyeight percent of the hired full-time equivalent (FTE), aligning closely with the budgeted FTE rate. This staffing level ensures minimal overtime, enabling Telecommunicators to remain refreshed and prepared for emergency events when Tinley Park's 9-1-1 backup system delivery is needed.

- Annual Financial Reports (AFR)- I have confirmed with the Illinois State Police Office of the State 9-1-1 Administrator that Tinley Park PSAP is in up-to-date compliance with their AFR filing requirements, provided there are no future withholdings of 9-1-1 surcharge revenue.
- Emergency Medical Dispatch (EMD) Site License- I've reached out to the EMS Coordinator for the South Cook County EMS System regarding an Emergency Medical Dispatch (EMD) PSAP Agency Site license. Tinley Park currently possesses a valid Illinois Department of Public Health (IDPH) EMS EMD Provider Agency Site License file number 8430EMDA. Consequently, each licensed Telecommunicator in Tinley Park is equipped to handle 9-1-1 emergencies necessitating emergency medical protocols and pre-arrival instructions using the Association of Public-Safety Communications Officials (APCO) EMD. This protocol aligns with the same standards and pre-arrival scripted medical procedures currently upheld by E-COM, and those expected to be adopted by the future PSAP, pending the award of a FY25 NG911 Grant application.
- 9-1-1 Authorities Backup Agreement- The approval process for the 9-1-1 Authorities Backup Agreement at the Tinley Park PSAP is immediate. The Tinley Park Director has the authority to sign off on it without delay. Following this, I will endorse the Agreement and swiftly submit it to the Illinois State Police Office of the State 9-1-1 Administrator to proceed with the processing and approval of the JETSB's 9-1-1 Consolidation Plan.

Considering the reasons stated above, I am fully supporting a lasting partnership with Tinley Park PSAP for the 9-1-1 Authorities Backup Agreement of the upcoming PSAP.
