INTRODUCTION

The following document provides the application for submitting a 9-1-1 Modification Plan that will supply the Illinois State Police (ISP), the Illinois Commerce Commission (ICC), and the Statewide 9-1-1 Administrator (Administrator) with the necessary information about the proposal to modify your 9-1-1 system. The modification plan must comply with 83 Ill. Adm. Code Part 1324.

Areas of testing include 9-1-1 Call Handling, Split Exchange Scenarios, TDD/TTY Accessibility, Network Trunking and Load Management, System Overflow and Failover Protocols, Backup and Alternate Routing Capabilities, Call Transfer Functionality, and NG9-1-1 Addressing, NGCS 9-1-1 GIS Database Validation, Integrated Text to 9-1-1 (SMS/RTT/MMS), API Interoperability, Measurement and Reporting Tools and Voice and Speech Quality Assessment.

WHEREAS, the Village of Stone Park (hereinafter referred to as the "Village") is an Illinois Municipal Corporation organized pursuant to the laws of the State of Illinois;

WHEREAS, the Village of Stone Park is a home rule unit of local government pursuant to the provisions of Article VII, Section 6(a) of the Illinois Constitution with authority granted pursuant to the Illinois Constitution of 1970, to exercise any power and perform any function pertaining to its local government and affairs, including but not limited to the power to tax and incur debt;

WHEREAS, the Village upon approval of the corporate authorities may enter into an Agreement with another party pursuant to Illinois Statute;

WHEREAS, the Village has previously contracted with NORCOMM Public Safety Communications, Inc. (hereinafter referred to as "NORCOMM") for the provisions of an array of services relating to police, fire and emergency dispatch services with a division that operates a 9-1-1 dispatch service;

WHEREAS, the Village has evaluated the comparative costs of 9-1-1 services and with the goal of reducing long-term operational expenses and providing more predictable budgeting for dispatch services for the Village, seeks to transition providers immediately;

WHEREAS, the Village authorizes the termination of the current contractual agreements with NORCOMM effective at the signing of the Intergovernmental Agreement between the Cook County Emergency Telephone System Board (hereinafter referred to as "ETSB") and the Village;

WHEREAS, the Village has determined it is in the best interests of public safety and fiscal responsibility to transition its 9-1-1 call-taking and dispatch services to ETSB;

WHEREAS, the ETSB has the infrastructure, resources, and technical capacity to provide 9-1-1 operations and dispatch services to the Village in compliance with all applicable state and federal laws;

WHEREAS, the Corporate Authorities of the Village of Stone Park are of the opinion that it is in the best interests of the health, welfare and safety of the residents of the Village to approve the agreement with ETSB as provided for herein (see Exhibit A)

NOW, THEREFORE, BE IT RESOLVED, in open meeting assembled by the Village President and Board of Trustees of the Village of Stone Park, Cook County, Illinois pursuant to the Village's Home Rule powers as follows:

Section One – Recitals

The Board of Trustees hereby find that all of the recitals hereinbefore stated as contained in the preamble to this resolution are full, true and correct and do hereby, by reference, incorporate and make them part of this resolution as legislative findings.

Section Two – Approval of Agreement

The Village hereby approves the agreement substantially in the form attached hereto and made a part hereof as Exhibit A. The Corporate Authorities hereby approve the agreement, with such revisions as the President or his designee deems necessary, authorize and direct the President to execute all necessary documents and perform all necessary acts to effectuate the intent of this Resolution.

Section Three – Authorization

The Village President is hereby authorized to execute, and the Village Clerk is hereby authorized to attest the agreement, and affix the Seal of the Village to all such documents as are deemed necessary to effectuate the intent of this resolution, substantially in the form of such agreement attached hereto as Exhibit A, with such changes therein as shall be approved by the Village Attorney and the officials of the Village executing the same, their execution thereof to constitute exclusive evidence of their approval to any and all changes or revisions therein from and after the execution and delivery of such Agreement, whether or not such other documents are attached hereto.

Section Four - Other Actions Authorized

The officers, employees and/or agents of the Village shall take all actions necessary or reasonably required to carry out and give effect to the intent of this resolution and otherwise to consummate the transactions contemplated herein and shall take all actions necessary in conformity therewith including, without limitation, the execution and delivery of all documents required to be delivered in connection with the transaction contemplated herein.

To the extent that any requirement of bidding would be applicable to the transactions contemplated hereunder, the same is hereby waived.

Section Seven - Acts of Village Officials

That all past, present and future acts and doings of the officials of the Village that are in conformity with the purpose and intent of this resolution are hereby, in all respects, ratified, approved, authorized and confirmed.

Section Eight – Passage Clause

This resolution shall be in full force and effect from and after its passage, approval and publication as provided by law.

Section Nine – Conflict Clause

All resolutions, parts of resolutions and/or board actions in conflict herewith are hereby repealed to the extent of such conflict.

Section Ten – Saving Clause

If any section, paragraph, clause or provision of this resolution is declared by a court of law to be invalid or unconstitutional, the invalidity or unconstitutionality thereof shall not affect the validity of any other provisions of this resolution which are hereby declared to be separable.

Section Eleven - Publication

This resolution shall be published in book or pamphlet form as provided by the Illinois Municipal Code.

Section Twelve – Recording

This resolution shall be entered into the minutes and upon the journals of the Board of Trustees of the Village of Stone Park.

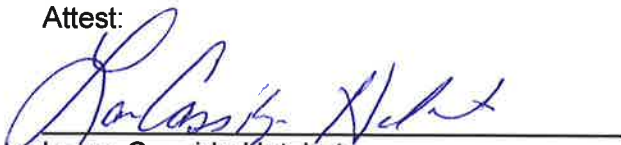

WHEREAS, the Village of Melrose Park, County of Cook, State of Illinois (the “Village”) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, the Village President (the “President”), the Honorable Ronald M. Serpico, the Village Clerk, the Honorable Mary Ann Paolantonio, and the Board of Trustees of the Village (the “Village Board”), the Honorable Arturo J. Mota, Mary Ramirez-Taconi, Jaime Anguiano, Anthony N. Abruzzo, Louis “Sonny” Nicotera and Anthony Williams constitute the duly elected, qualified and acting officials of the Village; and

WHEREAS, the Village of Melrose Park is a home rule unit of local government pursuant to the provisions of Article VII, Section 6(a) of the Illinois Constitution with authority granted pursuant to the Illinois Constitution of 1970, to exercise any power and perform any function pertaining to its local government and affairs, including but not limited to the power to tax and incur debt; and

WHEREAS, the Village is currently a participating member of the Proviso-Leyden Joint 9-1-1 Authority, which delivers consolidated 9-1-1 dispatch services to the communities within Leyden Township and Proviso Township; and

WHEREAS, Section D of Article II of the Proviso-Leyden Joint 9-1-1 Authority Bylaws states as follows:

Termination: Any Member Municipality of the Joint 9-1-1 Authority may terminate its membership at any time upon thirty (30) days written notice to each of the remaining Member Municipalities of the Joint 9-1-1 Authority. All Surcharge Funds (as hereinafter defined) allocated to the Member Municipality that terminates its membership in the Joint 9-1-1 Authority shall be returned to that Member Municipality, within ninety (90) days of said Member Municipality's termination of its membership; and

WHEREAS, the President and the Village Board (collectively, the "Corporate Authorities) have determined that it is in the best interests of the residents of the Village for the Village to issue its notice of intent to terminate its membership with the Proviso-Leyden Joint 9-1-1 Authority; and

NOW, THEREFORE, BE IT RESOLVED, by the Village President and the Board of Trustees of the Village of Melrose Park, County of Cook, State of Illinois, as follows:

ARTICLE I. IN GENERAL

Section 1.0 Incorporation Clause.

All of the recitals hereinbefore stated as contained in the preambles to this Resolution are full, true and correct, and the Village Board does hereby, by reference, incorporate and make them part of this Resolution as legislative findings.

Section 2.0 Purpose.

The purpose of this Resolution is to authorize the President or his designee to take all necessary action to withdraw the Village as a member of the Proviso-Leyden Joint 9-1-1 Authority in accordance with the terms of its bylaws, including the provision of all required written notice, and to direct the President, Village Clerk, and any other appropriate officers, employees, or agents of the Village are hereby authorized and directed to take all actions necessary or desirable to

implement and carry out the intent of this Resolution, including, but not limited to, the issuance and delivery of all required notices.

Section 3.0 Notice of Withdrawal. This Resolution constitutes the Village's formal written notice of its intent to resign from the Proviso-Leyden Joint 9-1-1 Authority. The Village's withdrawal is currently projected for on or about the first quarter of 2027. The Clerk is hereby directed to provide a certified copy of this Resolution to the Proviso-Leyden 9-1-1 Authority.

Section 4.0 Reserved.

ARTICLE II. APPROVAL & AUTHORIZATION

Section 5.0 Authorization.

The Corporate Authorities hereby authorize and approve the withdrawal from the Proviso-Leyden Joint 9-1-1 Authority. The Corporate Authorities hereby further authorize and direct the President to execute and ratify the execution of all necessary documents and perform all necessary acts to effectuate the intent of this Resolution, and to authorize and direct the provision of written notice to the Authority.

Section 6.0 Other Actions Authorized.

The officers, employees and/or agents of the Village shall take all action necessary or reasonably required to carry out and give effect to the intent of this Resolution and shall take all actions necessary in conformity therewith.

ARTICLE III. HEADINGS, SAVINGS CLAUSES, PUBLICATION, EFFECTIVE DATE

Section 7.0 Headings.

The headings for the articles, sections, paragraphs and sub-paragraphs of this Resolution are inserted solely for the convenience of reference and form no substantive part of this Resolution

nor should they be used in any interpretation or construction of this Resolution.

Section 8.0 Severability.

The provisions of this Resolution are hereby declared to be severable and should any provision, clause, sentence, paragraph, sub-paragraph, section or part of this Resolution be determined to be in conflict with any law, statute or regulation by a court of competent jurisdiction, said provision, clause, sentence, paragraph, sub-paragraph, section or part shall be excluded and deemed inoperative, unenforceable and as though not provided for herein, and all other provisions shall remain unaffected, unimpaired, valid and in full force and effect. It is hereby declared to be the legislative intent of the Village Board that this Resolution would have been adopted had not such unconstitutional or invalid provision, clause, sentence, paragraph, sub-paragraph, section or part thereof been included.

Section 9.0 Superseder.

All code provisions, ordinances, resolutions and orders, or parts thereof, in conflict herewith are, to the extent of such conflict, hereby superseded.

Section 10.0 Publication.

A full, true and complete copy of this Resolution shall be published in pamphlet form or in a newspaper published and of general circulation within the Village as provided by the Illinois Municipal Code, as amended.

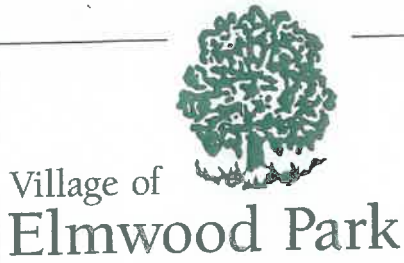
