FIVE YEAR STRATEGIC PLAN FOR MODIFIED PLAN

(Provide a detailed summary of the proposed system's operation, including but not limited to, a five-year strategic plan for implementation of the modified 9-1-1 plan with financial projections)

Narrative:

In anticipating for future consolidations the Cook County ETSB and Sheriff's Office began expanding 9-1-1 operations in July of 2015. The main center in Des Plaines currently has 20 full dispatch positions, 4 call taking positions and 8 positions that are building and waiting for computer equipment.

The Maywood backup center, which was renovated in 2017, has 10 dispatch positions. There are an additional 9 positions that are built and waiting for computer equipment.

The design of the Cook County next generation capable phone system from Zetron is unique in that it provides redundancy with a full independent system at the primary and backup sites. The system allows operators to select which controller they are using which essentially allows the backup center work simultaneously with the primary site. This increases the active call taking positions to 34 with room for 17 additional consoles that can be added as operations grow.

In 2017, through a partnership with the Illinois Department of Transportation, Cock County expanded the Motorola P1 CAD system to add an additional million calls for service per year. This expansion included a refresh of all server software and virtualizes the current environment. Infrastructure upgrades have brought the center up to date on all equipment. This has prepared the Cook County 9-1-1 Center to accept new consolidations without passing on the cost of technology or infrastructure to contract dispatch agencies.

INTERGOVERNMENTAL AGREEMENT BETWEEN THE COUNTY OF COOK ON BEHALF OF THE COOK COUNTY SHERIFF AND CITY OF HOMETOWN

This Intergovernmental Agreement ("IGA") is entered into by and between the County of Cook ("County") on behalf of the Sheriff of Cook County ("Sheriff") and the City of Hometown ("Hometown"), (collectively, the "Parties"), pursuant to authority granted by the Illinois Constitution of 1970, Article VII, Section 10, and The Intergovernmental Cooperation Act, 5 ILCS 220/1 et seq.

I. RECITALS

WHEREAS, the Cook County Emergency Telephone Systems Board ("Cook ETSB") operates the Cook County 9-1-1 system ("9-1-1 System") in the unincorporated areas of Cook County and certain municipalities; and

WHEREAS, the Sheriff processes 9-1-1 calls and provides other services for the 9-1-1 System, including call taking, dispatching, and radio monitoring; and

WHEREAS, the budget for the Sheriff's Office, through the Annual Appropriation Bill adopted by the County Board, currently funds the salary and benefits for in excess of sixty employees who currently staff the 9-1-1 System's communication center; and

WHEREAS, the Hometown Police have conducted their dispatch activity on the Hometown Emergency Telephone Systems Board, but are required to consolidate dispatch services with another emergency telephone systems board; and

WHEREAS, Hometown desires to obtain the Sheriff's 9-1-1 System dispatching services for Hometown Police and agrees to reimburse the Sheriff for providing said services pursuant to this IGA; and

WHEREAS, the Sheriff agrees to provide 9-1-1 System dispatching/monitoring services to Hometown Police twenty-four hours a day, seven days a week;

WHEREAS, the County, the Sheriff and Hometown seek to enter into this IGA where the Sheriff will provide dispatch services to the Hometown Police;

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein, the Parties agree as follows:

II. INCORPORATION OF RECITALS

The recitals set forth above are incorporated herein as though fully set forth.

III. GENERAL PROVISIONS

- A. Term: The term of this IGA shall begin on July 1st 2019 ("Effective Date") and shall continue for five (5) years from the Effective Date ("Termination Date").
- **B.** Termination: Either the Sheriff or Hometown may terminate this IGA at any time after the first three (3) months of the Term upon one hundred eighty (180) days written notice.

C. Roles and Responsibilities:

- The Sheriff agrees to provide 9-1-1 System dispatching services to Hometown twenty-four hours a day, seven days a week. Hometown Police Department dispatch will be done on a Cook County 800 mhz frequency.
- Hometown will adhere to current 9-1-1 Center procedures covering radio use and officer safety practices mandated by the Sheriff's Office.
- Hometown will only be allowed to have TDMA capable radios on the Sheriff's radio system.
- 4) Hometown's obligations under this agreement are contingent upon its execution of a separate Intergovernmental Agreement with ETSB, whereby ETSB agrees to provide Hometown with eight mobile device terminals at no charge, and upon its execution of a separate Intergovernmental Agreement with Cook County, whereby Cook County, acting through the Sheriff, makes available to Hometown up to six portable radios at no charge to Hometown.

D. Operational Reimbursement

 Hometown agrees to reimburse the Sheriff's Office on a monthly basis, with the first invoice being sent prior to commencement of services, for all personnel and operational costs associated with this IGA, including but not limited to costs associated with any additional positions necessary for performance of services ("Sheriff's Reimbursement"). Reimbursements shall take place in accordance with the following schedule, with any partial year prorated based the number of days the IGA has been in effect for that year:

> 1st year of service - \$91,112 2nd year of service - \$94,373 3rd year of service - \$97,906 4th year of service - \$101,562 5th year of service - \$105,628

2) Sheriff will send Hometown a monthly invoice. Payment to Sheriff will be due within thirty (30) days of receipt of invoice.

IV. INDEMNIFICATION

- A. Hometown agrees to indemnify, defend, save and hold the County and the Sheriff, and their respective Commissioners, agents, officers, and employees harmless from and against any and all liabilities, claims, demands or suits brought by any employee of Hometown pursuant to this IGA or member of the public arising out of any negligent act or omission of Hometown and/or its agents, officers, or employees in the performance of this IGA.
- B. The County shall be responsible for the acts of its agents, officers, or employees in the performance of this IGA.

V. DISPUTE RESOLUTION

In the event of a dispute between Hometown and the Sheriff concerning this IGA, each shall designate a representative who shall meet to resolve the dispute. If the designated representatives fail to resolve the dispute, then the Sheriff's General Counsel and Hometown's General Counsel are responsible for promptly resolving the dispute in good faith and in a cooperative manner.

VI. NOTICE

.....

Unless otherwise specified, any notice, demand or request required hereunder shall be given in writing at the addresses set forth below, by any of the following means: (a) personal service during regular business hours; (b) facsimile transmission during regular business hours; (c) overnight courier; or (d) first class mail properly addressed with postage prepaid and deposited in the U. S. Mail. Any notice, demand or request served personally or by facsimile transmission as aforesaid shall be effective upon receipt. Any notice, demand or request served by overnight courier shall be deemed received on the business day immediately following deposit with the overnight courier. Any notice, demand or request served by U.S. mail shall be deemed received two (2) business days following deposit in the mail. Notices shall be served at the following addresses or at such other place as the Parties may from time to time designate in writing by notice given hereunder

The Parties shall at all times observe and comply with all applicable federal, state and local laws, statutes, ordinances, rules, regulations, codes and executive orders, now existing or hereinafter in effect, which may in any manner affect the performance of this IGA.

INTERGOVERNMENTAL AGREEMENT BETWEEN THE COOK COUNTY EMERGENCY TELEPHONE SYSTEM BOARD AND THE CITY OF HOMETOWN (Distribution of 911 Surcharge Funds)

This Intergovernmental Agreement ("Agreement") is entered into by and between the Cook County Emergency Telephone System Board ("ETSB") and the City of Hometown ("City") (individually a "Party" and collectively the "Parties").

I. RECITALS

WHEREAS, the ETSB operates the Cook County 9-1-1 system ("County 9-1-1 System") in unincorporated areas of Cook County and certain municipalities; and

WHEREAS, the State of Illinois has enacted the Emergency Telephone System Act, 50 ILCS 750/0.01, et seq. ("Act") which enables a county to impose a surcharge on billed subscribers of network connections provided by telecommunications carriers at a rate per network connection in order to implement and maintain a 911 Emergency Telephone System ("Surcharge Funds"); and

WHEREAS, pursuant to 50 ILCS 15.4(a)(2), the City has requested that it be included in the County 9-1-1 System and the ETSB has agreed to accept the City into the County 9-1-1 System; and

WHEREAS, the consolidation of the City's Emergency Telephone System Board with the Cook County ETSB has been approved by the Illinois State Police and is effective as of _____; and

WHEREAS, the ETSB receives the Surcharge Funds allocated for each member of the ETSB from the Illinois State Police and the City has agreed to use a specified percentage of those Surcharge Funds to reimburse the ETSB for the use of the County 9-1-1 System including 9-1-1 Center operations and technology; and

WHEREAS, the City and ETSB have agreed that fifty percent (50%) of the City's Surcharge Funds shall be forwarded by the ETSB to the Cook County Sheriff's Office for the payment of a portion of the City's dispatch costs payable to the Sheriff's Office.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein, the Parties agree as follows:

II. INCORPORATION OF RECITALS

The recitals set forth above are incorporated herein as though fully set forth herein.

III. TERM

The term of this Agreement shall commence on ______ which is the date of consolidation approval by the Statewide 9-1-1 Administrator ("Effective Date") and shall continue as long as City is a member of the ETSB ("Term").

IV. TERMINATION

During the Term, either Party may terminate this Agreement upon ninety (90) days written notice to the other Party.

V. DISTRIBUTION OF CITY SURCHARGE FUNDS

The Parties agree that 50% of the City's Surcharge Funds shall be paid by the ETSB, on behalf of the City, to the Cook County Sheriff's Office ("Sheriff") to reimburse the Sheriff for dispatch services pursuant to an Intergovernmental Agreement between the City and the Sheriff dated and the remaining 50% of the City's Surcharge Funds will constitute reimbursement to the ETSB for the support of the 9-1-1 Center's operations and technology ("ETSB Reimbursement"). The ETSB shall make such reimbursement payments quarterly based on the ETSB's fiscal year with any partial year prorated based on the number of days this Agreement has been in effect for that year. The Parties agree that in the event the Illinois State Police or the State of Illinois fail to distribute the Surcharge Funds to the ETSB, for any reason whatsoever, then the ETSB shall withhold reimbursement of the City's Surcharge Funds to both the Sheriff and ETSB until such time as the Surcharge Funds are distributed to the ETSB by the Illinois State Police or the State of Illinois.

VI. INDEMNIFICATION

A. The City agrees to indemnify, defend, save and hold the ETSB and its agents, officers, and employees harmless from and against any and all liabilities, claims, demands or suits brought by any employee of City pursuant to this Agreement or by any member of the public arising out of any negligent act or omission of City and/or its agents, officers, or employees in the performance of this Agreement.

B. The ETSB shall be responsible for the acts of its agents, officers, or employees in the performance of this Agreement.

VII. DISPUTE RESOLUTION

In the event of a dispute between the City and the ETSB concerning this Agreement, each shall designate a representative who shall meet to resolve the dispute. If the designated representatives fail to resolve the dispute, then the City's General Counsel and the ETSB's. Attorney are responsible for promptly resolving the dispute in good faith and in a cooperative manner.

VIII. NOTICE

Unless otherwise specified, any notice, demand or request required hereunder shall be given in writing at the addresses set forth below, by any of the following means: (a) personal service during regular business hours; (b) facsimile transmission during regular business hours; (c) overnight courier; or (d) first class mail properly addressed with postage prepaid and deposited in the U. S. Mail. Any notice, demand or request served personally or by facsimile transmission as

aforesaid shall be effective upon receipt. Any notice, demand or request served by overnight courier shall be deemed received on the business day immediately following deposit with the overnight courier. Any notice, demand or request served by U.S. mail shall be deemed received two (2) business days following deposit in the mail. Notices shall be served at the following addresses or at such other place as the Parties may from time to time designate in writing by notice given hereunder.

AGREEMENT RELATING TO TRANSFER AND REPORTING OF SURCHARGE FUNDS ATTRIBUTABLE TO THE CITY OF HOMETOWN, ILLINOIS

THIS AGREEMENT (the "Agreement") is made and entered into the <u>15th</u> day of <u>October</u>, 2019 (the "Effective Date") by and between the Cook County Emergency Telephone System Board ("Cook County ETSB") and the Des Plaines Valley Emergency Telephone System Board ("Des Plaines Valley ETSB") for the purpose of providing for the transfer of and reporting relating to certain surcharge funds attributable to the City of Hometown, Illinois ("City")(individually a "Party" and collectively the "Parties").

WITNESSETH:

WHEREAS, Section 15.4a of the Emergency Telephone System Act, 50 ILCS 750/1 et seq. (the "Act"), requires any 9-1-1 Authority, as defined by the Act, in a county with a population of at least 250,000 to consolidate such that no 9-1-1 Authority in the county serves a population of less than 25,000; and

WHEREAS, Cook County ETSB operates the Cook County 9-1-1 system in unincorporated areas of Cook County and certain municipalities; and

WHEREAS, in accordance with the Act, Des Plaines Valley ETSB, a Joint ETSB, was created with the City of Hometown, along with other municipalities, participating as a member municipality; and

WHEREAS, pursuant to 50 ILCS 15.4(a)(2), the City of Hometown ("City") requested that it be included in the County 9-1-1 System and the Cook County ETSB has agreed to accept the City into the County 9-1-1 System; and

WHEREAS, in accordance with the bylaws adopted by Des Plaines Valley ETSB, City has provided notice of its termination as a member of Des Plaines Valley ETSB and its intention to join Cook County ETSB; and

WHEREAS, to facilitate City's transition from Des Plaines Valley ETSB to Cook County ETSB, the Parties desire to enter into this Agreement to confirm their understanding that City will cease to be a member of Des Plaines Valley ETSB and will become a member of Cook County ETSB; that, thereafter the boundaries for wireless emergency calls of each Party will change such that wireless emergency calls originating in the City will be handled by Cook County ETSB; and, to provide for the transfer to Cook County ETSB of any funds held by Des Plaines Valley ETSB attributable to City, including any surcharge funds (such as those funds commonly known as wireline and hold harmless surcharge funds) collected pursuant to the Act or any other applicable statute or ordinance (the "Funds").

NOW, THEREFORE, in consideration of the promises and mutual covenants hereafter set forth, the Parties agree as follows:

Section 1. Incorporation of Recitals.

The foregoing preambles are hereby incorporated into this Agreement as if full restated in this Section 1.

Section 2. City Opt-Out.

City has provided the notice required by Des Plaines Valley ETSB's bylaws to terminate its status as a Des Plaines Valley ETSB member municipality and that upon approval of Cook County ETSB's consolidation plan by the State of Illinois' Office of the Statewide 9-1-1 Administrator, City shall become a member of Cook County ETSB.

Section 3. Wireless Call Boundaries.

Upon City becoming a Cook County ETSB member municipality, the wireless call boundaries of Cook County ETSB and Des Plaines Valley ETSB shall change such that all wireless 9-1-1 calls originating in City shall no longer be handled by Des Plaines Valley ETSB and instead shall be handled by Cook County ETSB.

Section 4. Funds.

Once the consolidation plan is approved by the State of Illinois' Office of the Statewide 9-1-1 Administrator, Cook County ETSB shall receive all Funds attributable to City in accordance with the Act. Cook County ETSB will be responsible for all Funds it receives and for the reporting and auditing of all Funds as described in Section 5 below.

Section 5. Financial Reporting of Funds.

Des Plaines Valley ETSB shall be responsible for all required financial reporting relating to the Funds, including the financial report required by Section 40 of the Act, up to and including the date that Cook County ETSB's consolidation plan is approved by the State of Illinois' Office of the Statewide 9-1-1 Administrator. Thereafter, Cook County ETSB shall be responsible for all such reporting.

Section 6. Term.

The term of this Agreement shall commence on the Effective Date and shall end the later of (1) the date which is one (1) year after the date of approval of Cook County ETSB's consolidation plan by the State of Illinois' Office of the Statewide 9-1-1 Administrator or (2) the date upon which Des Plaines Valley ETSB files the last financial report relating to funds attributable to City as required by Section 5 hereof.

Section 7. Counterparts.

This Agreement may be executed in counterparts, each of which shall be deemed to be an original and both of which shall constitute one and the same Agreement.

Section 8. Severability.

If any part of this Agreement shall be held invalid for any reason, the remainder of this Agreement shall remain valid to the maximum extent possible.

Section 9. Governing Law.

This Agreement shall be governed by the laws of the State of Illinois without giving consideration to the principals of conflict of laws.

Section 10. Entire Agreement.

This Agreement represents the entire agreement between the Parties and there are no other promises or conditions in any other agreement whether oral or written.

ALTERNATE AGREEMENT

This agreement made and entered into between the Cook County 9-1-1 System (hereinafter referred to as "COUNTY") and the Northwest Central 9-1-1 System (hereinafter referred to as "NORTHWEST").

WITNESSETT:

WIBREAS, COUNTY has a fully operational BTS (Emergency Telephone System)

WHERBAS, NORTHWEST has a fully functional ETS and

WHERBAS, under Illinois law which an BTS is required to select a location for alternate routing when all 911 lines to the primary Public Safety Answering Point ("PSAP") are busy or if the primary PSAP closes down for a period of time due to an emergency situation; and

WHERBAS, COUNTY is a PSAP, and

WHERBAS, Article VII, Section 10 of the 1970 Illinois Constitution and Chapter 127, Section 748 of the <u>Illinois Revised Statutes</u> authorized an intergovernmental cooperation association to enterinto contract with units of local government, and

WEBRBAS, COUNTY and NORTHWEST mutually desire to enter into an Agreement establishing NORTHWEST as the location for alternate routing of 9-1-1 calls as agreed upon in the "Alternate Routing Agreement" and dispatch of <u>EMERGENCY 9-1-1</u> calls in the event that <u>COUNTY closes</u> down for period of time due to an emergency situation.

TEST PLAN DESCRIPTION

1) Description of test plan (back-up, overflow, failure, database).

The CCETSB has enough capacity to add the Village of Hometown to its existing system with the need for additional lines. The main Cook County dispatch site is located at 9511 W. Harrison in Des Plaines. In the event of a phone line failure, the 9-1-1 lines can either be manually switched over in Des Plaines by staff or switched by the 9-1-1 Resolution Center to Northwest and/or Southwest Central Dispatch system by selective router. The CCETSB has a backup center located in the Cook County Sheriff's Police Headquarters located at 1401 S. Maybrook Drive in Maywood, Illinois. This location is tested on a monthly basis by 9-1-1 Center staff in coordination with the 9-1-1 Resolution Center. Northwest Central Dispatch and Southwest Central Dispatch Centers can handle the overflow calls in the event a trunk line is busy at the CCETSB. The current phone system, which is Zetron Max Call Taking, is connected from Des Plaines to Maywood through an Opt-E-Man circuit and has a backup of a point to point microwave connection. The connection is monitored by the smart switches which can automatically fail over in the event of a disruption. Support for this infrastructure is provided by the Cook County Network Control Center (NCC). In the event that both paths were disrupted, the Zetron controllers can function independently at both locations. The connection between Maywood and Des Plaines is not needed in order to have redundancy.
