Plan Narrative:

The plan narrative statement for the Des Plaines Valley ETSB remains the same except that the Bedford Park PSAP will be dissolved.

The Bedford Park PSAP will dissolve and the Hickory Hills PSAP will serve as the lone PSAP for the Des Plaines Valley ETSB. The Village of Bedford Park has entered into an intergovernmental agreement with the City of Hickory Hills to have the Hickory Hills PSAP dispatch for the Bedford Park Police Department. The Village of Summit has also entered into an intergovernmental agreement with the City of Hickory Hills to have the Hickory Hills PSAP dispatch for the Village of Summit Police and Fire Departments. The proposed effective date for the closure of the Bedford Park PSAP and for Hickory Hills PSAP to handle the dispatching services for the Bedford Park Police Department and the Summit Police and Fire Departments is August 1, 2020. This consolidation will result in the reduction of overall operating expenses for the Des Plaines Valley ETSB. As such, the purpose of this modification is to authorize the closure of the Bedford Park PSAP with the Hickory Hills PSAP handling the dispatching for the Hometown Fire Protection District, Hickory Hills Police Department, Roberts Park Fire Protection District, Bedford Park Police Department, and the Summit Fire Department.

The Village of Bedford Park has decided to close its PSAP and has entered in to an intergovernmental agreement with the City of Hickory Hills for the Hickory Hills PSAP to provide dispatching services for the Bedford Park Police Department. The target date for Hickory Hills to begin providing dispatching services for the Bedford Park Police Department is August 1, 2020. The Village of Summit has decided to close its PSAP and has entered in to an intergovernmental agreement with the City of Hickory Hills for the Hickory Hills PSAP to provide dispatching services for the Summit Police Department and Fire Department. The target date for Hickory Hills to begin providing dispatching services for the Village of Summit is August 1, 2020. The estimated cost to add Summit and Bedford Park to the Hickory Hills PSAP is \$94,176. The closing of the Bedford Park PSAP will result in Hickory Hills becoming the sole PSAP for the Des Plaines Valley ETSB. As such, the purpose of this modification is to authorize the closure of the Bedford Park PSAP with the Hickory Hills PSAP handling the dispatching for the Hometown Fire Protection District, Hickory Hills Police Department, Roberts Park Fire Protection District, Bedford Park Police Department.

TEST PLAN DESCRIPTION

1) Description of test plan (back-up, overflow, failure, database).

The Bedford Park PSAP is the current back-up center to the Hickory Hills PSAP. We are currently in discussions and exploring back up possibilities for Hickory Hills with three multi-juridical consolidated centers. They are Oak Lawn Regional Emergency Center, Southwest Central, and Mid-South Communication ETSB. The ultimate goal is to find a center with as much interoperability as possible. The selection of a back up center would be completed prior to August 1st, 2020 cut over and go live of the consolidation of Bedford Park and Summit to Hickory Hills PSAP. AT&T, wireless, and VoIP providers will be advised of the consolidation so their internal processes can begin and the Hickory Hills PSAP will work with the providers for routing testing and accuracy on or before the cut-over.

2) List wireline exchanges to be tested.

When Bedford Park and Summit consolidates with the Hickory Hills PSAP we will work with AT&T to test and verify the wire lines.

3) List of wireless and VoIP Carriers to be tested.

Wireless and V0IP carriers will be notified of the consolidation so their routing and Phase II service can be tested for accuracy during the consolidation process.

INTERGOVERNMENTAL AGREEMENT BETWEEN THE CITY OF HICKORY HILLS AND THE VILLAGE OF SUMMIT

THIS AGREEMENT made this <u>\langle \infty</u> day of May, 2020, by and between the City of Hickory Hills ("City") and the Village of Summit ("Village") (collectively referred to as "Parties").

WITNESSETH

WHEREAS, Section 10 of Article VII of the Illinois Constitution of 1970 provides for intergovernmental cooperation; and

WHEREAS, the Illinois Intergovernmental Cooperation Act, 5 ILCS 220/1 et seq., further authorizes intergovernmental cooperation; and

WHEREAS, the City and the Village desire to enter into a contractual relationship for the City to provide police and fire dispatch services to the Village.

NOW THEREFORE, in consideration of the mutual promises that the Parties have made to each other, and other good and valuable consideration, the Parties hereby agree as follows:

- 1. Recitals. The above recitals are hereby incorporated as though fully set forth herein.
- 2. Term. This Agreement shall be for a term commencing on August 1, 2020 and terminating on December 31, 2025, unless sooner terminated as provided for herein.
- 3. Provision of Dispatch Services. The City agrees to provide reasonable and customary police and fire dispatch services, including, but not limited to, criminal activity, hazardous material, fire and fire alarm activations, technical rescue, complaints of hazardous conditions, trapped individuals, emergency medical services and related services, for the Village on a 24-hour basis. The Village agrees to promptly provide the City with any and all written documentation or other information necessary to provide the dispatch services for the Village.
- 4. Response Times. The City shall answer emergency calls within nationally accepted times and considering the circumstances and the other obligations of the City and Village at the time of the call. All calls shall be handled in the order received by the City and in accordance with priority as to the nature of the call. The Village shall not use as grounds for terminating this Agreement any unintentional or non-negligent failures by the City to adhere to national response times according to the above standards.

5. Compensation.

- A. The Village shall pay the City the sum of \$103,750, paid in equal monthly installments, for the first five-month period of this Agreement, from August 1, 2020 through December 31, 2020 All payments are due on or before the 5th day of each month. The compensation paid by the Village to the City shall increase as follows: \$256,000 commencing January 1, 2021 through December 31, 2021; \$263,000 for the period covering January 1, 2022 through December 31, 2022; \$270,000 for the period covering January 1, 2023 through December 31, 2023; \$277,000 for the period covering January 1, 2024 through December 31, 2024; and \$284,000 for the period covering January 1, 2025 through December 31, 2025; After this initial five year and five month term, the compensation paid by the Village to the City shall increase 2.5% per annum for each subsequent 12 month period.
- B. In addition to the monthly payments in Paragraph 5A, the Village shall be responsible for its proportionate share of any future capital costs associated with maintaining and/or replacing the equipment necessary to provide emergency dispatch services to the extent that such capital costs are not authorized to be paid using 9-1-1 surcharge funds. The Village's proportionate share shall be calculated based upon the percentage of the call volume attributable to the Village, including any additional parties to whom the City currently provides 9-1-1 dispatch services or with whom the City contracts to provide such services in the future. The City agrees to provide the Village with an itemized bill relating to all capital expenditures for which the Village is required to contribute funding. The Village agrees to remit payment within 60 days of receipt of the invoice.
- C. The services provided under Paragraph 6 of this Agreement shall be included in the charges contained in A.

6. Prisoner Detention

- A. The City agrees to provide prisoner detention services on a 24-hour basis for the Village and further agrees to provide any and all personnel necessary to fulfill its obligations under this subparagraph.
- B. The City is responsible for providing meals to prisoners, conducting regular prisoner checks, and otherwise complying with the Municipal Jail and Lockup Standards promulgated by the Illinois Department of Corrections.

- C. The City is authorized to reject a prisoner if injured or in need of medical attention. The Village shall transport all prisoners in need of medical attention. The Village is solely responsible for supervising any prisoner transportation from the City's lockup facility to a hospital or other medical facility and is also solely responsible for monitoring the prisoner while at the hospital or other medical facility. The Village is similarly responsible for any prisoner transportation from the City's lockup facility to court or other off-site location.
- D. The Village will be allowed reasonable access to the interview room at the lockup facility.
- E. The City is authorized to release prisoners if directed to do so by the Village.
- F. The Village will abide by all Rules and Regulations of the City of Hickory Hills Police Department while at the City's lockup facility.
- G. The Village will use its best efforts to bond and release all arrestees that qualify for release, including those arrestees eligible for an I-bond, prior to the use of the City's lockup facility.
- 7. Liability. The City agrees to use its best effort to transmit messages to the Village, but shall not be responsible for failure to transmit said messages due to damage to its equipment, caused by acts of sabotage, vandalism, or natural disaster or because demand for its services due to emergency calls related to the City or future parties. The determination of the priority of emergency matters shall not be done in an arbitrary or capricious manner.

8. Indemnification.

- A. To the fullest extent provided by law, the Village agrees to save, keep and hold the City, including its agents, employees and elected officials, harmless from any and all claims, causes of action, or damages of every kind, nature and description, including attorneys' fees, arising from or relating to the obligations undertaken by the Village under this Agreement.
- B. The City shall be responsible for the acts of its agents, officers or employees in the performance of this Agreement. The City agrees to indemnify, defend, save and hold the Village, its elected officials, agents, officers and employees harmless from and against any and all liabilities, claims, damages or suits brought by any employee of the City pursuant to this Agreement or member of the public arising out of any negligent act or omission of the City and/or its agents, officer or employees in the performance of this Agreement.

- 9. Consequential Damages. INTERGOVERNMENTAL AGREEMENT BETWEEN THE CITY OF HICKORY HILLS AND THE VILLAGE OF BEDFORD PARK

THIS AGREEMENT made this _____ day of July, 2020, by and between the City of Hickory Hills ("City") and the Village of Bedford Park ("Village") (collectively referred to as "Parties").

WITNESSETH

WHEREAS, Section 10 of Article VII of the Illinois Constitution of 1970 provides for intergovernmental cooperation; and

WHEREAS, the Illinois Intergovernmental Cooperation Act, 5 ILCS 220/1 et seq., further authorizes intergovernmental cooperation; and

WHEREAS, the City and the Village desire to enter into a contractual relationship for the City to provide police dispatch services to the Village.

NOW THEREFORE, in consideration of the mutual promises that the Parties have made to each other, and other good and valuable consideration, the Parties hereby agree as follows:

- 1. **Recitals**. The above recitals are hereby incorporated as though fully set forth herein.
- 2. **Term.** That this Agreement shall be for a term commencing on August 1, 2020 and shall terminate on July 31, 2024. The Agreement shall automatically be extended for one (1) year increments unless either party sends notification that it is terminating the Agreement. Said notification shall be sent at least 180 days in advance of the renewal.
- 3. **Provision of Dispatch Services.** The City agrees to be responsible for the maintenance and upkeep of all the electronic equipment and records which are used or generated in connection with this Agreement in a Criminal Justice Information System (CJIS) compliant manner exclusively utilizing ETSB funds to fulfill its obligation under this paragraph.
- 4. **Response Times.** The City shall answer emergency calls within nationally accepted times and considering the circumstances and the other obligations of the City and Village at the time of the call. All calls shall be handled in the order received by the City and in accordance with priority as to the nature of the call. The Village shall not use as grounds for terminating this Agreement any unintentional or non-negligent failures by the City to adhere to national response times according to the above standards.

5. Compensation.

- A. The Village shall pay the City the sum of \$140,000, paid in equal monthly installments, for the first twelve-month period of this Agreement. All payments are due on or before the 5th day of each month. The compensation paid by the Village to the City shall increase as follows: \$144,000 for the subsequent 12-month period (August 1, 2021 through July 31, 2022); \$148,000 for the period covering August 1, 2022 through July 31, 2023; \$152,000 for the period covering August 1, 2023 through July 31, 2024; and if renewed after the initial four year term, \$156,000 for the period covering August 1, 2024 through July 31, 2025. The compensation paid by the Village to the City for additional annual renewals shall increase 2.5% per annum for each subsequent 12 month period.
- B. In addition to the monthly payments in Paragraph 5A, the Village shall be responsible for its proportionate share of any future capital costs associated with maintaining and/or replacing the equipment necessary to provide emergency dispatch services to the extent that such capital costs are not authorized to be paid using 9-1-1 surcharge funds. The Village's proportionate share shall be calculated based upon the percentage of the call volume attributable to the Village, including any additional parties to whom the City currently provides 9-1-1 dispatch services or with whom the City contracts to provide such services in the future. The City agrees to provide the Village with an itemized bill relating to all capital expenditures for which the Village is required to contribute funding. The Village agrees to remit payment within 60 days of receipt of the invoice.
- C. For the services provided under Paragraph 6 of this Agreement, the Village shall pay to the City the sum of \$100 per day, paid monthly, for the first twelve-month period of this Agreement. A day shall be deemed any amount of time up to 24 hours, anything over 24 hours and less the 48 hours shall be two days, with each subsequent portion of a 24-hour day requiring an additional per day charge. All payments are due on or before the 5th of each month. The compensation paid by the Village to the City shall increase 2.5% per annum for each subsequent twelve-month period.

6. Prisoner Detention

A. The City agrees to provide prisoner detention services on a 24-hour basis for the Village and further agrees to provide any and all personnel necessary to fulfill its obligations under this subparagraph.

- B. The City is responsible for providing meals to prisoners, conducting regular prisoner checks, and otherwise complying with the Municipal Jail and Lockup Standards promulgated by the Illinois Department of Corrections.
- C. The City is authorized to reject a prisoner if injured or in need of medical attention. The City shall direct the Roberts Park Fire Department or any authorized EMS agency to transport all prisoners in need of medical attention. A Village Police Officer shall accompany the transport of the prisoner. The Village is solely responsible for supervising any prisoner transportation from the City's lockup facility to a hospital or other medical facility and is also solely responsible for monitoring the prisoner while at the hospital or other medical facility. The Village is similarly responsible for any prisoner transportation from the City's lockup facility to court or other off-site location.
- D. The Village will be allowed reasonable access to the interview room at the lockup facility.
- E. The City is authorized to release prisoners if directed to do so by the Village.
- F. The Village will abide by all Rules and Regulations of the City of Hickory Hills Police Department while at the City's lockup facility.
- 7. **Liability.** The City agrees to use its best effort to transmit messages to the Village, but shall not be responsible for failure to transmit said messages due to damage to its equipment, caused by acts of sabotage, vandalism, or natural disaster or because demand for its services due to emergency calls related to the City or future parties. The determination of the priority of emergency matters shall not be done in an arbitrary or capricious manner.

8. Indemnification.

- A. To the fullest extent provided by law, the Village agrees to save, keep and hold the City, including its agents, employees and elected officials, harmless from any and all claims, causes of action, or damages of every kind, nature and description, including attorneys' fees, arising from or relating to the obligations undertaken by the Village under this Agreement. The Village agrees to name the City as additional insured on its insurance policy. Any additional premium to be paid from ETSB funds.
- B. The City shall be responsible for the acts of its agents, officers or employees in the performance of this Agreement. The City agrees to indemnify, defend, save and hold the Village, its elected officials, agents, officers and employees harmless from and against any and all liabilities, claims, damages or suits brought by any employee of the City pursuant to this Agreement or member of the public arising out of any negligent

act or omission of the City and/or its agents, officer or employees in the performance of this Agreement. The City agrees to name the Village as additional insured on its liability insurance policy. Any additional premium to be paid from ETSB funds.

- 9. **Consequential Damages.** In no event shall the City be liable to the Village for any special, incidental or consequential damages, including, but not limited to, loss of income, loss of revenue, loss of profits, loss of use, loss of capital, rental expenses, financing, reputation, overhead expenses, or interest, whether based on contract, tort, negligence, strict liability, or otherwise and arising from any cause whatsoever by performance under this Agreement or breach of this Agreement.

P.01 Grade of Service Information

P.01 is a recognized Telecommunications Industry Standard, adopted by NENA for 9-1-1 trunk group sizing. The AT&T Illinois 9-1-1 Tariff lists P.01 as its standard of service in its terms and conditions.

P.01 reviews performed by AT&T begin with a comparison of an aggregate record count in the 9-1-1 ALI database (including Wireless ESRKs and VoIP ESQKs (pANIs)) to the Neal-Wilkinson Table, a standard P.01 measurement guide. This table makes recommendations for trunk group sizing based on the number of lines served by a single trunk group.

If requested, AT&T will initiate a busy study on a customer's 9-1-1 trunk group(s). A busy study is set up to run for a period of 30 days in which advance data is collected (retroactive data is not available). Once completed AT&T compiles the results, in 4 distinct sections:

- Incoming call counts
- Outgoing call counts for 9-1-1 trunk groups this represents the number of calls transferred
 to other agencies as transfers are the only type of outgoing call allowed with 9-1-1 trunks
- Overflow call counts number of calls sent to overflow route
- Trunk group usage breaks down amount of time in which entire trunk group was in use
 (Note: this section includes data in which the selective router completes an algorithm and makes a P.01 sizing requirement based on actual trunk group usage patterns)

The P.01 sizing requirement as indicated by a network busy study has proven to be accurate 99.999% of the time. Once a P.01 sizing requirement is made by the switch as part of a busy study, AT&T may adjust a 9-1-1 trunk group in size accordingly.

As a rule, AT&T does not trunk for exigent circumstances, but bases trunk group sizing on regular call patterns. AT&T offers overflow routing to accommodate exigent circumstances as allowed by the Selective Router software.

Combined 9-1-1 Traffic Delivery

For those customers who are currently using separate trunk groups for wireline and wireless 9-1-1 call delivery, AT&T offers an option to combine the traffic into a single trunk group for more efficient call delivery. If a customer wishes to pursue this option, it is first performed on a trial basis. During the trial period, AT&T will temporarily route all 9-1-1 calls to the same trunk group, while leaving the other trunk group in place (not in use). A busy study is run in parallel to the trial period to verify combined traffic delivery is successful for that agency. Once the busy study results prove the success of combined traffic, permanent routing changes are made and the unused network elements are disconnected.

Example: PSAP A has 2 trunk groups, 1 group of 6 trunks dedicated to wireline traffic, 1 group of 4 trunks dedicated to wireless traffic. Initial P.01 review shows the total number of lines supported by PSAP A requires 4 trunks total for both wireline and wireless 9-1-1 calls. A combined traffic trial is initiated and all 9-1-1 calls are directed to existing 6-member trunk group. A network busy study is run concurrently with the trial. Busy Study results show the required number of trunks to support all calls in a single group is 5 trunks. Once approved by the agency requesting the trial and the final number of trunks are agreed upon, permanent routing changes are made and unused network elements are disconnected.

This Agreement made and entered into between the Southwest Central 9-1-1 System, an intergovernmental cooperation association and Emergency Telephone System Board and Southwest Central Dispatch, an intergovernmental cooperation association and Public Safety Answering Point, (herein after referred to as "SOUTHWEST911") and the Des Plaines Valley Emergency Telephone System Board, a 9-1-1 Authority and a Public Safety Answering Point (hereinafter referred to as "DVETSB").

WITNESSETH:

Whereas, DVETSB currently provides Enhanced 9-1-1 service to the City of Hickory Hills and the Villages of Bedford Park and Summit; and

Whereas, SOUTHWEST911 currently provides Enhanced 9-1-1 service to the Cities Palos Heights, Palos Hills and the Villages of Chicago Ridge, Crestwood, Lemont and Worth; and

Whereas, under Illinois law an ETSB is required to select a location for alternate routing when all 9-1-1 lines to the primary Public Safety Answering Point ("PSAP") are busy or if the primary PSAP closes down for a period of time due to an emergency situation; and

Whereas, Article VII, Section 10 of the 1970 Illinois Constitution and Chapter 127, Section 748 of the Illinois Revised Statutes authorize an intergovernmental cooperation to enter into contracts with units of local government; and

Whereas, SOUTHWEST911 and DVETSB mutually desire to enter into an Agreement establishing SOUTHWEST911 as the location for alternate routing of 9-1-1 calls when all 9-1-1 lines to DVETSB are busy or in the event that DVETSB closes down for a period of time due to an emergency situation,

Now, Therefore, in consideration of the above premises, and also the mutual covenants contained herein, SOUTHWEST911 and DVETSB do hereby agree as follows:

Beginning upon the effective date of this Agreement, when, at any time, the 9-1-1
lines of DVETSB serviced by the AT&T Elk Grove Tandem Office are busy or in the
event that DVETSB closes down for a period of time due to an emergency situation,
DVETSB shall instruct AT&T to reroute these 9-1-1 calls to SOUTHWEST911 via their
designated 9-1-1 trunks. SOUTHWEST911 agrees to process all calls rerouted to
SOUTHWEST911 as set out above.

- 2. When there is a need for alternate routing, DVETSB will contact SOUTHWEST911 and advise the reason for the alternate routing request, the length of time the alternate routing will need to be in effect (if possible), provide personnel from DVETSB to assist SOUTHWEST911 and provide an estimated time of arrival of the DVETSB personnel to assist at SOUTHWEST911 dispatch center.
- SOUTHWEST911 agrees to serve as DVETSB's backup PSAP without any compensation, except as provided in this Agreement.
- 4. Any notice permitted or required to be given hereunder by DVETSB or SOUTHWEST911 shall be in writing and shall be personally delivered or mailed, by registered or certified US Mail, postage prepaid, return receipt required, to the party to receive the same as follows:

Notice by US Mail shall be considered served four (4) days after mailing.

- 5. This Agreement shall be effective when executed by the proper officials of SOUTHWEST911 and DVETSB. Unless otherwise terminated, this Agreement shall remain in effect perpetually until either SOUTHWEST911 or DVETSB notifies the other, by means of a one hundred and twenty (120) day notice, that this Agreement shall be terminated on a date no less than one hundred twenty (120) days after service of notice to terminate this Agreement.
- 6. If in the event a Court of proper jurisdiction determines that any paragraph or paragraphs of this Agreement are invalid, the parties agree that such invalidity shall not affect the validity of the remaining portions of this Agreement.
- 7. This Agreement is not assignable by SOUTHWEST911 nor DVETSB and any purported assignment of this Agreement by SOUTHWEST911 or DVETSB shall be null and void, provided however SOUTHWEST911 or DVETSB shall be entitled to assign this Agreement to any successor entity of SOUTHWEST911 and DVETSB.

- 8. The persons signing the Agreement on behalf of SOUTHWEST911 or DVETSB warrant that they have actual authority to enter into this Agreement on behalf of SOUTHWEST911 and DVETSB respectively.
- 9. This Agreement constitutes the complete, final, and entire Agreement between SOUTHWEST911 and DVETSB regarding the subject matter of this Agreement.
- 10. Any modification to this Agreement must be in writing and signed by both SOUTHWEST911 and DVETSB.
- 11. This Agreement shall be governed and construed in accordance with the laws of the State of Illinois.
- 12. The effective date of this agreement shall be the latest date this Agreement is signed by SOUTHWEST911 and DVETSB.
