ORDER OF THE STATEWIDE 9-1-1 ADMINISTRATOR

WHEREAS, the Tazewell County ETSB submitted a consolidation plan with the Office of the Statewide 9-1-1 Administrator on December 28, 2017, seeking to consolidate by reducing the number of PSAP's within their Enhanced 9-1-1 System by 50% or no more than two as required by the Emergency Telephone System Act;

WHEREAS the consolidation plan has been read and reviewed by the Department, the Illinois Commerce Commission, and the Administrator; and

WHEREAS the consolidation plan seeks to reduce the number of PSAP's within the Enhanced 9-1-1 System from 4 PSAP's to 2;

NOW THEREFORE, the Administrator orders the following;

IT IS HEREBY ORDERED that the Tazewell County ETSB's request for approval of its consolidation plan as follows:

- to close the Washington Police Department PSAP on May 30, 2018
- to close the East Peoria PSAP on August 1, 2019

pursuant to Section 15.4a of the Emergency Telephone System Act, 50 ILCS 750/15.4a, is hereby approved subject to the requirements of this Order.

IT IS FURTHER ORDERED that the Tazewell County ETSB's consolidation be completed no later than August 1, 2019.

IT IS FURTHER ORDERED that the Tazewell County ETSB's Service Provider conduct a P.01 Study and if necessary a Traffic Study to determine the number of 9-1-1 trunks required to serve the Tazewell County PSAP's.

IT IS FURTHER ORDERED that the Tazewell County ETSB will be required to file a Progress Report on or before March 31, 2018, and every quarter thereafter describing in detail the steps that have been taken and the progress that has been made toward completing its consolidation to the Office of the Statewide 9-1-1 Administrator.

This Order is a final administrative decision of the Statewide 9-1-1 Administrator subject to review under the Administrative Review Law, 735 ILCS 5/3-101. In the event you wish to seek review of or appeal this Order, you are advised:

- 1. Every action seeking review of such final decision shall be commenced by the filing of a Complaint and the issuance of Summons in the Circuit Court within 35 days from the date a copy of the decision was served upon the parties.
- 2. In your action seeking review you must name in the Complaint, and issue a Summons for, each party of record to the case other than yourself.
- 3. Attached below is a list of all parties of record to this case, including the name and address of the agency or officer entering the Order, and the addresses of each party where the parties may be served with pleadings, notices, or service of process for any review or further proceedings.
- 4. You are not required to file any motion or request for reconsideration with the Department or the Statewide 9-1-1 Administrator before filing your action for review in the Circuit Court. The administrative rules of the Department do not require or allow for any further proceedings before the Statewide 9-1-1 Administrator.
