# ORDER OF THE STATEWIDE 9-1-1 ADMINISTRATOR

WHEREAS, the Naperville ETSB submitted a modification plan with the Office of the Statewide 9-1-1 Administrator on August 30, 2017, seeking to opt in the City of Aurora and the Village of North Aurora;

WHEREAS the modification plan has been read and reviewed by the Department and the Administrator; and

WHEREAS the modification plan seeks to opt in the City of Aurora and the Village of North Aurora into the Naperville ETSB from the Kane County ETSB;

NOW THEREFORE, the Administrator orders the following;

IT IS HEREBY ORDERED that the Naperville ETSB request for approval of its modification plan as follows:

Opting in the City of Aurora and the Village of North Aurora from the Kane County ETSB to the Naperville ETSB

pursuant to Section 15.4a of the Emergency Telephone System Act, 50 ILCS 750/15.4a, is hereby approved subject to the requirements of this Order.

IT IS FURTHER ORDERED that the Naperville ETSB modification will be completed no later than November 30, 2017.

IT IS FURTHER ORDERED that Naperville's 9-1-1 System Service Provider will conduct a P.01 Study and if necessary a Traffic Study to determine the number of 9-1-1 trunks required to serve the Naperville and Aurora PSAP's.

IT IS FURTHER ORDERED that Naperville ETSB will file with the Administrator a Wireless 9-1-1 Plan to included Aurora and North Aurora with an effective date no later than November 30, 2017.

IT IS FURTHER ORDERED that the Aurora and North Aurora surcharge payments currently being distributed to the Kane County ETSB shall begin to be distributed to the Naperville ETSB as defined in 50 ILCS 750/30 beginning December 1, 2017.

IT IS FURTHER ORDERED that the Kane County ETSB will transfer any reserve fund balance to the Naperville ETSB by December 31, 2017.
