ORDER OF THE STATEWIDE 9-1-1 ADMINISTRATOR

WHEREAS, the Joint Central Lake County ETSB submitted a modification plan with the Office of the Statewide 9-1-1 Administrator on July 25, 2019, seeking to opt in the City of North Chicago;

WHEREAS the modification plan has been read and reviewed by the Department and the Administrator; and

WHEREAS the modification plan seeks to opt in the City of North Chicago into the Joint Central Lake County ETSB from the North Chicago ETSB;

NOW THEREFORE, the Administrator orders the following;

IT IS HEREBY ORDERED that the Joint Central Lake County ETSB request for approval of its modification plan as follows:

Opting in the City of North Chicago from the North Chicago ETSB to the Joint Central Lake County ETSB

pursuant to Title 83: Public Utilities Chapter IV: Department of State Police Part 1325 - Standards of Service Applicable to 9-1-1 Emergency Systems Section 205, is hereby approved subject to the requirements of this Order.

IT IS FURTHER ORDERED that the Joint Central Lake County ETSB modification will be completed no later than April 1, 2020.

IT IS FURTHER ORDERED that the Joint Central Lake County ETSB's 9-1-1 System Service Provider will conduct a P.01 Study and if necessary, a Traffic Study to determine the number of 9-1-1 trunks required to serve the Joint Central Lake County ETSB with the addition of North Chicago.

IT IS FURTHER ORDERED that the Joint Central Lake County ETSB will file with the Administrator a Wireless 9-1-1 Plan to include North Chicago with an effective date no later than April 1, 2020.

IT IS FURTHER ORDERED that North Chicago surcharge payments currently being distributed to the North Chicago ETSB shall begin to be distributed to the Joint Central Lake County ETSB as defined in 50 ILCS 750/30 beginning no later than April 1, 2020.

IT IS FURTHER ORDERED that the North Chicago ETSB will transfer any reserve fund balance to the Joint Central Lake County ETSB no later than May 1, 2020.

IT IS FURTHER ORDERED that North Chicago will submit a close out AFR Report no later than May 1, 2020 that will include the reporting of surcharge and other Revenue received from January 1, 2020 through the end of the month that the modification is completed when the surcharge is scheduled to be transitioned to the Joint Central Lake County ETSB. In the event that North Chicago has not submitted their 2020 Close Out AFR by May 1, 2020, surcharge shall be withheld until their Close Out AFR Reports have been filed and accepted.
