

## PLAN NARRATIVE:

The La Salle County 9-1-1 System is transitioning from E9-1-1 to Next Generation 9-1-1 (NG911). AT&T is the NG 9-1-1 system provider ("SSP") with Frontier as the local telco service provider. The La Salle County 9-1-1 System will comply with all Federal and State laws and with National Emergency Number Association Standards (NENA) that pertain to NG911 including the NENA i3 Standard for Next Generation NENA-STA-010.3a-2021. The State of Illinois has selected AT&T to provide a statewide Next Generation 9-1-1 System. AT&T's ESInet combines AT&T's network capabilities with technology from Intrado life & Safety, Inc. (Intrado). The AT&T ESInet solution will facilitate an efficient transition from legacy 9-1-1 networks to networks capable of supporting the growing demands of a mobile society. With AT&T ESInet, the State is taking advantage of AT&T's investment in a pre-built, cloud-based solution that delivers next-generation functionality. AT&T will provide service in concert with local telco provider, Frontier Telephone. AT&T is also providing their industry-leading AT&T VPN MPIS network for primary access to all PSAPs. AT&T's ESInet solution is a combination of their IP network and Next Gen Core Services (NGCS) components that includes industry leading SLAs, management services and tools to help ensure that they provide the best possible service. The design is based on building redundant systems to avoid any single point of failure (SPOF) in the ESInet and the overall NG9-1-1 Network Architecture. The NG9-1-1 system will provide flexibility in the routing of calls. The ESInet being deployed has all PSAPs connected and can route calls based on not only location, but also by availability. In a Next Generation solution, a call will be answered through intelligent routing. Additionally, there will be more available positions to answer calls because all connected and tested PSAPs will be technically able to answer the call and will be able to dispatch or transfer the call to another PSAP. Further, while the IVRD and Ottawa PSAPs are both currently providing Text To 9-1-1 service, all three (3) PSAPs expect to be providing Text To 9-1-1 after NG9-1-1 service is implemented. Back-up and overflow under the proposed NG9-1-1 system will remain exactly the same as they currently operate today under the E9-1-1 system in that IVRD will back-up the La Salle County Sheriff PSAP and the Ottawa PSAP and the Ottawa PSAP will back-up the IVRD PSAP. Because all three (3) PSAPs fall under the single governing authority of the La Salle County Joint ETSB no intergovernmental agreements are required for back-up or overflow with other outside governed agencies. Local telco provider Frontier will work together with AT&T to provide dependable call routing with Frontier routing their 9-1-1 calls to AT&T's ESInet for final delivery to the three (3) PSAPs.

## Plan Narrative:

AT&T's ESInet defense-in-depth-security is built into the architecture. AT&T's global IP network is monitored by 8 different Security Operations Centers (SOC) facilities located across the world. AT&T uses its security portfolio capabilities to protect their data centers and networks. AT&T's six geographically diverse and fully redundant facilities with scalable capacity capable of supporting more than twice the 9-1-1 busy hour call for the entire U.S. AT&T has documented business continuity and restoration plans, including complex disaster and evacuation contingencies. The 24x7 operations center employs an incident handling process modeled on FEMA's Incident Command System, with notifications built into the process.

The ESInet is monitored 24x7x365 from a NOC with tier 2 and tier 3 technical resources dedicated to the AT&T ESInet. AT&T's 9-1-1 Resolution Center has dedicated public safety resources. The AT&T ESInet provides a flexible routing platform that supports both ESN (tabular) and GIS (spatial) routing on the same Emergency Call Routing Function (ECRF). The AT&T ESInet solution will interconnect to legacy selective routers as defined per NENA standards. AT&T provides redundant, public safety grade points of presence in each LATA for OSP ingress locations for Legacy Network Gateways (LNGs).

AT&T will interconnect to Legacy Selective Routers, including Frontier Telephone, to transfer and/or receive calls with Automatic Number Identification (ANI) and Automatic Location Identification (ALI) information to the State's NGCS via legacy means through the Legacy Selective Router Gateway (LSRG). Interconnections will also allow legacy PSAPs served by legacy selective routers to serve as the abandonment route for PSAPs served by the AT&T ESInet solution.

Connectivity extends beyond the internal ESInet transport to external network and OSP interfaces. The ESInet supports both TDM and IP OSP ingress at geographically distributed Points of Interconnection (POI's). The ESInet supports standards-based protocol interfaces to external ESInets for call hand-off and call transfers. With pre-established connectivity capabilities, PSAPs on the ESInet have the ability to transfer calls to PSAPs on other ESInets or PSAPs that have not yet transitioned off legacy selective routers.

AT&T will coordinate getting the OSPs records into the AT&T ESInet database. AT&T will also jointly plan the interconnecting network with the OSP. Circuits will be ordered and implemented between the OSP and the ESInet POI. The ESInet POI may reside in an AT&T office or hub. AT&T will cooperatively test and turn up all trunking arrangements with the OSP. Traffic migrations from the legacy to new AT&T infrastructure will follow. Integrated Text-to-911 is supported by the ESInet.

AT&T is responsible for negotiating interconnection agreements and trunking arrangements with each service provider. Interconnection agreements will include the roles and responsibilities of the Parties related to the exchange of 9-1-1 traffic including but not limited to, split rate centers, tandem to tandem and IP connections. GIS data is submitted to the AT&T ESInet via a web-based spatial interface (SI) portal. The portal provides secure GIS file transfer. 9-1-1 Authorities can maintain their local database schema and configure database changes using attribute field mapping tools.

The Spatial Interface (SI) validation engine logs errors and refers errors back to the originating 9-1-1 Authority in comprehensive reports that are retrieved in the 9-1-1 Enterprise Geospatial Database Management System (9-1-1EGDMS). Validation errors are corrected by the 9-1-1 Authority within their own GIS database. Updates are submitted and processed on an on-going basis.

AT&T's ESInet cyber security policies, standards, and guidelines are consistent with industry best practices as defined by International Organization for Standardization and Control Objectives for Information and related Technology. The AT&T ESInet is a highly secure, privately managed IP network providing IP based call routing services for next generation 9-1-1 call delivery. All inbound and outbound traffic interactions are with pre-authorized entities, utilize agreed upon protocols and traverse controlled access points. Call processing and real-time data delivery are protected through both physical and logical controls.

Sensitive data resides in trusted data centers that employ logical and physical access controls. All hardware and software elements deployed in a production environment go through stringent release management processes that incorporate thorough penetration scan testing. Corporate and development environments are separate from production and are not used in development or system test environments. Inter-zone traffic is restricted to only that of authorized personnel and the necessary protocols destinations used to support the management and applications of the ESInet with all other traffic implicitly denied by way of redundant and diverse Session Border Controllers (SBC) and stateful firewalls.

A Network Operations Center (NOC) staffed 24 hours a day, seven days a week, 365 days a year to actively monitor and manage the AT&T ESInet end-to-end service is provided. When a potential or actual Customer-affecting issue is detected, the Incident Administration team is engaged by the NOC. The team uses established processes that are ISO 9001:2008-compliant for immediate escalation, notification, resolution, and reporting. All buildings, NOC and Data Center access are monitored by 24x7 security and access control systems.

# FIVE YEAR STRATEGIC PLAN FOR MODIFIED PLAN

Narrative:

**History:**

La Salle County 9-1-1 service originally consisted of six (6) PSAPs that operated under the authority of seven (7) separate ETSBs. In 2017 in compliance with Illinois Public Act #099-0006 the number of PSAPs was reduced from six (6) to three (3). At that time those three (3) PSAPs came under the authority of a single newly created La Salle County Joint ETSB with all the previously established ETSBs de-certified and dissolved. With this application it is now the intention of the La Salle County Joint ETSB to migrate the E9-1-1 service at these existing three (3) PSAPs from E9-1-1 service to NG9-1-1 service.

**Call Handling Agreements:**

La Salle County ETSB has "Call Handling Agreements" with all participating agencies and all adjacent public safety agencies listed in its 9-1-1 plan. Copies of these agreements are currently on file with the Illinois State Police and were re-certified with both the Illinois State Police and the Illinois Attorney General in January 2023 as required under the Emergency Telephone System Act (50 ILCS 750). There are no changes to these agreements as a result of this plan modification.

**Time Line:**

The La Salle County ETSB expects to migrate from E9-1-1 to NG9-1-1 services in June of 2023. At this time the exact cut-over is not yet known. The ETSB will continue to operate three (3) PSAPs (La Salle County Sheriff in Ottawa, Ottawa-Marseilles PSAP in Ottawa, and Illinois Valley Regional Dispatch in Peru). These PSAPs will continue to provide emergency communication services to the citizens of La Salle County and will continue to operate under the governing authority of the La Salle County Joint ETSB.

**Costs:**

Under the proposed NG911 Plan all La Salle County ETSB PSAPs will continue to share and manage costs and efficiencies and will provide both redundancy, back-up, and overflow services to each other.

It shall be the responsibility of your agency to maintain the report of the call and the disposition of each call received.

Emergency Telephone System Board)

WHEREAS, the County of LaSalle ("County"), on behalf of the LaSalle County Emergency Telephone System Board ("LaSalle County ETSB"), established and operated an Emergency Telephone System Board ("ETSB") pursuant to Section 15.4 of the Emergency Telephone System Act (50 ILCS 750/15.4) as set forth in Ordinance No. 04-101 on August 12<sup>th</sup>, 2004 (Emergency Telephone System Board) of the LaSalle County Code, as amended (the "Code"); and

WHEREAS, the Emergency Telephone System Act (50 ILCS 750/1 *et seq.*), the Wireless Emergency Telephone Safety Act (50 ILCS 751/1 *et seq.*) and the Prepaid Wireless 9-1-1 Surcharge Act (50 ILCS 753/1 *et seq.*) authorize the collection of certain surcharges to assist municipalities with the delivery of emergency dispatch services, 9-1-1 communication services and wireless E-9-1-1 communication services (collectively referred to as "surcharges" or "surcharge funds"). The County receives statutorily authorized surcharges and the County's ETSB expends such surcharge funds in accordance with the applicable State laws; and

WHEREAS, Section 15.4 of the Emergency Telephone System Act (50 ILCS 750/15.4), as amended by Public Act 99-006 (effective July 2, 2015), authorizes two or more municipalities that impose a surcharge pursuant to Section 15.3 of the Act (50 ILCS 750/15.3) to establish by intergovernmental agreement a "Joint Emergency Telephone System Board" ("JETSBS"), provided that the local emergency telephone system boards are terminated by ordinances that rescind their establishment, authority and operational functions; and

WHEREAS, the Corporate Authorities of LaSalle, the City of Marseilles ("Marseilles"), the City of Mendota ("Mendota"), the City of Oglesby ("Oglesby"), the City of Ottawa ("Ottawa"), the City of Peru ("Peru"), and the County of LaSalle, Illinois on behalf of the LaSalle County Emergency Telephone System Board ("LaSalle County ETSB") (collectively referred to as the "Participating Members") have each agreed to adopt ordinances that approve an intergovernmental agreement ("IGA") to provide for the establishment of an intergovernmental cooperative venture known as the "LaSalle County Joint Emergency Telephone System Board" (also referred to as "LaSalle County JETSBS"). The purpose of the LaSalle County JETSBS is to oversee the consolidation of six (6) existing public safety answering points into three (3) public safety answering points, to administer the receipt and allocation of surcharge funds and any other revenues budgeted for ETSB purposes (collectively "ETSB funds") based on a cost-sharing formula or as otherwise directed in the IGA to assist in funding the operations of the three (3) public safety answering points and the LaSalle County JETSBS, and to provide general coordination of the delivery of emergency dispatch services and 9-1-1 communication services and wireless E-9-1-1 communication services within the service territories of the Participating Members of the LaSalle County JETSBS; and

**WHEREAS**, the three (3) public safety answering points that will be receiving funds from the LaSalle County JETSB under the IGA are: (1) the "LaSalle County Sheriff's PSAP," which is owned, staffed and operated by the LaSalle County Sheriff's Department and is located at 707 East Etna Road, Ottawa, Illinois; (2) the "Ottawa Central Dispatch PSAP," which is owned, staffed and operated by the City of Ottawa and is located at 301 West Lafayette Street, Ottawa, Illinois; and (3) the "Peru PSAP" (whose operations will be transferred to the Illinois Valley Regional Dispatch upon the formation), which is currently owned, staffed and operated by the City of Peru and is located at 1503 Fourth Street, Peru, Illinois (collectively referred to as the "PSAPS"); and

**WHEREAS**, even though the LaSalle County JETSB will receive and allocate ETSB funds, the LaSalle County JETSB will not fully fund the operations, maintenance and staffing of each of the PSAPS, and will not obtain an ownership interest in: (a) the real property or personal property associated with any of the PSAPS, (b) any personal property (e.g., equipment, fixtures or technology) currently owned by or acquired by any of the PSAPS, and (c) any improvements to the existing or any new facilities of the PSAPS. The LaSalle County JETSB will not govern or direct the operations or employ the personnel of the PSAPS. The IGA does not establish a centralized, combined emergency dispatch and communication system, as the PSAPS will each remain independently owned, staffed and operated, and each PSAP owner will be solely responsible for delivery of emergency dispatch services, 9-1-1 communication services and wireless E-9-1-1 communication services to those Participating Members within its respective service territory. Each PSAP owner shall be solely responsible to fully fund the operations, maintenance and staffing of its PSAP, as the ETSB funds received from the LaSalle County JETSB will not be adequate to provide a full level of funding for such activities; and

**WHEREAS**, the authority to enter into the IGA to create and operate the La Salle County JETSB and to assist in the funding of the operations, maintenance and staffing of the PSAPS is set forth in Article VII, Section 10 of the 1970 Constitution of the State of Illinois, the Illinois Intergovernmental Cooperation Act (5 ILCS 220/1 *et seq.*), the Emergency Telephone System Act (50 ILCS 750/1 *et seq.*), the Wireless Emergency Telephone Safety Act (50 ILCS 75111 *et seq.*), the Prepaid Wireless 9-1-1 Surcharge Act (50 ILCS 753/1 *et seq.*), Section 11-5.3-1 of the Illinois Municipal Code (65 ILCS 5/11-5.3-1), the Department of State Police Law (20 ILCS 2605-52 (Office of Statewide 9-1-1 Administrator)) and the applicable provisions of the Illinois Administrative Code (83 Ill. Admin. Code § 725.200(i)) (collectively referred to as the "Intergovernmental and 911-JETSB Statutes"); and

**WHEREAS**, in accordance with 50 ILCS 750/15.4(e) and in order to participate in the LaSalle County JETSB under the IGA, the Participating Members have agreed to adopt ordinances that terminate the establishment, authority and operational functions of their respective local ETSBs, subject to two conditions: (1) each Participating Member, in its own discretion, is allowed to use any of its remaining ETSB funds to pay for budgeted items or obligations that exist in its Fiscal Year 2016 and Fiscal Year 2017 ETSB budgets or may contribute its ETSB funds to the LaSalle County JETSB and receive a credit equal to the amount of its contributed ETSB funds towards any financial obligations that the Participating Member owes in regard to membership in the LaSalle County JETSB, with the balance of the ETSB funds being paid by the LaSalle County JETSB to the Participating Member's respective PSAP; and (2) the termination of the local ETSBs will be effective only upon the creation of the LaSalle County JETSB and the regulatory approval of the LaSalle County JETSB by the 9-1-1 Administrator of the Illinois Department of State Police (the "State 9-1-1 Administrator"); and

**WHEREAS**, in order to participate in the LaSalle County JETSB under the IGA, each of the Participating Members are required to adopt a code amendment ordinance that enacts the same or substantially the same code amendments as found in this Ordinance; and

**WHEREAS**, the Corporate Authorities of the County of LaSalle desire to amend the provisions of **Ordinance No. 04-101 of August 12<sup>th</sup>, 2004 (Emergency Telephone System Board)** of the LaSalle County Code to recognize the County's participation in the IGA and the establishment of LaSalle County's JETSB, and to terminate the establishment, authority and operational functions of its local ETSB ("LaSalle ETSB"), subject to two conditions: (1) the use by the County, in its own discretion, of any of its remaining ETSB funds to pay for budgeted items or obligations that exist in its Fiscal Year 2016 and Fiscal Year 2017 ETSB budgets or may contribute its ETSB funds to the LaSalle County JETSB and receive a credit equal to the amount of its contributed ETSB funds towards any financial obligations that the County owes in regard to membership in the LaSalle County JETSB, with the balance of the ETSB funds being paid by the LaSalle County JETSB to the County's PSAP; and (2) the termination of its local ETSB will be effective only upon the creation of the LaSalle County JETSB and the regulatory approval of the LaSalle County JETSB by the State 9-1-1 Administrator; and

**WHEREAS**, pursuant to the authority granted by the applicable provisions of the Intergovernmental and 911-JETSB Statutes, the Corporate Authorities of the County of LaSalle find that the below LaSalle County Code amendments are in the best interests of and for the protection of the health, welfare and safety of the County, its residents and the public, and they approve the Code amendments as set forth below.

**BE IT ORDAINED BY THE CORPORATE AUTHORITIES OF THE COUNTY OF LASALLE, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1:** Each Whereas paragraph above is incorporated by reference into this Section 1 and made a part hereof as material and operative provisions of this Ordinance.

**SECTION 2:** Subject to the conditions set forth below in this Ordinance, **Ordinance No. 04-101 of August 12<sup>th</sup>, 2004 (Emergency Telephone System Board)** of the LaSalle County Code, as amended, shall be further amended to read in its entirety as follows:

- 1: ESTABLISHMENT; MEMBERSHIP; AUTHORITY AND DUTIES:**  
**2: DISSOLUTION OF LOCAL ETSB; RE-INSTATEMENT:**  
**3: USE OF ETSB FUNDS; SURCHARGE FUNDS:**

**1: ESTABLISHMENT; MEMBERSHIP; AUTHORITY AND DUTIES:**

- A. Establishment. Pursuant to **Ordinance No. 16-71** (adopted on June 13, 2016), the County approved an intergovernmental agreement entitled "Intergovernmental Agreement Establishing The LaSalle County Joint Emergency Telephone System Board And Providing For The Consolidation Of and Operation Of Certain Public Safety Answering Points (Initial Participating Members: City Of LaSalle, City Of Marseilles, City Of Mendota, City Of Oglesby, City Of Ottawa, City Of Peru And County Of LaSalle, Illinois on behalf of the LaSalle County Emergency Telephone System Board" (the "LaSalle County JETSB Intergovernmental Agreement") that provided for the establishment of an intergovernmental cooperative venture known as the "LaSalle County Joint Emergency Telephone System Board" (also referred to as the "LaSalle County JETSB"). The purpose of the intergovernmental arrangement is for the LaSalle County JETSB to initially oversee the consolidation of six (6) existing public safety answering points ("PSAPS") into three (3) PSAPS, to administer the receipt and allocation of surcharge funds and any other revenues budgeted for ETSB purposes (collectively "ETSB funds") based on a cost-sharing formula or as otherwise directed in the IGA to assist in funding the operations, maintenance and staffing of the three (3) PSAPS and the LaSalle County JETSB, and to provide general coordination of the delivery of emergency dispatch services and 9-1-1 communication services and wireless E-9-1-1 communication services within the service territories of the Participating Members of the LaSalle County JETSB. The three (3) PSAPS that will be funded by the LaSalle County JETSB Intergovernmental Agreement are: (1) the LaSalle County Sheriff's PSAP, which is owned, staffed and operated by the LaSalle County Sheriff's Department and is located at 707 East Etna Road, Ottawa, Illinois; (2) the Ottawa Central Dispatch PSAP, which is owned, staffed and operated by the City of Ottawa and is located at 301 West Lafayette Street, Ottawa, Illinois; and (3) the Peru PSAP (whose operations will be transferred to the Illinois Valley Regional Dispatch upon the formation), which is currently owned, staffed and operated by the City of Peru and is located at 1503 Fourth Street, Peru, Illinois (collectively referred to as the "PSAPS").
- B. Membership; Authority and Duties. The total number of members on the LaSalle County JETSB shall match the total number of participating members that are parties to the LaSalle County JETSB Intergovernmental Agreement, as amended to add new members. The initial membership on the LaSalle County JETSB shall total seven (7) members, including the statutory "public member." The members of the LaSalle County JETSB shall be comprised of one (1) representative from each of the participating members of the LaSalle County JETSB Intergovernmental Agreement, as designated in writing by the mayor or presiding administrative officer of each participating member. The statutory "public member" will be one of the designated representatives of one of the participating members of the LaSalle County JETSB Intergovernmental Agreement or appointed pursuant to the terms of the Agreement. The authority and duties of the LaSalle County JETSB shall be governed by the terms of the LaSalle County JETSB Intergovernmental Agreement and the Emergency Telephone System Act (50 ILCS 750/1 *et seq.*) and any other applicable laws.



## 2: DISSOLUTION OF LOCAL EMERGENCY TELEPHONE SYSTEM BOARD; RE-INSTATEMENT:

- A. Dissolution of Local Emergency Telephone System Board (ETSB). Pursuant to **Ordinance No. 16-72** (adopted June 13, 2016), the County's ETSB was dissolved effective upon the date of the regulatory approval of creation of the LaSalle County JETSB by the 9-1-1 Administrator of the Illinois Department of State Police. The County's ETSB was initially established by the adoption of Ordinance No. **04-101** on **August 12<sup>th</sup>, 2004**
- B. Re-instatement of Local ETSB. In the event the County withdraws from participation in the LaSalle County JETSB Intergovernmental Agreement, to the extent permitted by applicable laws and regulations, the County will either take the necessary corporate actions to re-instate its local ETSB or join another Joint Emergency Telephone System Board (JETSB).

## 3: USE OF ETSB FUNDS; SURCHARGE FUNDS:

- A. Use of ETSB Funds. Under the LaSalle County JETSB Intergovernmental Agreement, the County, in its own discretion, may use or expend any of its ETSB funds, including any surcharge funds, to pay for budgeted items or obligations that exist in its Fiscal Year 2016 and Fiscal Year 2017 ETSB budgets in accordance with the applicable laws, including the Emergency Telephone System Act (50 ILCS 750/1 *et seq.*), the Wireless Emergency Telephone Safety Act (50 ILCS 751/1 *et seq.*) and the Prepaid Wireless 9-1-1 Surcharge Act (50 ILCS 753/1 *et seq.*), or may contribute its ETSB funds to the LaSalle County JETSB and receive a credit equal to the amount of its contributed ETSB funds towards any financial obligations that the County owes in regard to membership in the LaSalle County JETSB, with the balance of the ETSB funds being paid by the LaSalle County JETSB to the County's PSAP.
- B. Surcharge Funds. Upon dissolution of the County's ETSB and subject to the terms of the LaSalle County JETSB Intergovernmental Agreement and the County's continued participation in the LaSalle County JETSB, all monies received or collected by the County that are intended to be used for ETSB purposes or LaSalle County JETSB purposes from any surcharge or revenue source authorized by any federal or State law, including Section 15.3 of the Emergency Telephone System Act (50 ILCS 750/15.3), the Wireless Emergency Telephone Safety Act (50 ILCS 751/1 *et seq.*) and the Prepaid Wireless 9-1-1 Surcharge Act (50 ILCS 753/1 *et seq.*), shall be transferred to the LaSalle County JETSB for deposit and expenditure by the LaSalle County JETSB in accordance with the terms of the LaSalle County JETSB Intergovernmental Agreement, the Emergency Telephone System Act (50 ILCS 750/1 *et seq.*) and any other applicable laws.
- C. Surcharge Rate. The County is authorized to receive surcharge funds pursuant to Section 15.3 of the Emergency Telephone System Act (50 ILCS 750/15.3), the Wireless Emergency Telephone Safety Act (50 ILCS 751/1 *et seq.*) and the Prepaid Wireless 9-1-1 Surcharge Act (50 ILCS 753/1 *et seq.*) at rates and in amounts established by and regulated by these applicable State laws. Under **Ordinance No. 05-07** (adopted **January 13, 2005**), the County enacted a 9-1-1 surcharge rate of **One Dollar and Sixty Cents (\$1.60)**, which was based on a **November 2, 2004** referendum in which a majority of the voters voted in favor of the 9-1-1 surcharge rate ("**Established 9-1-1 Surcharge Rate**"). The County is authorized to continue to receive surcharge funds at the **Established Surcharge Rate** or any other rate established by and regulated by

applicable State laws. The dissolution of the County's local ETSB shall have no impact on the County's authority and right to continue to receive its allocation of surcharge funds under these applicable State laws in accordance with the terms of the LaSalle County JETSB Intergovernmental Agreement."

**SECTION 3:** This Ordinance shall become effective and enforceable only upon the following conditions being met:

- A. Adoption by each of the initial Participating Members of an ordinance approving the LaSalle County JETSB Intergovernmental Agreement.
- B. Adoption by the other initial Participating Members of code amendment ordinances that enact the same or substantially the same code amendments as found in this Ordinance.
- C. Regulatory approval of the LaSalle County JETSB by the State 9-1-1 Administrator, or his/her designee.

**SECTION 4:** To the extent necessary, all tables of contents, indexes, headings, and internal references or cross-references to sections contained in the LaSalle County Code, as amended, shall be amended by the County's codifier so as to be consistent with the amendments set forth in this Ordinance.

**SECTION 5:** Any ordinance, or portion thereof, in conflict herewith is repealed to the extent of such conflict. Except as to the above amendments, all Chapters and Sections of the LaSalle County Code, as amended, shall remain in full force and effect.

**SECTION 6:** Each section, paragraph, clause and provision of this Ordinance is separable, and if any provision is held unconstitutional or invalid for any reason, such decision shall not affect the remainder of this Ordinance, nor any part thereof, other than that part affected by such decision.

**SECTION 7:** This Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by State law.

**SECTION 8:** The Corporate Authorities of the County of LaSalle, LaSalle County, Illinois authorize and direct the County Board Chairman and County Clerk, or their designees, to execute and submit to all required governmental oversight and regulatory agencies, including but not limited to the Illinois Department of State Police, a certified copy of this Ordinance and such other documents as are necessary to fulfill all of the applicable obligations under the applicable laws and regulations to dissolve the LaSalle County ETSB. In addition, the County Clerk shall transmit certified copies of this Ordinance to each of the other Participating Members of the LaSalle County JETSB within ten (10) calendar days of approval of this Ordinance.





**Emergency Telephone System Act (ETSA) (50 ILCS 750/)**  
**PSAP CONSOLIDATION FAQ'S**

This information provided below is intended for general information purposes only to assist those subject to the Emergency Telephone System Act (hereinafter "the Act") understand how the Department of the Illinois State Police will implement its provisions.

**When was the Emergency Telephone Act (ETSA) signed into law?**  
Governor Rauner signed the ETSA on June 29, 2015

**What are the significant components of the Act?**

- It transitioned the 911 Program from the Illinois Commerce Commission to the Illinois State Police and created an Office of the Statewide 9-1-1 Administrator.
- It created a Statewide 9-1-1 Fund and equalized surcharge across the State to \$.87 for landline, wireless and VoIP.
- It requires Consolidation of Public Safety Answering Points (PSAP's).
- It focuses on bringing 9-1-1 to 13 counties that do not currently provide 9-1-1.
- It includes opportunities for Consolidation Grants.
- It includes a plan for implementing Next Generation 9-1-1 statewide.

**Is my County required to consolidate?**

- By July 1, 2017 Emergency Telephone System Board's (ETSB's), Joint ETSB's, qualified government entities and PSAP's shall be consolidated based on **population** and the **number of ETSB's**.
- Counties and 9-1-1 Authorities use their service population to determine whether they are required to consolidate. Service Population is defined as the total population of the community served as determined by the latest (2014) complete vintage population estimates available from the U.S. Census Bureau.
- ETSB's, Joint ETSB's, qualified government entities and PSAP's shall be consolidated as follows:


(1) In any county with a **population of at least 250,000** that has a **single Emergency Telephone System Board, or qualified governmental entity and more than 2 PSAPs**, shall reduce the number of PSAPs by at least 50% or to 2 PSAPs, whichever is greater. Nothing in this paragraph shall preclude consolidation resulting in one PSAP in the county.

(2) In any county with a **population of at least 250,000** that has **more than one Emergency Telephone System Board, Joint Emergency Telephone System Board, or qualified governmental entity**, any 9-1-1 Authority serving a population of less than 25,000 shall be consolidated such that no 9-1-1 Authority in the county serves a population of less than 25,000.
