# ORDER OF THE STATEWIDE 9-1-1 ADMINISTRATOR AMENDED

**WHEREAS** the Glenview JETSB submitted a modification plan with the Office of the Statewide 9-1-1 Administrator on June 16, 2025, seeking to opt in the Village of Libertyville;

**WHEREAS** the modification plan has been read and reviewed by the Statewide 9-1-1 Bureau and the Administrator; and

**WHEREAS** the modification plan seeks to opt in the Village of Libertyville into the Glenview 9-1-1 System from the Vernon Hills 9-1-1 System. Libertyville will be served by the Glenview South PSAP:

**WHEREAS** as it relates to "wireline" surcharge monies the Vernon Hills ETSB and the Glenview JETSB have entered into an IGA allowing wireline surcharge monies to be paid to Glenview and requiring Glenview to account for such monies in its audited annual financial reporting as required under Section 40 of the ETSA.

**WHEREAS** as it relates to "wireless" surcharge monies, Section 30(b)(1)(D) and 30(2)(E) of the ETSA directs the Illinois State Police to make monthly grants to the appropriate 9-1-1 Authority currently taking wireless 9-1-1 based upon zip code billing of wireless subscribers. Accordingly, the IGA specified the boundary change resulting from Libertyville disengaging with the Vernon Hills 9-1-1 System and consolidating with Glenview and specified that Glenview will then be responsible to account for such monies in its audited annual financial reporting as required under Section 40 of the ETSA.

**WHEREAS** Glenview JETSB and the Vernon Hills 9-1-1 System have entered into an IGA concerning the payment of 9-1-1 surcharge, the financial reporting and auditing of the funds, and other specifics concerning the addition of the Village of Libertyville into the Glenview 9-1-1 System.

On June 17, 2025, Catherine Tanner, 911 Analyst, Statewide 9-1-1 Bureau filed a Technical Review of the Application which included the Illinois Commerce Commission's review. The Technical Review met the requirements of 83 Illinois Administrative Code Part 1325.

**NOW THEREFORE,** the Administrator orders the following;

**IT IS HEREBY ORDERED** that Glenview JETSB's request for approval of its modification plan is as follows:

Opting in the Village of Libertyville from the Vernon Hills 9-1-1 System to the Glenview 9-1-1 System pursuant to Title 83: Public Utilities Chapter IV: Illinois State Police Part 1325 - Standards of Service Applicable to 9-1-1 Emergency Systems Section 205, is hereby approved subject to the requirements of this Order.

**IT IS FURTHER ORDERED** that the Glenview modification will be completed no later than June 30, 2025.

**IT IS FURTHER ORDERED** that the Glenview 9-1-1 System will add Libertyville to their current Wireless Plan with an effective date no later than June 2025.

**IT IS FURTHER ORDERED** that the Libertyville surcharge remittances currently being remitted to Vernon Hills shall begin to be distributed to the Glenview 9-1-1 System as defined in 50 ILCS 750/30 beginning with the July 2025 remit period for the October 2025 distribution.
