## **LAW ENFORCEMENT OFFICERS KILLED**

During 2010 and 2011, eleven Illinois law enforcement officers lost their lives in the performance of their duties while upholding the laws of the state of Illinois. A brief narrative of the circumstances surrounding their deaths is presented below.

### **February 22, 2010 - CHICAGO POLICE DEPARTMENT**

Sergeant Alan J. Haymaker was killed in an automobile crash while on duty. When responding to a burglary-in-progress call, Sergeant Haymaker's vehicle left the roadway striking a light pole and tree. He succumbed to his injuries a short time later. Sergeant Haymaker was a third-generation officer with the Chicago Police Department and had served for 21 years.

### **March 26, 2010 - ST. CLAIR COUNTY SHERIFF'S DEPARTMENT**

Deputy Sheriff Lamont C. Reid suffered a fatal heart attack shortly after assisting with the search for a suicidal subject. Deputy Reid had served with the St. Clair Sheriff's Department for over 20 years.

### **May 20, 2010 - CHICAGO POLICE DEPARTMENT**

Officer Thomas E. Wortham, IV was killed during an attempted robbery. Officer Wortham was off duty when he was approached by subjects who attempted to rob him of his motorcycle. Withdrawing his service weapon, Officer Wortham fired at the four subjects but was fatally shot. Officer Wortham had served with the Chicago Police Department for nearly three years, with eight months previous service with the Evergreen Park Police Department and two tours of duty in Iraq while serving with the Wisconsin National Guard.

### **July 7, 2010 - CHICAGO POLICE DEPARTMENT**

Officer Thor Odin Soderberg was shot and killed in a robbery attempt. While returning to his vehicle at the end of his shift, a subject approached Officer Soderberg from behind. During the ensuing struggle, Officer Soderberg was fatally shot. The suspect fled and was apprehended a short time later while attempting to commit an armed robbery. Officer Soderberg had served with the Chicago Police Department for 10 years and was a US Army veteran.

### **July 18, 2010 - CHICAGO POLICE DEPARTMENT**

Officer Michael R. Bailey was shot and killed while trying to take action during an attempted armed robbery in front of his home. Having returned home and still in uniform, Officer Bailey was approached by subjects who attempted to rob him of his vehicle. He identified himself and exchanged shots with the suspects, who fled the scene. Officer Bailey was a month from retiring from the Chicago Police Department with 20 years of service.

## **August 6, 2010 - WYOMING POLICE DEPARTMENT**

Chief William T. (Bill) Bauer was killed in an automobile crash on duty when a vehicle pulled into his path. Chief Bauer had served with the Wyoming Police Department for seven years, and was also the Acting Chief of the Bradford Police Department at the time of his death. Chief Bauer had five years of service with the Henry, Princeton, and Sheffield Police Departments.

## **August 10, 2010 - COWDEN POLICE DEPARTMENT**

Officer Jeremy J. Hubbard was killed during the pursuit of a vehicle whose driver was suspected of diesel gas theft. After observing the vehicle, he pursued the vehicle for approximately 15 miles before he lost control, overturning his patrol car. Officer Hubbard died as a result of the injuries suffered in the accident. Officer Hubbard served as an officer with the Cowden Police Department for four years, with eight months of service with the Effingham County Sheriff's Department.

## **November 23, 2010 - JOHN H. STROGER HOSPITAL POLICE DEPARTMENT**

Officer Dwayne Parks suffered a fatal heart attack following an attack by several youths. Officer Parks was harassed and attacked by the youths on a bus enroute to his residence following his shift. After exiting the bus, he was chased and attacked again, suffering a heart attack and collapsing as the youths fled. Officer Parks served as an officer with the John H. Stroger Jr. Hospital Police Department for 16 years, with six years service as a security police officer with the US Air Force.

## **November 26, 2010 - CHICAGO POLICE DEPARTMENT**

Officer Michael R. Flisk was shot and killed while processing the scene of a vehicle burglary. Officer Flisk was collecting evidence when the suspect returned. The suspect shot and killed both Officer Flisk and the burglary victim. Officer Flisk had served with the Chicago Police Department for nearly 20 years. Three of Officer Flisk's siblings serve as officers with the Chicago Police Department.

## **May 20, 2011 - CHICAGO POLICE DEPARTMENT**

Officer Paul Winston Nauden suffered a fatal heart attack while conducting an undercover narcotics buy as part of a large narcotics investigation. He left the scene in order not to jeopardize the operation. Officer Nauden flagged down an ambulance and was transported to the hospital where he died early the next morning. Officer Nauden had served with the Chicago Police Department for 21 years.

## **December 29, 2011 - CHICAGO POLICE DEPARTMENT**

Officer Clifton P. Lewis was shot and killed attempting to take action during a robbery. He was working an overtime security detail at a grocery store. Two subjects entered the store, shooting Officer Lewis multiple times before fleeing. Officer Lewis was transported to the hospital where he succumbed to his wounds. Officer Lewis had served with the Chicago Police Department for eight years.
