

## ILLINOIS STATE POLICE DIRECTIVE ENF-010, ARREST FINGERPRINT CARD COMPLETION

### I. POLICY

The Illinois State Police (ISP) will, when necessary to comply with the Illinois Compiled Statutes, submit an Arrest Fingerprint Card listing charges, a physical description, and fingerprints to the Bureau of Identification (BOI), Division of Justice Services.

### II. AUTHORITY

II.A. 20 ILCS 2630/5.2 - "arrest reports; expungement and sealing"

II.B. 705 ILCS 405/5-301 - "station adjustments"

II.C. 705 ILCS 405/5-105(3) - "definitions, delinquent minor"

### III. DEFINITIONS

III.A. Formal Station Adjustment - a procedure when a Juvenile Officer determines that there is probable cause to believe a minor has committed an offense and an admission by the minor of involvement in the offense.

III.B. Informal Station Adjustment - a procedure when a Juvenile Officer determines that there is probable cause to believe that the minor has committed an offense.

### IV. PROCEDURES

A centralized booking site utilizing Livescan technology may be used to submit Arrest Fingerprint Cards or the BOI will provide the Arrest Fingerprint Card(s) to use when submitting manually, and the following guidelines will be adhered to:

IV.A. For individuals 18 years of age or older, or a minor 10 years of age or older but under the age of 18 being charged as an adult, submission of an electronic Adult Arrest Fingerprint Card or completion of a BOI Arrest Fingerprint Card, ISP 6-402 (available from the BOI Supply Room), including fingerprints, is required when the person is arrested for:

IV.A.1. A felony

IV.A.2. A class A or B misdemeanor except arrests for the following misdemeanors that do not require fingerprinting:

IV.A.2.a. Conservation offenses, as defined in Illinois Supreme Court Rule (S.Ct.Rule) 501(c) (see Addendum 1), when charged as a class B misdemeanor, or

IV.A.2.b. Moving and non-moving traffic violations under the Illinois Vehicle Code, other than the following (that do require fingerprinting):

IV.A.2.b.1) 625 ILCS 5/4-101 et seq., "Anti-theft Laws and Abandoned Vehicles"

IV.A.2.b.2) 625 ILCS 5/11-204.1, "Aggravated fleeing or attempting to elude a peace officer"

IV.A.2.b.3) 625 ILCS 5/11-501, "Driving while under the influence of alcohol, other drug or drugs, intoxicating compound or compounds, or any combination thereof"

IV.A.2.b.4) 625 ILCS 40/5-7, "Operating a snowmobile while under the influence of alcohol or drug other drugs, intoxicating compound or compounds, or a combination of them"

- IV.A.2.b.5) 625 45/5-16, "Operating a watercraft under the influence of alcohol, other drug or drugs, intoxicating compound or compounds, or combination thereof"
- IV.B. For minors 10 years of age or older, but prior to their 18<sup>th</sup> birthday who have violated or attempted to violate any federal, State or county law, or municipal ordinance classified as a misdemeanor, or for minors 10 years of age or older, but prior to their 18<sup>th</sup> birthday who have violated or attempted to violate any federal, State or county law, or municipal ordinance classified as a felony if committed by an adult, submission of an electronic Juvenile Arrest Fingerprint Card or completion of a BOI Juvenile Arrest Fingerprint Card, ISP 6-657 (available from the BOI Supply Room), including fingerprints, is required when the person is arrested for:
  - IV.B.1. A class A or B misdemeanor except arrests for the following misdemeanors that do not require fingerprinting:
    - IV.B.1.a. Conservation offenses, as defined in S.Ct.Rule 501(c) (see Addendum 1), when charged as a class B misdemeanor, or
    - IV.B.1.b. Moving and non-moving traffic violations under the Illinois Vehicle Code, other than the following (that do require fingerprinting):
      - IV.B.1.b.1) 625 ILCS 5/4-101 et seq., "Anti-theft Laws and Abandoned Vehicles"
      - IV.B.1.b.2) 625 ILCS 5/11-204.1, "Aggravated fleeing or attempting to elude a peace officer"
      - IV.B.1.b.3) 625 ILCS 5/11-501, "Driving while under the influence of alcohol, other drug or drugs, intoxicating compound or compounds, or any combination thereof"
      - IV.B.1.b.4) 625 ILCS 40/5-7, "Operating a snowmobile while under the influence of alcohol or other drug or other drugs, intoxicating compound or compounds, or a combination of them"
      - IV.B.1.b.5) 625 ILCS 45/5-16, "Operating a watercraft under the influence of alcohol, other drug or drugs, intoxicating compound or compounds, or combination thereof"
- IV.C. A Certified Juvenile Officer may complete a Juvenile Arrest Fingerprint Card when he/she apprehends a juvenile for a minor offense for which, in the officer's opinion, an Informal or Formal Station Adjustment would be the appropriate level of enforcement action.
  - IV.C.1. The Juvenile Officer will complete the Juvenile Arrest Fingerprint Card with the Station Adjustment stated on the card.
  - IV.C.2. Since the type of Station Adjustment may be unknown at the time of the arrest, the Station Adjustment can be reported to the BOI at a later date by completing the reverse side of Copy 2 of the manual Juvenile Arrest Card packet.

**NOTE:** Section IV.A. mandates that fingerprints for adult offenders be submitted to the BOI for both felony and class A and B misdemeanors. Section IV.B. mandates that fingerprints for juvenile offenders be submitted to the BOI for offenses classified as felonies if committed by an adult. However, the BOI will accept any other classification of offenses for adult and/or juvenile offenders that may be reportable, but not mandated, by statute to include local ordinances and juvenile misdemeanor offenses. Juvenile Station Adjustment notifications can also be reported for any offense.

## IV.D. General Provisions

IV.D.1. Each criminal offender posted to the Illinois Criminal History Record Information (CHRI) database is assigned a state identification number (SID).

IV.D.1.a. The number is established when the subject's first arrest fingerprint card is submitted and posted to the CHRI system.

IV.D.1.b. Each subsequent arrest fingerprint card submitted and matched against the subject's initial fingerprint card is posted to the subject's SID number.

IV.D.1.c. Each subject has a unique SID number and each number remains the same for the subject as long as the arrest data remains on the system.

**NOTE:** Arrests for the offenses listed in paragraphs IV.A., IV.B., and IV.C. require the information part of the fingerprint card to be completed and fingerprints to be taken.

IV.D.2. The arresting officer is responsible for the completion of the arrest and/or fingerprint card information at the time of processing (booking) in addition to any other required forms or reports.

IV.D.2.a. The BOI Arrest Fingerprint Cards must contain the numerical identifier for the county of arrest in the block labeled COUNTY OF PROSECUTION (see Addendum 2).

IV.D.2.b. When completing or submitting a BOI Arrest Fingerprint Card, all personnel will use the Originating Agency Identifier (ORI) of their office of assignment to identify the arresting agency. Ensure the ORI when submitting via live scan belongs to the appropriate ISP arresting troop. The space on the BOI Arrest Fingerprint Card labeled DEPARTMENT NAME is to contain the name and address of the arresting agency.

IV.D.2.c. The primary National Crime Information Center (NCIC) ORI assigned to the office of assignment must be used when submitting the Arrest Fingerprint Card.

## IV.E. Paper Fingerprint Card Use

IV.E.1. Accuracy, neatness, and completeness are essential when completing the cards.

IV.E.1.a. All fingerprint cards will be completed by typing or printing legibly in black ink.

IV.E.1.b. Unit supervisors are responsible for providing quality control and processing of all completed cards.

IV.E.1.c. The arresting officer must attach a completed Arrest Fingerprint Card to the Citation Arrest Record copy.

IV.E.1.d. The card(s) and the Citation Arrest Record copy will then be forwarded to the appropriate Troop staff.

IV.E.1.e. Cards received by the BOI and the Federal Bureau of Investigation (FBI) that are incomplete, incorrect, or illegible will be returned to the contributor for correction or completion.

IV.E.2. The appropriate Troop staff will make the proper distribution of the card(s). Troop staff will:

IV.E.2.a. Forward Arrest Fingerprint Cards to the BOI daily.

IV.E.2.b. Process the Citation Arrest Record copy and any other related documents as usual.

IV.E.2.c. Forward Copy 2 (State's Attorney Copy) and Copy 3 (Circuit Clerk's Copy) of the ISP/BOI Arrest Card Packet to the appropriate County State's Attorney's Office for processing the court documents.

IV.E.2.c.1) The appropriate State's Attorney will then forward Copy 3 to the Circuit Clerk's Office.

IV.E.2.c.2) This does not include Copy 2 and Copy 3 of the juvenile packets for those juveniles handled within the facility and where either a Formal or Informal Station Adjustment was issued.

IV.E.3. When multiple arrest citations are issued to one offender, the card(s) will be attached to the Citation Arrest Record copy issued for the most serious violation. This would also be the charge listed as number one on the card(s).

IV.F. Livescan Device Use

IV.F.1. Personnel who use such facilities for booking purposes are to ensure that the data fields are completed properly before the arrest card is transmitted. Officers may have to alter the machine's standard input settings to ensure the correct ISP ORI number is captured during the live scan transmission.

IV.F.2. Officers will obtain a copy of the arrest card produced by the live scan device and attach it to the citation arrest record.

IV.F.3. The Juvenile and Adult Livescan Arrest Forms require the following fields be completed (**all** fields should be completed, but these fields **must** be completed on the subject):

- IV.F.3.a. Name
- IV.F.3.b. Date of Birth
- IV.F.3.c. Place of Birth
- IV.F.3.d. Sex
- IV.F.3.e. Race
- IV.F.3.f. Height
- IV.F.3.g. Weight
- IV.F.3.h. Eye Color
- IV.F.3.i. Hair Color
- IV.F.3.j. Date Printed
- IV.F.3.k. Date of Arrest
- IV.F.3.l. Submission Type
- IV.F.3.m. Transaction Action Code
- IV.F.3.n. Document Control Number
- IV.F.3.o. Agency NCIC Number
- IV.F.3.p. Arrestee Armed With Segment
- IV.F.3.q. Weapon Type
- IV.F.3.r. Automatic Weapon
- IV.F.3.s. Arrest Charge Segment
- IV.F.3.t. Charge Number
- IV.F.3.u. Charge Statute Citation **or** Administrative Office of the Illinois Courts (AOIC) Offense Code (do not enter **both** codes)
- IV.F.3.v. Inchoate Offense
- IV.F.3.w. Charge Penalty Class
- IV.F.3.x. Domestic Violence Indicator

IV.G. Summary criminal history record information may be obtained through troop computer terminals. The entire criminal history will automatically be sent to the Troop upon completion of the processing of the Arrest Fingerprint Card by the BOI.
