

# ILLINOIS STATE POLICE DIRECTIVE

## SRV-104, CRIMINAL INTERDICTION TRAINING AND ENFORCEMENT

### I. POLICY

The Illinois State Police will:

- I.A. Promote the development of officers in the area of criminal interdiction to establish a firm foundation of trained and experienced officers in combatting in-transit crimes while simultaneously supporting fatality reduction efforts.
- I.B. Maintain a Statewide Criminal Interdiction program under the Division of Patrol (DOP) responsible for criminal interdiction training and focused criminal enforcement initiatives. The Deputy Director of the DOP will appoint a Statewide Criminal Interdiction Coordinator to help oversee and implement the program.
- I.C. Identify Regional Criminal Interdiction Coordinators to assist with the implementation of the statewide criminal interdiction program within their respective regions.
- I.D. Support criminal interdiction and enforcement details with the following objectives:
  - I.D.1. Disrupt in-transit contraband on Illinois highway systems through criminal enforcement saturation patrols
  - I.D.2. Develop and implement CRIMPAT/Valkyrie training initiatives, including advanced seminars, informational briefs, and hands-on training opportunities
  - I.D.3. Assist troops with fatality reduction and criminal enforcement efforts
  - I.D.4. Provide criminal interdiction training to Cadets at the ISP Academy to ensure updated and professional criminal interdiction concepts are provided
  - I.D.5. Develop and deliver an eight-hour in-service interdiction training seminar and a 32-hour advanced criminal interdiction training program for ISP officers
  - I.D.6. Prohibit duplication or dissemination of ISP documents, photographs, slides, video tapes, or other materials related to the criminal interdiction training without explicit authorization of the Commander of the ISP Academy. Copies of commercially produced video tapes used in the training must be obtained directly from vendors.

### II. RESPONSIBILITIES

The Statewide Criminal Interdiction Coordinator will:

- II.A. Utilize Regional Criminal Interdiction Coordinators to assist the delivery of criminal interdiction training and coordination of enforcement.
- II.B. Review criminal interdiction training material to ensure updated legal and professional criminal interdiction concepts are delivered to ISP officers.
- II.C. Construct and disseminate guidelines for administering and delivering training, as needed, for Region Commanders, coordinators, instructors, and others with responsibilities in the program.
- II.D. Select officers knowledgeable and experienced in criminal interdiction techniques for instructor training and certification. Certified instructors will ultimately assume responsibility for delivering training.

- II.E. In consultation with Region Commanders, schedule and deliver criminal interdiction training to ISP officers.
- II.F. Annually by March 1, compile and submit a report of program-related enforcement activities and achievements for the previous calendar year. The report will be forwarded to the Deputy Director of DOP who will forward copies to the Deputy Director of the Division of Internal Investigation and the Director.
- II.G. In consultation with the Academy Commander, identify future training needs.
- II.H. Maintain liaison with command personnel.
- II.I. Promote the introduction/use of advanced criminal interdiction techniques.
- II.J. Provide guidance and support.
- II.K. Ensure training objectives are met.
- II.L. When sufficient funding is identified, organize quarterly details throughout the state with trained ISP interdiction officers working a 2-3 day saturation patrol with objectives of fatality reduction and criminal apprehension.
- II.M. Communicate with the Statewide Terrorism and Intelligence Center to record statistics and gain intelligence.
- II.N. When sufficient funding is identified, host quarterly briefings with personnel working interdiction to discuss and keep current on case laws, intelligence, officer safety issues, upcoming training, etc.
- II.O. Maintain a record of specialized tools issued to interdiction officers and help prepare grant requests to receive such tools.

Regional Criminal Interdiction Coordinators will:

- II.P. If deemed necessary by the Deputy Director of DOP, be identified on a regional basis to assist with the implementation and operations of the statewide criminal interdiction program.
- II.Q. As requested by the Statewide Criminal Interdiction Coordinator, assist with the delivery of criminal interdiction training and coordination of enforcement activities.

### III. PROCEDURES

#### III.A. Training Standards

Except as noted, all criminal interdiction training will be based on an eight-hour block of instruction and must, at a minimum, include each of the following topics:

- III.A.1. Prohibition of improperly biased-based law enforcement
- III.A.2. Common concealment locations/hidden compartments
- III.A.3. Gun trafficking
- III.A.4. Investigative liaison/intelligence
- III.A.5. Legal issues/search and seizure methodology
- III.A.6. Methodology used by drug couriers
- III.A.7. Methods used to detect smuggling activity
- III.A.8. Officer safety

- III.A.9. Roadside interview techniques
- III.A.10. Terrorism
- III.B. Standards for selection of criminal interdiction instructors  

Instructors will possess extensive knowledge and experience in the application of criminal interdiction techniques in a traffic enforcement setting.
- III.C. Certification of Instructors
  - III.C.1. The ISP has trained and certified instructors who will provide all training pursuant to this directive.
  - III.C.2. Such certification will only be granted upon successful completion of a 32-hour instructor development course of study approved by the Statewide Criminal Interdiction Coordinator, Academy Commander and Director. The Statewide Criminal Interdiction Coordinator will be responsible for the maintenance of instructor certifications and records.
- III.D. Scheduling of Training  

Responsibility for scheduling Criminal Interdiction Training is vested with the Statewide Criminal Interdiction Coordinator. Work units will be responsible for entering records of criminal interdiction training for their respective officers.
- III.E. 32-Hour Advanced Interdiction Training Seminar conducted by the El Paso Information Center and the Drug Enforcement Administration is designed for officers:
  - III.E.1. Who have received prior instruction in the tenets of the program.
  - III.E.2. Who have amassed some program-related experience.
  - III.E.3. Who maintain a continuing interest in the interdiction effort.
  - III.E.4. Whose duties encompass the role of traffic law enforcement and provide regular opportunities for the use of interdiction techniques.
