On July 14, 2024, there was a report of a vehicle stopped in the southbound lane on I-57 just north of Johnston City.

ISP Trooper Rebecca Wise and Deputy Knight of the Williamson County Sherriff’s Office arrived to assist. Deputy Knight and Trooper Wise confirmed the senior citizen had run out of fuel and pushed the vehicle out of the lane of traffic and onto the shoulder.

Deputy Knight took the citizen to a nearby gas station to obtain fuel while Trooper Wise remained with the vehicle. Once the car was re-fueled the citizen was back enroute to his original destination.

“Sometimes it’s the smallest acts that make the largest impact”, stated Sheriff Diederich. “Both of these law enforcement officers should be commended. These are the acts performed daily by law enforcement that often go unrecognized”.

In Memoriam: Ret. Trooper Richard W. Shreve #1138

July 9, 1941 ~ July 19, 2024

RICHARD WAYNE SHREVE, loving husband, proud father, grandfather and Marine veteran transitioned into eternity shortly after his 83rd birthday on July 19, 2024. He peacefully passed away at home surrounded by his family.

Dick, as he was known to all, was born on July 9, 1941, to parents Glenn and Harriet (Plopper) Shreve. He ran the streets of Mt. Olive, IL as a youngster hustling a buck everywhere he could from picking up cans to shining shoes. He attended and graduated Mt. Olive High School in 1959, where he later served on the school board. He served his country as a proud Marine from 1960 to 1964 with the last 2 years being spent overseas in Atsugi, Japan.

In his thirties he attended the University of Illinois where he made the Dean's List and earned a bachelor's degree in 1976. He was a member of the First Baptist Church of Litchfield where he gave his life to our Father on February 24, 1999. He was also a member of the Moose and a lifetime member of both the Amvets and the VFW.

Dick worked for the State of Illinois starting in 1966. He was actively involved in the FOP #041 where he was the treasurer at one point. In 1991 he took an early retirement. From there he continued to keep busy being involved in multiple businesses: Maggie's, Ric-Kel's, Sam's, Crossroads, & Bi-County Asphalt. In 2001 he finally started to relax and began snow birding in FL

where he and Cyndi finally moved permanently in 2007. He remained active by being an avid golfer and remodeling every home they lived in (and they moved a lot!) including his last which was just 6 years ago.

Dick is survived by his wife Cynthia (Fyfe), who he married on August 6, 1965; 3 children: Tracy Shreve, Kellie (Dennis) Parker, Rick (Keesha) Shreve; 9 grandchildren: Jessica, Andy, Alex (Jessica), Matt, Samantha, Tommie, Gia, Caleb, Ian; 2 great-grandchildren: Chloe, Beckett; 3 sisters: Hope (Ray) Rilling, Donna Mander-Fiser, Ruthie Traylor.

**Trooper
Clarence Swain**
End of Watch
August 1, 1959

Trooper Clarence Swain served with the Illinois State Police in District 9. Trooper Swain was killed in an automobile accident. A truck pulled out in front of his path and failed to gain speed. In-an-attempt to avoid striking the truck Trooper Swain swerved into the opposite lane but struck a vehicle head-on. Both he and the driver of the other vehicle were killed. Trooper Swain's partner was injured in the accident.

Prior to his service with the Illinois State Police, Trooper Swain was a veteran of both WWII and the Korean War. Trooper Swain was survived by his wife and four children. Trooper Swain's Illinois State Police career spanned from May 29, 1950 to August 1, 1959.



Sergeant Phillip Guinto

**End of Watch
August 5, 1943**

Sergeant Phillip Guinto was killed in a motorcycle accident on Route 20 near Volo, Illinois. He had lost control of his motorcycle and skidded 115 feet before crashing. A passing motorist located his body on the side of the road.

Sergeant Guinto had served with the Illinois State Police from September 1, 1930 to August 5, 1943 and was assigned to District 2. Trooper Guinto had been in law enforcement for 17 years and was survived by his wife.



Trooper Charles Deans

**End of Watch
August 8, 1944**

Trooper Charles Deans was killed in a motorcycle accident while transferring a motorcycle from Benton to Du-Quoin. The motorcycle experienced mechanical problems on Route 14 near Christopher and caused him to lose control and strike a ditch.

Trooper Deans had served with the Illinois State Police from January 1, 1940 to August 8, 1944 and was assigned to District 13. Trooper Deans was survived by his wife and two children.



Trooper Frank Tamulis

**End of Watch
August 9, 1937**

Trooper Frank Tamulis was killed in a motorcycle accident while on patrol on Southwest Highway near Oak Lawn. He struck the back of a truck during a period of heavy fog.

Trooper Tamulis had served with the Illinois State Police from March 6, 1936 to August 9, 1937 and was assigned to District 13. Trooper Tamulis was survived by his wife.

ISP Investigates Officer Involved Shooting in Pope County

GOLCONDA – Illinois State Police (ISP) Division of Criminal Investigation Zone 7 was requested by the United States Marshals Service (USMS) to investigate an officer involved shooting.

On August 6, 2024, at approximately 9:26 p.m., deputies with the USMS and an officer with the Illinois Department of Natural Resources were attempting to serve an arrest warrant issued from Indiana on 40-year-old Floyd D. Caudill of Oakland City, Indiana. Caudill was tracked to the Lake Glendale Campground in Golconda. The officers made verbal contact with Caudill, but Caudill refused to exit his tent. A shot was fired from within the tent and a deputy marshal returned fire. Caudill was subsequently located deceased in the tent.

ISP is leading the open and ongoing investigation. An autopsy is pending. No additional information will be released at this time.

ISP Continues Efforts to Reduce Gun Violence Through Focused Firearm Enforcement Details

SPRINGFIELD – To help ensure those who are prohibited by law from having a firearm, and who pose a threat, do not have guns in their possession, the Illinois State Police (ISP) conducted numerous firearm enforcement details in counties across the state from June 24 through July 19, 2024. The enforcement details focused on individuals who have become the subject of a Firearms Restraining Order or Clear and Present Danger, or received a criminal conviction, among other reasons.

“Firearms Restraining Orders and Clear and Present Danger reporting are two highly effective tools for getting firearms out of the hands of someone who poses a significant threat to themselves or others,” said Brendan F. Kelly. “As the use of these tools increases, so does the need for law enforcement to be able to safely conduct these arduous, intensive enforcement details.”

From July 2023 through June 2024, ISP received approximately 11,300 Clear and Present Danger reports, of which more than

10,800 were affirmed. While not all of those 10,800 individuals are out of compliance with state law, law enforcement is able to take action on those who are to bring them into compliance, thereby making communities safer.

During the recent ISP focused enforcement details, ISP officers completed 192 details and brought 673 people into compliance with state law. As a result of these efforts, 318 individuals transferred firearms out of their possession. ISP has been conducting firearm enforcement details since May 2019. From that time through July 2024, ISP has conducted 2,303 details and placed 5,549 individuals into compliance with the law.

In addition to its own efforts, ISP provides grants to local law enforcement agencies to help protect the public by transferring firearms out of the possession of a person legally prohibited from having a firearm and who is a danger to themselves or others.

In Fiscal Year 2024, ISP awarded almost \$1 million in firearm enforcement grants to 16 law enforcement agencies across the

state. During that time, local law enforcement agencies completed 7,048 compliance checks and brought 2,101 people into compliance with state law by transferring all firearms out of their possession and documenting that transfer with a [Firearm Disposition Record](#). ISP awarded another \$1.5 million in grants to 21 law enforcement agencies in Fiscal Year 2025.

Law enforcement agencies that are members of the Violent Crime Intelligence Task Force are eligible to receive grants from the [State Police Enforcement Fund](#). Funding helps agencies conduct firearms enforcement details and ensure firearms are turned over to a person who is legally allowed to possess firearms, or to law enforcement.

Funding for the enforcement grants comes from the State Police Enforcement Fund and were made possible through [Public Act 102-0237](#).

Along with enforcement details, between 2020 and the end of June 2024, ISP stopped more than 139,000 unlawful attempts to obtain a firearm through firearm eligibility checks.

ISP Leads Human Trafficking Enforcement Operation

COLUMBIA – The Illinois State Police (ISP) Division of Criminal Investigation Trafficking Enforcement Bureau arrested five individuals during a two-day human trafficking enforcement operation in the Columbia area of Monroe County on July 31- August 1, 2024. The operation focused on identifying individuals seeking to engage in commercial sex acts.

As a result of the operation, the following individuals were arrested and charged:

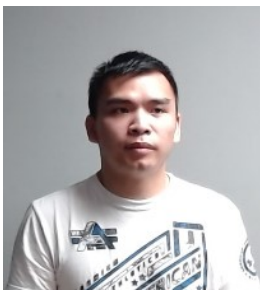

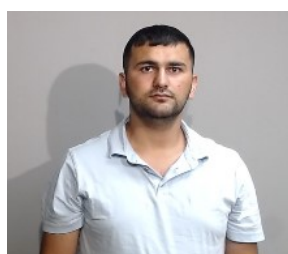

SPRINGFIELD – The Illinois State Police (ISP) has earned Commission on Accreditation for Law Enforcement Agencies (CALEA) Law Enforcement Accreditation for the 11th time.

“Integrity, Service, and Pride are at the core of ISP. They’re not just words, they’re an attitude, a lifestyle, the foundation upon which our officers build everyday as they serve their communities,” said ISP Director Brendan F. Kelly. “This accreditation affirms our continued commitment to excellence and we will use all available resources, including technology and training, to better our people and serve and protect the citizens of Illinois.”

CALEA is often referred to as the “Gold Standard for Public Safety Agencies.” In 1986, ISP became the first state law enforcement agency to be accredited. There are 40 CALEA accredited law enforcement agen-

cies in Illinois. To become [accredited](#), law enforcement agencies must complete a comprehensive two-to-three-year self-assessment, including the review and revision of policies, directives, and training standards. Agencies must also pass a CALEA site-based compliance check and attend a review committee hearing. Reaccreditation requires on-going quality performance reviews and maintenance of agency information and statistical data.

Transparency and accountability are two areas of focus for CALEA accreditation. In its ongoing efforts for transparency and accountability, ISP shares its departmental policies, its [Officer Involved Investigations Dashboard](#), and its [Expressway Shooting Dashboard](#), publicly on its website. ISP has also simplified its civilian complaint process, allowing citizens to report their grievances against ISP officers, as well as

elected officials, through Quick Links on the ISP website. ISP’s continued efforts in these areas have improved community trust and engagement but have also improved the work environment for the men and women of ISP. In excess of the CALEA requirements and long before they became a CALEA category, ISP expanded its mental health services for its employees. ISP created a full-time Peer Support team with dedicated staff to support both police and civilian employees around the State.

Accreditation has helped ISP become one of the top law enforcement agencies in the country. Starting compensation for all new ISP troopers is just over \$90,000. The July 1, 2024 increase in starting pay and benefits for first year troopers allows ISP to remain competitive and attract qualified candidates who are dedicated to pursuing justice and protecting the public.

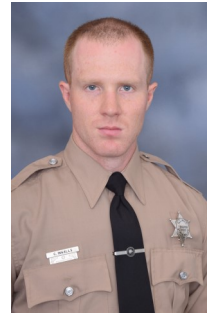
