

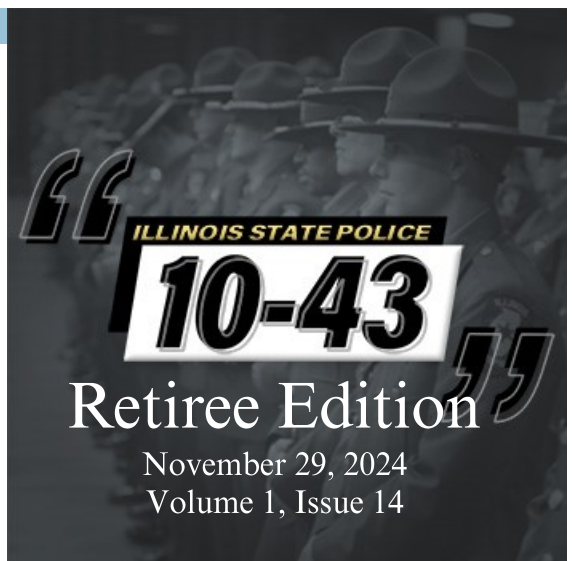
Agreement Gives College Credit for ISP Cadet Training

ISP Investigates Officer Involved Death in LaSalle County

SHERIDAN – The Illinois State Police (ISP) Division of Criminal Investigation Zone 1 is investigating an officer involved death at the request of the LaSalle County Sheriff’s Office (LCSO).

On November 21, 2024, LCSO deputies were serving an arrest warrant for an Internet Crimes Against Children investigation at a residence in the 4300 block of East 2175th Road in Sheridan, IL. LCSO deputies entered the residence and made contact with the suspect. As LCSO deputies attempted to place the suspect into custody,

the suspect grabbed a firearm located within the residence and administered a self-inflicted gunshot to the head. The deputies did not fire any shots. Deputies immediately attempted life saving measures on the suspect until emergency medical services arrived. The suspect died of their injuries.

An autopsy is scheduled to be performed today in McLean County. At the conclusion of its investigation, ISP will present the case to the LaSalle County State’s Attorney’s Office. There is no additional information.

Results of Metro East Violent Crime Suppression Detail

EAST ST. LOUIS – Illinois State Police (ISP) conducted a violent crime suppression detail on November 18-20, 2024, in St. Clair and Madison counties, focusing its efforts on East St. Louis and neighboring Metro East communities. The operation utilized intelligence and technology to target known high crime areas, violent offenders, and structured criminal groups in the communities of the Metro East. There were several notable events and arrests during the detail.

On November 18, 2024, troopers conducted a traffic stop on a vehicle for Illinois Vehicle Code (IVC) violations. The vehicle fled. Trooper located the vehicle a short while later and attempted to conduct another traffic stop on the vehicle, when the vehicle rammed an ISP squad car and began fleeing again. The vehicle subsequently crashed, and the driver attempted to flee on foot, but Troopers successfully apprehended the sus-

pect. It was determined the vehicle was stolen. A firearm was also recovered.

On November 19, 2024, troopers conducted a traffic stop on a vehicle for IVC violations. A probable cause search of the vehicle resulted in the seizure of a stolen firearm and over 150 grams of cannabis. Two subjects were taken into custody.

On November 19, 2024, troopers conducted a traffic stop on a vehicle for IVC violations. A probable cause search of the vehicle resulted in the seizure of a loaded firearm with an extended magazine, suspected oxycodone, and over 400 grams of cannabis. One subject was taken into custody.

Nearly 40 ISP officers from around the state, including Troop 3, Troop 6, Troop 7, Troop 8, Troop 9, Troop 10, South Fatal Four Team, Division of Criminal Investigation Zone 6, Firearms Investigations Unit, Crime Scene, Air Operations, and the Public Safety Enforcement Group joined forces with the Division of Patrol’s Special Operation Group South Statewide Anti-Violence Enforcement Unit for the multi-day operation. The Metropolitan Enforcement Group of Southwestern Illinois provided additional support during the operational period.

ISP will continue to use all available resources, including air operations, technology, forensic services, investigators, increase patrols, and information sharing to combat violent crime.

ISP Investigation Leads to Arrest of Watseka Man for Possession of Child Sexual Abuse Material

WATSEKA – An Illinois State Police (ISP) investigation led to the arrest of 22-year-old Manuel Perez of Watseka, Illinois for possession of child sexual abuse material.



After receiving a cyber tip from the National Center for Missing and Exploited Children (NCMEC), ISP conducted an investigation into possession of child sexual abuse material, which led to an arrest warrant for Perez.

On November 18, 2024, officers took Perez into custody and he is being held pending an arraignment hearing in Iroquois County, Illinois. Perez is charged with five counts of Possession of Child Pornography (Class 2 Felony).

This investigation is a collaborative effort between the Illinois Attorney General’s Office Internet Crimes Against Children Task Force, the Iroquois County Sheriff’s Office, the Watseka Police Department, the Iroquois County State’s Attorney’s Office, and ISP.

ISP Continues to Combat Public Corruption

EAST ST. LOUIS – The Illinois State Police (ISP) Division of Criminal Investigation Special Investigations Unit continues to combat public corruption with a recent case involving charges against a former city official. ISP worked with the Saint Clair County State’s Attorney to bring charges against 60-year-old Carlos Mayfield of East St. Louis, IL.

On April 3, 2024, ISP received an allegation of theft and official misconduct against former East St. Louis City Manager Carlos Mayfield.

ISP immediately began an investigation into Mayfield’s conduct and special agents found evidence Mayfield knowingly used City of East St. Louis funds for personal gain.

On October 1, 2024, an arrest warrant for Mayfield was issued for one count of Theft \$500-\$10,000 of Government Property (Class 2 Felony) and one count of Fraudulent Use of a Credit/Debit Card (Class 4 Felony). Mayfield surrendered himself to law enforcement on November 15, 2024.

Move Over Violations & More During Brian Frank Details

ISP conducted 3-day Fatal Four details in Will and DuPage counties in honor of Trooper Brian Frank, who was seriously injured due to a Scott’s Law violation. Troopers issued 68 speeding citations, 54 distracted driving violations, 11 seatbelt violations, and 5 Move Over violations. They also arrested three subjects and filed four criminal charges.

Concurrently, a Highway Interdiction Detail in the same area resulted in the seizure of over 84,000 grams of cannabis and almost \$41,000 in cash.

ISP Investigates Death of Missing Wisconsin Man Found in Rosemont

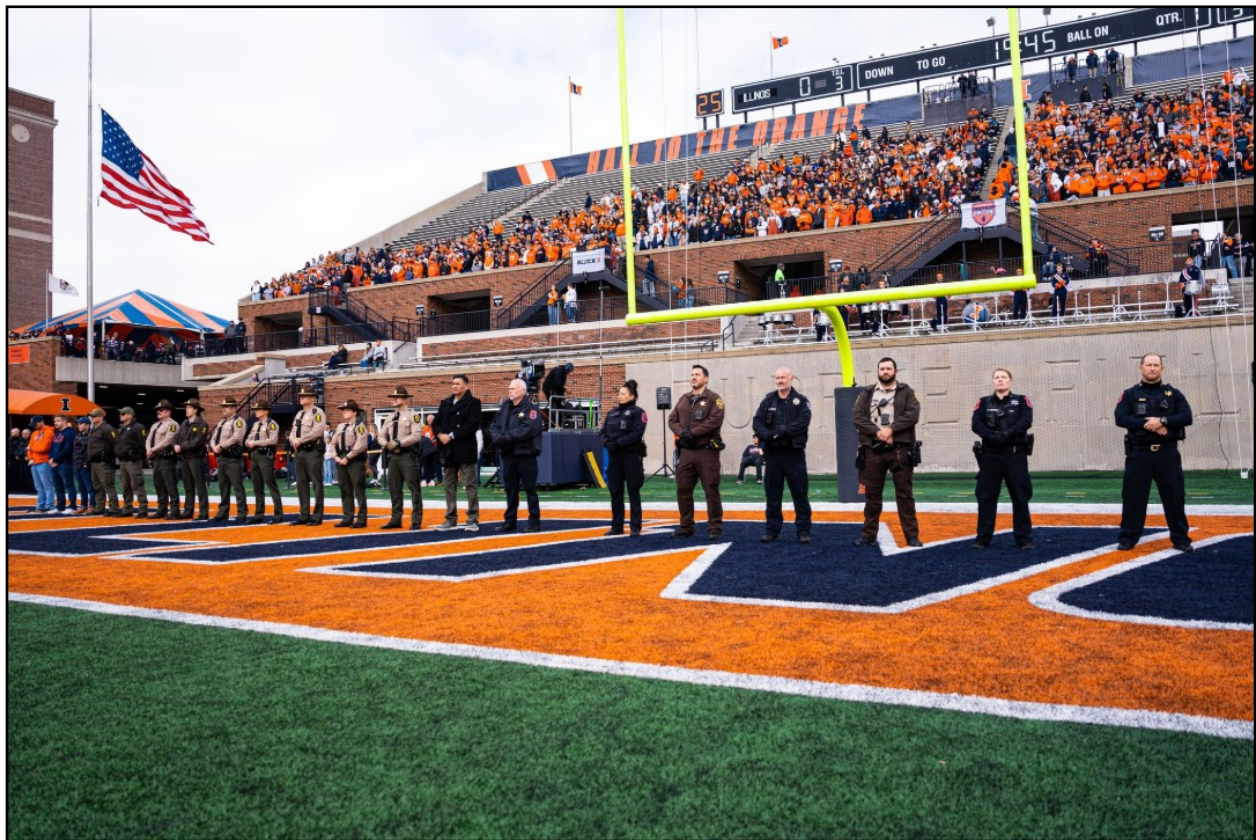
ROSEMONT – Illinois State Police Division of Criminal Investigation Zone 1 announces that the search for missing 45-year-old Benjamin Oberto of New Berlin, Wisconsin has ended after he was located deceased inside his vehicle in Rosemont, IL.

On November 14, 2024, Oberto was reported missing to the New Berlin Police Department in Wisconsin. On November 15, 2024, Rosemont Police Department (RPD) officers located a Subaru Impreza with Wisconsin registration partially submerged in a creek at the bottom of the embankment, on the curve of the Interstate 90 eastbound ramp to Interstate 294 northbound. RPD divers located a body inside the vehicle, later identified as Oberto.

ISP agents have taken over as the lead agency on this investigation.

After three years on the Danville Police Department, she earned a position as an Illinois State Trooper where she quickly rose to the rank of sergeant within five years. She has been commended by her superiors as taking her oath very seriously, donating hours of her own time if it was required to complete a task. She has a passion for investigating and building strong cases against sexual predators. Trooper Cecil Brokmyer

End of Watch: November 19, 1939

Trooper Cecil Brokmyer succumbed to gunshot wounds sustained two days earlier in Carrier Mills while attempting to arrest a man for an armed robbery.

Trooper Brokmyer and his partner located the man in a service station where he had taken a stolen vehicle to have it repaired. As they approached him the man pulled out a handgun from his coat and shot Trooper Brokmyer twice before fleeing. Trooper Brokmyer gave chase but did not return fire for fear of striking citizens.

Trooper Brokmyer succumbed to his wounds two days after the shooting.

Trooper Brokmyer had served with the Illinois State Police for seven years and was assigned to District 13. He was survived by his wife and two children.



Trooper George Wheeler

End of Watch: November 22, 1927

Trooper George Wheeler was killed in a motorcycle accident in Kankakee, Illinois.

Trooper Wheeler just picked up his new motorcycle with sidecar and left headquarters. He lost control and was thrown from the motorcycle, striking a tree. He suffered a fractured skull and succumbed to the injuries a short time later.

Trooper Wheeler was a six-week veteran of the Illinois State Police; He was assigned to District 12. Trooper Wheeler was survived by his father and two sisters.



Trooper Leo LaVelle

End of Watch: November 24, 1934

Trooper Leo LaVelle was in a motorcycle accident while patrolling Route 80 near Rapids City. He succumbed to his injuries two months later.

Trooper LaVelle was a U.S Army veteran of WWI and had served with the Illinois State Police in District 7 for one year. He had previously worked with the Los Angeles Police Department, California for nine years.



Trooper Kyle Deatherage

End of Watch: November 26, 2012

Trooper Kyle Deatherage was struck and killed by a tractor trailer while making a traffic stop on I-55, at mile marker 62, near Litchfield.

He had parked his motorcycle on the shoulder and was speaking with the driver of the vehicle when the collision occurred.

Trooper Deatherage had served with the Illinois State Police for three years. He was survived by his wife, daughter, son, father, mother, sister, and two brothers.



Special Agent Pete Lackey

End of Watch: November 27, 1972

Special Agent Pete Lackey was ambushed and killed on his way to work on November 27, 1972.

Special Agent Lackey had served with the Illinois Bureau of Investigation for two years. He was survived by his wife and two children.

In Memoriam: Colin John Brown

It is with profound sadness and a heavy heart that I share the tragic news of Colin Brown's passing. Colin is the beloved son of our colleague and friend, Retired LTC Calvin Brown.

While ISP protocol usually reserves LDALLs for the death of family members of those currently working for ISP, the circumstance of this death strikes close to home for many and is unfathomably heartbreaking.

On Saturday, November 23, 2024, at approximately 10:30 P.M., while traveling home from a hockey game on Interstate 55 in St. Louis, MO, Calvin and Colin encountered unimaginable tragedy as shots were fired in the area and they were caught in crossfire. Colin sustained a gunshot wound and, Wednesday, November 27, 2024, succumbed to his injuries.

Colin was an exceptional young man, a talented hockey player, and a source of joy to all who knew him. He touched many lives with his kindness and energy. Please keep Calvin, Tracey, Liam, and the entire Brown family in your thoughts and prayers as they navigate this devastating loss.

As an agency, we've experienced line-of-duty deaths and most of us have seen up close, in one way or another, the loss of human life in any number of situations. We understand it is part of the mission and the "business of risk" we all commit ourselves to on a daily basis. However, death like this is not just hard to understand, it's jarring, searing, gut wrenching.

But we will not falter or hesitate. All resources of the Illinois State Police permitted by law are being brought to bear on this case and we are working closely to support the St. Louis Metropolitan Police Department and other law enforcement partners across the river to apprehend those responsible, and to seek justice for the murder of Colin Brown. Let us come together to support the Brown family during this incredibly difficult time.

IN MEMORIAM: ISP K9 RIGGS

END OF WATCH: NOVEMBER 19, 2024



It is with profound sadness we share the passing of Illinois State Police Canine Riggs. Riggs, who faithfully served the people of Illinois alongside his handlers, sergeants Steve Ent and Jeremy Moyer passed away unexpectedly November 19, 2024, from a cardiac event at the age of 10.

Riggs graduated with Canine Class 75 in the spring of 2017 with his original handler Jeremy Moyer of District 11 (Troop 8). In 2018, Canine Riggs was assigned to Sgt. Ent and worked with the Statewide CRIMPAT Team. Together, they worked tirelessly to protect the people of Illinois and this country by disrupting the flow of illicit narcotics and currency throughout our borders, while helping to dismantle drug trafficking organizations. During his impressive 8-year career, Riggs helped seize 220 kilograms of cocaine, 105 kilograms of heroin, 131 kilograms of methamphetamine, 2,032 pounds of illegal cannabis, 97 firearms, and more than \$5 million in US currency. Canine Riggs was a loyal, beloved partner and team member whose presence will be missed dearly.

Our prayers are with Sgt. Ent, his family, and all those who had the privilege of working alongside Riggs during his distinguished career. We pause to honor Rigg's memory and give thanks for the incredible work he did to keep our communities safe.
