## Trooper Clay M. Carns #6512 Killed on I-55 on December 23, 2024



To the Men and Women of the Illinois State Police,

It is with profound sadness, dismay and a heavy heart that I inform you of the untimely death of Trooper Clay Carns #6512. Trooper Carns was on-duty in Troop 3 when he stopped for debris in the roadway near I-55 and Blodgett Road in Will County. Trooper Carns was outside of his vehicle when he was struck by a pick-up truck in traffic. Trooper Carns was taken to St. Joseph Hospital in Joliet, where at approximately 10:45 p.m., December 23, 2024, Trooper Carns succumbed to his injuries.

Please keep the Carns family in your prayers during this difficult time.




## ISP Arrests Moline Woman for Manufacturing Child Sexual Abuse Materials

**MOLINE** – Illinois State Police (ISP) Division of Criminal Investigation Zone 2 agents arrested 46-year-old Shanna L. Miller of Moline, IL for Manufacturing Child Pornography (Class X Felony) and Predatory Criminal Sexual Assault of a Child (Class X Felony).

On June 18, 2024, ISP agents executed a search warrant as part of an on-going investigation into the dissemination of child pornography. During the next several months, ISP agents were able to identify Miller as a suspect in that investigation.

On December 21, 2024, ISP agents arrested Miller near the 4000 block of

## ISP Announces Results of a Violent Crime Suppression Detail in the Metro East Area

**EAST ST. LOUIS** – Illinois State Police ered. The driver was taken into custo-(ISP) Statewide Anti-Violence Enforce- dy. ment South group conducted a violent crime suppression detail December 16-19, 2024, in St. Clair and Madison counties, focusing its efforts on East St. Louis and neighboring Metro East communities. The operation utilized intelligence and technology to target known high crime areas, viogroups in the communities of the Metro East.

There were several notable events and arrests during the detail.


To the public, Clay became a hero on December 23, 2024, when he was killed in the line of duty. To his family, he has always been a hero.

Decatur and Trooper Heinel assisted the NFL paramedics in locating the AED. Once it was in place, the individual was shocked, and Trooper Resendez stepped in to relieve M/Sgt. Hansen by performing chest compressions. The individual soon regained consciousness and began breathing on his own. When the NFL/Bears medical staff arrived, the man was taken to a local hospital in stable condition.

#### Trooper Glenn Gagnon

End of Watch: December 28, 1952

Trooper Glenn Gagnon was killed in an automobile accident while pursuing a car that had passed his patrol car at 80 mph on Route 54 near Kankakee.

As Trooper Gagnon and his partner attempted to overtake the vehicle they crossed into the inside lane.

As they rounded a curve an oncoming car forced the patrol car to swerve to the other lane and lose control. The car struck a tree and both troopers were thrown from the vehicle. Trooper Gagnon perished at the scene. His partner was injured but recovered.

Trooper Gagnon had served with the Illinois State Police for six years and was assigned to District 6. He was a U.S. Navy veteran of WWII. Trooper Gagnon was survived by his wife, parents, and sister.

## Lieutenant Clarence Robinson

Ed of Watch: December 28, 1963

Lieutenant Robinson was assigned to District 12A (District 19) from January 4, 1928 to July 5, 1933 and from January 1, 1941 to December 28, 1963.

Lt. Clarence Robinson, a native of Grayville, suffered a heart attack and died Saturday December 28 in the Richland Meat Olney. He had been ill since October 17 when he had his

#### Trooper Dale Van Vooren

End of Watch: December 29, 1962

Trooper Dale Van Vooren was killed in an automobile accident as a result of a mechanical failure in his squad car.

On what normally would have been his day off, Trooper Van Vooren was working a special holiday patrol on Saturday, December 29, 1962, with Trooper Darrel Vandenore. When the two first came on duty, they no-

ticed that the accelerator was sticking when they first began their shift. They took the vehicle to a service station and had a spring replaced.

The repair did not fix the problem and afterwards, the problem was found to be a malfunctioning carburetor linkage. Accelerating to pursue a speeder, the two troopers were driving on Highway 6, about a mile east of Annawan, when the carburetor stuck wide open. The squad car spun out of control, struck a culvert, skidded across the highway and overturned. Trooper Van Vooren was thrown through the windshield. He died of head injuries at St. Francis Hospital in Kewanee. His partner, although seriously injured, survived and returned to duty.

Trooper Van Vooren was a U.S Navy veteran and served with the Illinois State Police for five years. He was assigned to District 7, Rock Island. He was survived by his wife and three children.
