ISP Partners with SIU-E on Cold Cases

Women in Jane Doe cases associated with a serial killer identified and first degree murder charges filed in a 14-year-old case

BELLEVILLE – A partnership between the Illinois State Police (ISP) and Southern Illinois University Edwardsville (SIUE) is offering real world experience for the next generation of criminal justice students and aiding ISP Division of Criminal Investigation Zone 6 special agents working to solve old homicide cases.

"The Illinois State Police investigates hundreds of new cases each year, while also following up on cold cases from years past," said ISP Director Brendan F. Kelly. "Improvements in technology and advancements in forensic testing over the years can breathe new life into old cases. SIUE students have helped us review cold cases to prioritize them based on how close they are to solving. The partnership is not only helping with cold case review, it is providing students with experience and insight into homicide investigations."

In 2022, ISP and SIUE partnered to provide unpaid practical experience for Criminal Justice Program students. Each semester, SIUE students review cold cases and apply a solvability matrix to help prioritize cases based on the likelihood it could be furthered.

"This project has been an incredible learning experience for all of us, myself included. The collaboration leverages talent from multiple state entities and creates a novel, hands-on learning experience that has real world implications," said SIUE Professor of Criminal Justice Studies Dr. Trish Oberweis.

Since the program began, SIUE students have worked closely with ISP special agents to review dozens of cases. As part of that review process, students have also created what they call a "Murder Book," which includes searchable information for cold homicide cases in the Metro East.

"Every person deserves to be identified and remembered. I'm proud to have played a part in giving two women their names back," said Ryleigh Franklin, an SIUE graduate involved in the program. "I'm incredibly grateful to SIUE and the Illinois State Police for giving me the chance to make a real difference."





Cold Cases, continued

In 2002, the bodies of three women, believed to be victims of serial killer Maury Travis, were found along Illinois roadways. Through the partnership, SIUE students were able to review two of these cases, learn about methods used to make forensic identifications, and track the continued efforts of ISP to identify these women.

ISP reviewed and entered all three cases in the National Missing and Unidentified Person System (NamUs) in 2014 and ensured the completion of DNA analysis at the University of North Texas Center for Human Identification. This year, students were able to witness the results of ISP's continued efforts to identify each of these women. Collaboration with partner criminal justice agencies and support services, including the Columbia Police Department, the FBI, the St. Charles County Police Department (MO), NamUs, and University of North Texas Center for Human Identification, has led to the identification of all three women.

- On January 30, 2002, road workers discovered a body along I-64 on the east side of the Silver Creek overpass near Mascoutah, IL. The individual appeared to have been deceased for several months. Fingerprint information was not available at the time of discovery due to decomposition, and dental charts were not available. After review, special agents identified the victim as Kelly Johnson.
- On March 11, 2002, road workers discovered a body along I-70 just west of Illinois Route 143 near Highland, IL. Neither fingerprint nor

- dental charting information was available at the time. Earlier this year, ISP special agents identified the victim as Crystal Lay.
- On March 28, 2002, road workers discovered human skeletal remains in a creek bed adjacent to Illinois Route 3 in Columbia, IL. The remains appeared to be at least six months old. Again, ISP special agents were able to identify the victim in this case, Carol Jean Hemphill.

In another case, SIUE students and ISP special agents reviewed the death of Truman Smith, who was shot on February 17, 2011 while making a delivery to a business near 26th Street and McCasland Avenue in East St. Louis. Upon the arrival of officers, Smith was able to relay what had occurred and provided a description of the suspect. Smith was then transported to an area hospital where he succumbed to his injuries. After an extensive investigation, 34-year-old Alan Davis of East St. Louis, IL was ultimately charged with First Degree Murder (Class M Felony) on May 22, 2025. Davis is currently being held at the Graham Correctional Center in Hillsboro, IL on an unrelated 2012 conviction for Aggravated Battery with a Firearm.

The partnership between ISP and SIUE is providing students with practical criminal investigation experience, and providing another avenue for review of cold cases to hold those responsible for crimes accountable.

ISP and Sangamon County State's Attorney Announce Arrest in Death of Springfield Woman Found on I-55

SPRINGFIELD – Illinois State Police (ISP) Division of Criminal Investigation (DCI) Zone 4 and Sangamon County State's Attorney John Milhiser announce the arrest of 57-year-old Robert Lee Jr. of Springfield, IL, for three counts of First-Degree Murder (Class M Felony) and one count of Concealment of a Homicidal Death (Class 3 Felony).

On March 13, 2024, the Illinois Department of Transportation (IDOT) notified ISP of the discovery of human remains located along the I-55 southbound ramp from Stevenson Drive in Springfield. The victim was later identified as Teresa Coleman of Springfield. ISP was requested to handle the death investigation. Preliminary autopsy results determined Coleman's death to be a homicide.



After a lengthy and thorough investigation, ISP special agents identified Robert Lee as the suspect. An arrest warrant was issued for Lee. On July 23, 2025, the US Marshals Service Great Lakes Regional Fugitive Task Force and ISP special agents took Lee into custody. Lee is being held at the Sangamon County Jail pending a detention hearing.

ISP is continuing to investigate the homicide. Anyone with information regarding Teresa's death that leads to a conviction may receive a cash reward up to \$5,000. If you have any information regarding this incident call Crime Stoppers anonymously at 217-788-8427.

ISP Arrests Du Quoin Man for Possession and Dissemination of Child Sexual Abuse Material

DU QUOIN – Illinois State Police (ISP) Division of Criminal Investigation Zone 7 announce the arrest of 70-year-old Jon W. Montgomery of Du Quoin, IL for multiple counts of Possession and Dissemination of Child Pornography.

On June 11, 2025, ISP special agents executed a search warrant at Montgomery's residence in rural Du Quoin and collected electronic evidence. The evidence was analyzed and revealed child sexual abuse materials. Montgomery was booked into the Perry County jail on July 23, 2025, and a detention hearing is set for July 24, 2025. Montgomery was charged with seven counts of Possession of Child Pornography (Class 2 Felony) and four counts of Dissemination of Child Pornography – Victim Under 13 Years of Age (Class X Felony).

ISP Arrests Chicago Woman for Road-Rage Expressway Shooting

CHICAGO – Illinois State Police (ISP) Division of Criminal Investigation Zone 1 arrested 24-year-old Octavia Howleit from Chicago, IL for one count of Aggravated Battery with a Firearm (Class X Felony) and one count of Aggravated Discharge of a Firearm (Class 1 Felony) related to a road-rage incident and expressway shooting on I-57 in April.

On April 30, 2025, at approximately 2:36 p.m., ISP officers responded to the Mobil Gas Station in the 2700 Block of 147th Street in Posen, IL for the report of a victim who had been shot on I-57 near 127th Street. The victim was struck by gunfire while driving on I-57 and pulled over at the gas station before being transported to an area hospital with serious injuries. After an exhaustive investigation, ISP special agents identified Howleit as a suspect.



On July 21, 2025, ISP special agents took Howleit into custody. ISP special agents presented their case to the Cook County State's Attorney's Office and the above-mentioned charges were filed against Howleit. Howleit is being held pending her first court appearance.


ISP Arrests Chicago Men for Attempted Murder in Expressway

Shootings

CHICAGO – Illinois State Police (ISP) Division of Criminal Investigation Zone 1 arrested 36-year-old Lamarkcus R. Ferguson of Country Club Hills, IL and 22-year-old Aldo Ruiz of Wonder Lake, IL for Attempted Murder, stemming from recent expressway shooting investigations.

On July 9, 2025, ISP officers responded to an expressway shooting on Interstate 94 northbound at 47th Street in Chicago. Two victims had been struck by gunfire and were taken to an area hospital for treatment. After a thorough investigation, ISP agents identified Ferguson as a suspect.

On July 21, 2025, the Country Club Hills Police Department took Ferguson into custody during a traffic stop. The Cook County State's Attorney's Office approved five counts of Attempted Murder (Class X Felony), two counts of Aggravated Battery with a Firearm (Class 1 Felony) and five counts of Aggravated Discharge of a Firearm (Class 1 Felony). There is no further information.

On July 12, 2025, ISP officers responded to an expressway shooting on I-90 southbound at East River Road in Chicago. One victim had been struck by gunfire and was taken to an area hospital for treatment. After a thorough investigation, ISP agents identified Ruiz as a suspect.

ISP Arrests Winnebago County Man for Possession of Child Sexual Abuse Materials

LOVES PARK – Illinois State Police (ISP) Division of Criminal Investigation Zone 2 special agents arrested 20-year-old Tyler J. Horton of Loves Park, IL for 10 counts of Possession of Child Pornography (Class 1 Felony).

On July 24, 2025, ISP special agents executed a search warrant at Horton's residence in the 4500 block of Moorlands Drive in Loves Park and collected electronic evidence. The evidence was analyzed and revealed child sexual abuse materials. ISP special agents arrested Horton and transported him to the Winnebago County Jail pending his first court appearance.



ISP was assisted in their investigation by the Boone County Sheriff's Office, Stephenson County Sheriff's Office, Belvidere Police Department, Loves Park Police Department, Freeport Police Department, and the Illinois Attorney General's Office.

Troop 6 Detail Nets 31 Arrests

ISP conducted a 6-day joint traffic enforcement detail in Sangamon County. The detail focused on high crash fatality areas, high crime areas, organized violent offenders, and structured criminal groups utilizing our interstate systems in furtherance of crime in and around Springfield.

Participating agencies were ISP, Springfield Police Department - Illinois, and the Sangamon County Sheriff's Office.

ISP Combats Vehicle Hijacking and Theft

SPRINGFIELD – The Illinois State Police (ISP) continues to target vehicle theft, hijacking, and related violent crimes using grant funding from the Illinois Secretary of State Illinois Vehicle Hijacking and Motor Vehicle Theft Prevention and Insurance Verification Council. ISP was awarded a \$10 million grant for the first fiscal year, another \$677,000 in June 2024, and \$637,500 in July 2025.

From April through June 2025, ISP missions resulted in the following:

Forensic laboratory assignments related to stolen/hijacked vehicle	1,215

Highlights of ISP vehicle recovery efforts:

- April 26, 2025, ISP located a stolen Land Rover and attempted a traffic stop on I-94 southbound at 95th Street
 in Chicago, but the Land Rover fled. The driver of the Land Rover parked around 83rd and Elizabeth and two
 occupants ran from the vehicle. ISP took both occupants into custody and recovered a firearm.
- May 3, 2025, ISP located a stolen Kia and attempted a traffic stop in the 400 block of Sauget Avenue in Cahokia, but the Kia fled. The driver of the Kia stopped and two occupants ran from the vehicle. One occupant was taken into custody.
- June 1, 2025, ISP located a stolen Jeep and attempted a traffic stop on I-94 northbound at 43rd Street in Chicago, but the Jeep fled. The driver of the Jeep parked near Haddon and Kostner and five occupants ran from the vehicle. ISP took all five occupants into custody and recovered a firearm.

ISP Looks Forward to a Fun and Safe Illinois State Fair

Yesterday, the Illinois State Police joined forces with the Illinois Department of Agriculture (IDoA) for Press Preview Day, an opportunity for news outlets and the public to learn about new attractions and security measures in place for the 2025 Illinois State Fair.

ISP Troop 6 Commander Joshua Adcock spoke about security updates aimed at improving safety for all fair-goers. Security measures include walk-through metal detectors at the Grandstand, bag-check procedures, uniformed troopers throughout the fairgrounds focused on community engagement and rapid response, along with new technology.

"These new security measures aren't just about enforcement; they're about prevention, visibility, and reassurance. Our goal is simple: keep the Fair a fun, secure space for everyone. Our new security measures and updates add up to one clear message:

We are prepared. We are present. And your safety is our priority."



Field Study of Digital Alert Systems to Increase Move Over

Compliance



During July 22-24, 2025, the Division of Statewide 9-1-1 assisted IDOT and the University of Illinois Urbana-Champaign (U of I) in a field study to evaluate the benefits of digital alerting systems. This is a multi-year study that seeks to utilize technology on emergency response vehicles to improve Move Over compliance. The technology being evaluated involved a HAAS alert beacon, which is activated in conjunction with the activation of emergency lights on a patrol car. The beacon sends a signal to GPS mapping programs, such as Google Maps and Waze, which alerts drivers to the presence of an emergency vehicle ahead. The study utilized a helicopter to observe the driving behaviors of motorists and collect data, which researchers at the University of Illinois will analyze.



Quick Thinking in Troop 4



On July 18, 2025, Troop 4 officers narrowly avoided what could have been a major hazardous materials incident. Troopers were dispatched to a rolled-over tractor-trailer hauling anhydrous ammonia after initial reports indicated the tanker was leaking.

Upon arrival, Troop 4 immediately secured the scene, established a safety perimeter, and implemented hazmat precautions. After a thorough inspection, it was determined that the tank was not leaking. Although the trailer had buckled during the rollover, it remained intact

and unpunctured.

Thanks to the coordinated response, a large-scale spill was avoided, the roadway was safely cleared, and no injuries were reported.

The 2025 Team Illinois Youth Police Camp at Lewis University was a tremendous success this summer! The Team Illinois Youth Police Camp is a highly structured, week-long residential program held at Lewis University in Romeoville, IL. during the month of June. 






ISP Celebrates Summer Retirements

Trooper Clarence Swain

End of Watch August 1, 1959

Trooper Clarence Swain served with the Illinois State Police in District 9. Trooper Swain was killed in an automobile accident. A truck pulled out in front of his path and failed to gain speed. In-an-attempt to avoid striking the truck Trooper Swain swerved into the opposite lane but struck a vehicle head-on. Both he and the driver of the other vehicle were killed. Trooper Swain's partner was injured in the accident.

Trooper Swain had served with the Illinois State Police. He was a veteran of both WWII and the Korea, War. Trooper Swain was survived by his wife and four children. Trooper Swain's Illinois State Police career spanned from May 29, 1950 to August 1, 1959.
