# In Memoriam: K-9 Bane



With love and a deep sadness, we announce the passing of Illinois State Police canine, Bane, the loyal partner of Trooper Carrie Arvidson #6508. On August 5, 2025, Bane passed away after a heroic law enforcement career at the age of 8. Recently, Bane fought valiantly after a life-saving operation that was made possible through the love and contributions of ISP Troopers and supporters. Bane was officially retired on July 10, 2025, after the onset of a rare neuromuscular condition.

Bane initiated his career in May of 2018 after graduation from Basic Canine School Class 77. Throughout his career, Bane has been a fixture in


the canine program and was responsible for 117 free-air sniffs and deployments for 13 area searches, 12 article searches and 7 tracks. Through his tenacity and the expertise of Trooper Arvidson, Bane facilitated the seizure of 36 firearms, 352,787.81 grams of cocaine, 9,031 grams of crack cocaine, 1,262 grams of heroin, 187,207.2 grams of cannabis, 220.262.66 grams of methamphetamine, 95,911.5 grams of fentanyl, 549.8 grams of psylocibin mushrooms, 1,356.96 grams of other controlled substances, 1,368.5 MDMA pills, \$3,325,905 USD and the recovery of 2 stolen vehicles. Known for his hallmark Rex Specs, Bane conquered these feats despite a visual impairment in one eye.





As evidenced through these yields, Bane's passion consistently progressed the mission of the Division of Patrol while influencing Divisions across the entire Department. Apart from his professional dedication to ISP, Bane will always be remembered as a loving and devoted companion and friend.

ISP honored Bane with a final salute on Tuesday, August 5, 2025. Please keep Bane and Trooper Arvidson in your prayers.

## ISP Investigates Vehicular Endangerment Incidents Near Effingham

**EFFINGHAM** – The Illinois State Police (ISP) Division of Patrol Troop 9 and Division of Criminal Investigation Zone 8 are actively investigating reports of Vehicular Endangerment in Effingham and Shelby counties. Multiple damage to vehicle reports have been taken as a result of objects being thrown from overpasses along Interstate 57.

These dangerous incidents, which have occurred over a span of several days, are being treated as cases of Vehicular Endangerment, a Class 2 Felony under Illinois law. ISP emphasizes that throwing

items from an overpass onto moving vehicles presents an immediate and severe threat to public safety.

ISP is asking the public for assistance in identifying any suspects or suspicious activity in the area of Interstate 57 near overpasses between Effingham and Sigel (mileposts 165 to 170). Witnesses or anyone with dashcam footage from the affected area during the nighttime hours in recent days are urged to contact ISP at (217) 342-7871. This is an active and ongoing investigation.

## **ISP Issues 4th Round of Firearm Enforcement Grants**

# \$1 million for local law enforcement agencies

**SPRINGFIELD** – The Illinois State Police (ISP) is issuing the fourth round of firearm enforcement grants totaling \$1 million to 21 law enforcement agencies across the state to conduct enforcement details for individuals legally barred from having a firearm.

"Keeping Illinoisans safe is my top priority, and that includes keeping people safe from gun violence," said Governor JB Pritzker. "I'm proud that we are providing local police departments across the state with the resources they need to ensure we keep deadly weapons out of the hands of those who pose a risk to themselves or their communities."

The enforcement details focus on individuals who have become the subject of a Firearm Restraining Order, a Clear and Present Danger report, or received a criminal conviction, among other reasons.

"Conducting enforcement details can be time intensive and require additional resources," said ISP Director Brendan F. Kelly. "These grants can help local law enforcement agencies pay for the details, which focus on ensuring individuals who pose a danger to the public or themselves do not have firearms in their possession."

During the first three years of the grants, local law enforcement agencies conducted thousands of compliance checks and placed thousands of individuals directly into compliance, transferring all firearms out of their possession and documenting that transfer with a <a href="Firearm Disposition Record">Firearm Disposition Record</a>. The number of compliance checks and individuals placed into compliance has increased each of the three years.

Law enforcement agencies that are members of the Violent Crime Intelligence Task Force are eligible to receive grants from the State Police Enforcement Fund. Funding will help agencies conduct firearms enforcement details and ensure firearms are turned over to a person who is legally allowed to possess firearms, or to law enforcement.

Funding for the enforcement grants comes from the State Police Enforcement Fund and were made possible through <u>Public Act</u> 102-0237.

# ISP Searching for Suspect in Ford County

GIBSON CITY - The Illinois State Police (ISP) Division of Criminal Investigation Zone 5 is investigating the shooting of two officers in Ford County at the request of the Gibson City Police Department (GCPD) and Ford County Sheriff's Department (FCSD).

On August 9, 2025, at approximately 2:31 a.m., officers from the GCPD and the FCSD responded to a report of a naked man, identified as 70-year-old David D. Jordan of Gibson City, walking outside in the 100 block of Ash Street, Gibson City. Upon attempting to make contact with Jordan at his residence, officers were met with gunfire. A GCPD officer and an FCSD deputy were struck by the gunfire. Both were transported to local hospitals and treated for non-life-threatening injuries. Shortly after the shooting, the house caught fire.


Jordan was last seen at the residence, his whereabouts are currently unknown. He was last seen unclothed and is considered to be armed and dangerous. He may be seen with a red bicycle. If you should see Jordan, do not approach him and call 911. For any information on his whereabouts, please contact GCPD at 217-784-8666. This investigation into the shooting is open and ongoing. When complete, ISP will submit all evidence and facts for review to the Ford County State's Attorney's Office.

# ISP Announces Sweeping Changes to Human Trafficking Laws in IL

## Gov. Pritzker signs Statewide Trauma-Informed Response to Human Trafficking Act

SPRINGFIELD - The Illinois State Police (ISP) is announcing major updates to several laws impacting the ability to combat human trafficking and help those who have been trafficked with the signing of Senate Bill 2323, the Illinois Statewide Trauma-Informed Response to Human Trafficking Act. The Act addresses human trafficking through prevention, intervention, and establishing standards for survivor support, and impacts laws governing ISP, Illinois Department of Children and Family Services (DCFS), Illinois Department of Human Services (IDHS), Illinois Department of Labor (IDOL), Illinois Department of Juvenile Justice (IDJJ), Illinois Department of Corrections (IDOC), Illinois Law Enforcement Training Standards Board (ILETSB), Children's Advocacy Centers (CACs), the Office of the State's Attorneys Appellate Prosecutor, the Illinois Secretary of State, and other stakeholders.

"As Illinois continues to enhance its strategies to combat human trafficking, it's crucial that we ensure survivors — no matter who they are or where they live — have access to the resources they need," said Governor JB Pritzker. "This vital legislation marks a coordinated, multi-agency effort to better identify, protect, and support our most vulnerable, making Illinois a safer place for everyone."

Human trafficking is one of the most underreported and under-identified crimes. In fiscal year 2024, 448 human trafficking survivors were reported to the Illinois Criminal Justice Information Authority as receiving services from an Illinois domestic violence or sexual assault agency, and 213 possible cases of child trafficking were reported to DCFS during that same time frame. However, we know these numbers are only a fraction of the human trafficking victims in our state.

"Human trafficking can come in many forms, from commercial sex acts to forced labor," said ISP Director Brendan F. Kelly. "Because human trafficking has many faces and can happen almost anywhere, it is important to have a comprehensive, statewide victim-centered, trauma-informed response that encompasses those who may come in contact with individuals who are being trafficked, such as law enforcement, child services, case workers, treatment providers, and others."

The Illinois Statewide Trauma-Informed Response to Human Trafficking Act provides consistency in the state's response by creating uniform service response, policies, agency infrastructure, screening tools, training, and protocols.

#### Service Response for Survivors of Human Trafficking

- Coordinates several state agencies through a single statewide plan to identify and respond to survivors.
- Creates standards of care for human trafficking service providers.
- Develops curriculum standards and training for human trafficking and other service providers.
- Calls for collaboration with medical and legal associations to provide training for their members working with survivors.
- Requires Children's Advocacy Centers adopt multidisciplinary team human trafficking task force protocols and facilitate training, standards, and collaboration to ensure a coordinated response to trafficked children.

#### **Law Enforcement and Prosecution**

- Creates multidisciplinary team human trafficking task forces where they do not exist across the state.
- Supports local law enforcement encountering victims of human trafficking.
- Develops law enforcement curriculum standards and policy guidelines for human trafficking detection, investigation, and response.
- Mandates support and training for state's attorneys prosecuting human traffickers.
- Aligns penalties for child labor trafficking with child sex trafficking penalties.
- Allows an affirmative defense for minors accused of status or misdemeanor crimes committed as a result of human trafficking victimization.
- Requires the court to take into account the age of human trafficking victims when sentencing those convicted of human trafficking crimes.
- Eliminates the statute of limitation for civil liability to allow individuals who were trafficked as a minor to bring suit against their trafficker at any point in their healing process.
- Permits dissolution of corporations convicted of

#### **State Agency Response**

- Expands screening of children and youth in state care, juveniles in IDJJ, and individuals under the...
   ...jurisdiction of IDOC for indicators of having been trafficked or at high-risk of being trafficked for specialized services and placements.
- Expands training for DCFS, IDHS, and IDOC staff on screening tools and appropriate protocols for children, youth, and adults in state care and custody who have been trafficked or are at risk of being trafficked.
- Creates training for state inspectors, investigators, and regulators on signs of human trafficking in industries at high risk for trafficking, such as restaurants, hotel, agriculture, construction, and educational materials on the rights of youth workers.

"Too often, trafficking victims are left without support because the systems in place aren't communicating with each other," said State Senator Julie Morrison (D-Lake Forest). "This law strengthens coordination across state agencies to identify victims earlier and expedite access to trauma-informed care for survivors."

In October 2023, ISP and the Illinois Department of Human Services launched the Joint Human Trafficking Working Group – an ad hoc working group comprised of several State agencies, the Office of the Illinois Attorney General, the Illinois Law Enforcement Training and Standards Board, the Office of the State's Attorneys Appellate Prosecutor, and more than 60 stakeholders representing human trafficking, domestic violence, and sexual assault advocacy organizations, survivors, local law enforcement, prosecutors, and courts, as well as medical, substance use disorder, and behavioral health providers. The working group helped develop policy recommendations, which are reflected in the Illinois Statewide Trauma-Informed Response to Human Trafficking Act.

"Since launching the Joint Human Trafficking Working Group in the Fall of 2023, we have made significant progress," said IDHS Secretary Dulce M. Quintero. "I want to thank Governor Pritzker and our sister agencies, ISP and DCFS. This law means our response is not only compassionate, but consistent. It will set standards of care for human trafficking service providers all across the state."

"Human trafficking is a reality that affects every corner of our nation, from large cities to small towns, and Illinois children and youth are not immune," said Illinois DCFS Director Heidi E. Mueller. "Through expanded training for our staff and our ongoing collaborations with law enforcement, community organizations and dedicated service providers, we are strengthening our ability to prevent the human trafficking of children and support the children who have been trafficked and their families so they can heal."

To combat human trafficking, ISP created the Trafficking Enforcement Bureau in 2022. Since that time, more than 1,300 ISP officers have received human trafficking awareness training, and almost 140 officers have been trained in advanced investigative techniques related to human trafficking investigations. Last year, the ISP Trafficking Enforcement Bureau conducted seven human trafficking demand suppression operations resulting in 31 arrests and 90 criminal charges, including Grooming, Indecent Solicitation of a Minor and Traveling to Meet a Minor and obtained charges in three additional cases, including charges of Involuntary Servitude and Promoting Prostitution.

Every year, millions of men, women, and children are victims of trafficking worldwide, including in the United States and in Illinois. The signs of human trafficking can be subtle. #### ISP Announces Results of Metro East Violent Crime Suppression Detail

**EAST ST. LOUIS** – Illinois State Police (ISP) conducted a violent crime suppression detail on July 29 - 30, 2025, in St. Clair and Madison counties, focusing its efforts on East St. Louis and neighboring Metro East communities. Metro East.

The operation utilized intelligence and technology to target known high crime areas, violent offenders, and structured criminal groups in the communities of the Metro East.

There were several notable events and arrests during the detail.

On July 29, 2025, troopers conducted a traffic stop on a vehicle for Illinois Vehicle Code (IVC) violations. A probable cause search of the vehicle resulted in the seizure of a firearm and ammunition. One subject was taken into custody. Charges are pending.

On July 30, 2025, a trooper located and recovered an unoccupied, stolen vehicle with no registration parked on the side of the roadway.

On July 30, 2025, troopers conducted a consensual encounter with a group of individuals. One subject was ultimately taken into custody and a stolen firearm was seized. Charges are pending.

ISP officers from around the state including Division of Criminal Investigation Zone 6, Firearms Investigations Unit, Air Operations, SWAT, and the Public Safety Enforcement Group joined forces with the Division of Patrol's Special Operation Group South Statewide Anti-Violence Enforcement Unit for the multi-day operation. Homeland Security Investigations also provided support during the operation period.

# ISP Arrests Two Men on Three Felony Counts for Separate Chicago Crashes

**CHICAGO** – Illinois State Police (ISP) Division of Criminal Investigation Zone 1 special agents presented two cases to the Cook County State's Attorney's Office on August 5, 2025, resulting in three felony charges. Both unrelated cases involved crashes where victims were seriously or fatally injured.

The first crash occurred on February 2, 2025. ISP troopers responded to a hit-and-run crash involving a pedestrian in the 8000 block of S. Lafayette Avenue, right off I-94 in Chicago. A white Jaguar struck a pedestrian and fled the scene. The pedestrian was transported to an area hospital with critical injuries.

After an extensive investigation, ISP special agents identified 32-year-old Antonio Jackson of Chicago as the driver of the Jaguar. On August 5, 2025, ISP officers took Jackson into custody and the Cook County State's Attorney's Office approved the following charges: Failure to Report Accident/Injury (Class 2 Felony) and Leaving the Scene of Per-

sonal Injury Crash (Class 4 Felony). Jackson is being held pending his first court appearance.

On August 5, 2025, ISP troopers responded to a fatal crash on I-94 southbound at 95th Street in Chicago. Preliminary reports indicate that a crash occurred and the driver of one of the vehicles, 47-year-old Alassane Tchandikou of Hinsdale, IL, exited his vehicle and was subsequently struck by a passing white Kia. Tchandikou was transported to an area hospital and later declared deceased. The driver of the Kia, 34-year-old Marques D. Worrell of Chicago, was also injured in the crash and taken to an area hospital for treatment.

On August 6, 2025, ISP special agents presented their case to the Cook County State's Attorney's Office and Worrell was charged with Aggravated Driving Under the Influence of Alcohol Resulting in Death (Class 2 Felony). Worrell was arrested and held pending his first court appearance but has since been released.


