


## ISP Seeks Public Assistance with 2007 Burger King Double-Homicide Cold Case

MOMENCE – September is recognized as National Cold Case Month and the Illinois State Police is committed to bringing justice and resolution for victims and families impacted by violent crimes. The Illinois State Police Division of Criminal Investigation Zone 1 requests the public's assistance with the death investigation of Pam Branka and Paul Jones.

On January 13, 2007, in the early morning, police received a 911 call from the Burger King attached to the Circle K gas station, located at 3 Gladiolus Street in Momence. A female was heard screaming but unable to speak to the dispatcher. Momence Police Department arrived approximately one minute later and found both Burger King employees, Pamela Branka and Paul Jones deceased at the restaurant.

# DuQuoin Communications Center Undergoes Upgrade

On Thursday, July 10, 2025, the DuQuoin Communications Center (DCC), housed at the Troop 10 (formerly District 13) Headquarters, began a long-overdue facelift. The center, originally designed and built in 2004 to house three (3) radio consoles, was re-engineered in the summer of 2012 to accommodate eight (8) consoles in response to the consolidation of communications for Districts 12 (Effingham), 13 (DuQuoin), 19 (Carmi), and 22 (Ullin).

Over the course of several weeks in July 2012, the console furniture, radios, and CAD equipment from Effingham, Carmi, and Ullin were dismantled and reassembled by Radio Network Services Bureau (RNSB), phone company staff, and electrical personnel in the DuQuoin center—all while patrol and dispatch operations continued uninterrupted.

The process of replacing console furniture began late in 2024, with the selection of the new console furniture design and carpeting. Technical specifications were established, and electrical needs were identified, requested, and planned by CMS personnel at the facility. Some electrical work was completed in advance, with the remainder carried out during the teardown and rebuild.

Deconstruction began with RNSB personnel removing the radios and CAD equipment. Watson Furniture Co. staff then dismantled and removed the old furniture, after which carpet contractors installed new flooring. Once complete, the process was reversed to rebuild the center.

DCC manages communications for Troops 9 and 10, which requires a minimum of four (4) operational consoles at all times, with six (6) needed for a CVEO detail the week of July 21. RNSB staff, along with outside contractors (carpet, furniture,

and electrical), carefully coordinated their work to keep the center fully operational. Progress remained steady, and the final installation of furniture was completed ahead of the August 1 deadline. RNSB personnel continued working over the following two weeks to finish installing ISP equipment (radios and CAD/MACH).

## ISP Special Agent Zachary French Awarded Certificate of Merit from IDNR

Illinois State Police Special Agent Zachary French has been awarded the Certificate of Merit for his outstanding contributions to the long-term investigation known as *Trucking for Trophies*. The five-year case, conducted while French was serving as a Conservation Police Officer with the Illinois Department of Natural Resources (IDNR), targeted a group of Mississippi individuals who conspired to illegally hunt and transport trophy white-tailed deer from Illinois in violation of state and federal wildlife laws.

From 2018 to 2022, investigators uncovered that multiple trophy bucks were spotlighted, killed with rifles during closed seasons, and transported across state lines in violation of the Lacey Act. The investigation led to five defendants pleading guilty. The court ordered them to pay \$119,500 in fines and restitution, imposed a five-year worldwide hunting ban, and seized more than 60 mounted deer as evidence. This remains one of the largest deer poaching prosecutions in IDNR history.

Special Agent French played a pivotal role in the case by gathering actionable intelligence, conducting key witness interviews, and analyzing extensive records obtained through search warrants. His professionalism, attention to detail, and coordination with federal partners such as the U.S. Fish and Wildlife Service were essential to the successful prosecution.

“The success of this investigation is a direct reflection of the hard work and dedication of these officers,” said Sgt. Heath Tepovich. “Their efforts not only brought poachers to justice but also protected Illinois’s natural resources for future generations.”

Special Agent French’s recognition highlights his continued commitment to law enforcement and public service. After his distinguished tenure as a Conservation Police Officer, he now serves with the Illinois State Police Zone 6 as part of the PSEG unit.

# In Memoriam: K-9 Kiloh

It is with profound sadness that we announce the passing of Illinois State Police (ISP) Canine Kiloh. Kiloh was a graduate of Canine Class 75 in 2017 along with his handler, A/Lt. Eli Adams #6117.

Canine Kiloh passed away on September 10, 2025, after a short battle with cancer, at the age of 9. He faithfully served the people of Illinois for 8 years alongside A/Lt. Eli Adams until his passing. Together, A/Lt. Eli Adams and Kiloh exemplified exceptional dedication to duty and forged an extraordinary partnership.

Kiloh completed the 10-week Basic Canine Training Course and began his career in the spring of 2017 in Troop 6 (formerly District 9). He quickly became an integral part of the District 9 SET team and Statewide CRIMPAT Team. Canine Kiloh finished his career with the Special Operations Group - Central Highway Interdiction Team. Kiloh served as a full-service canine, proficient in narcotics detection, tracking, article searches, and criminal apprehension.

A/Lt. Eli Adams and Kiloh also engaged with the community through demonstrations at schools and civic events, showcasing the ca-


pabilities of a well-trained K9 unit. Their efforts extended to drug searches, school searches, and building searches—positively impacting multiple facets of public safety.

Throughout their career, A/Lt. Eli Adams and Kiloh worked collaboratively with numerous state, county, local, and federal agencies. They focused on attacking the vulnerabilities of drug networks through coordinated interdiction efforts at every point along transportation routes in Illinois, disrupting individuals and criminal organizations trafficking illicit narcotics and currency through the state.

Canine Kiloh's career highlights include assisting in the seizure of approximately 2,678 pounds of cannabis, 20 kilograms of cocaine, 108 kilograms of heroin, 610 kilograms of methamphetamine, and \$3,328,904 in illicit U.S. currency.

K9 Kiloh was a proven asset to the Illinois State Police, and his contributions will be deeply missed. The dedication and hard work of A/Lt. Eli Adams and Kiloh have left a lasting impression on the ISP Canine Section and set a high standard for K9 teams everywhere.


